Statement of Purpose

Daviess County Right to Life is offering a \$500 Scholarship in honor of Donna Gentry to a Daviess County high school Senior who presents the best essay to the following subject matter.

Scholarship Rules

1. This scholarship is open to high school seniors, as of February 1, 2017. All applicants must be able to prove they will be attending college in the fall of 2017. **Students must be from Daviess County or attending a high school in Daviess County. Applications must be postmarked no later than Friday, March 31, 2017.**
2. Contestants are to research, write, and present an original pro-life essay developed from the theme: **“What is happening to America because of abortion.”**
3. The following specific issues can also be addressed: **Abortion, Infanticide, Euthanasia, and Abstinence until Marriage, or Stem Cell Research.**
4. The essay must be at least 500 words in length and not more than 550.
5. The essay should use **up-to-date, factual** information.
6. No copyrighted essays shall be used for this scholarship.
7. The contest will be judged by three members of Daviess County Right to Life Board.
8. The judges’ decisions will be **FINAL**.
