In Spite of Obama's win Nationally, Pro-Lifers Win Big in Indiana

While most of the post-election analytical focus has been on the presidential campaign and Congressional losses, pro-life candidates did well across the country as they fared well when it comes to races for the state legislature. In many cases most all of the candidates RTL supported and endorsed won, and they say the results set up state legislatures to make more pro-life gains with bills that limit abortion. After last year pro-abortion advocates complain that more pro-life legislation was proposed and passed than in years prior.

Here in Indiana Mike Fichter of Indiana Right to Life had this to say: "Indiana fared much better on election night, with the most significant victory being the election of Mike Pence as Indiana's next governor. Governor-elect Pence and Lieutenant Governor-elect Sue Ellspermann represent a powerful tandem that will work to enact pro-life policies in Indiana." Republicans added nine seats in the Indiana House, creating pro-life super-majorities in the Indiana Sen-

ate and House. These super-majorities create great opportunities for advancing pro-life legislation in 2013 and 2014. Indiana State Senator Scott Schneider, the senate author of the 2011 amendment to defund Planned Parenthood, won a convincing victory over a challenger who was heavily funded by Planned Parenthood. Schneider was the top state legislative target of abortion supporters in Indiana.

Indiana will send two pro-life women to Congress with Susan Brooks (CD5) and Jackie Walorski (CD2). Jackie Walorski's pick-up of CD2 gives us 7 pro-life seats in the U.S. House (Walorski, Stutzman, Rokita, Brooks, Messer, Bucshon, and Young) versus 2 pro-abortion seats (Visclosky, Carson). The Indiana House will welcome three pro-life freshmen women to its caucus: Sharon Negele, Cindy Ziemke and Peggy Mayfield. Seventy-eight percent of candidates endorsed by Indiana Right to Life PAC were victorious on Election Day 2012.

Thanks To Pro-life Voters locally, Louis Kavanaugh Jr.

I would like to thank the many individuals that voted pro-life in the recent election. Obama Won, But the Pro-Life Movement is Still Winning

To my Pro-life Friends and Allies:

The results of the presidential election were certainly disappointing. We knew the next president might get the opportunity to appoint as many as four new judges to the U.S. Supreme Court. We also knew that the 2012 election marked our best opportunity to repeal Obamacare. We were running against an incumbent president who very openly and aggressively supported legal abortion. We knew the stakes were high, and we responded admirably. In the end, our efforts came up a bit short.

However, I want to encourage you not to despair. We continue to make good progress. In fact, I would argue that our biggest successes during the past twenty years have neither been political nor legislative. Our biggest success story is that we have succeeded in changing the hearts and minds of millions of Americans.

Allow me to explain. One simple measure of the effectiveness of the pro-life movement is the number of abortions that are performed every year in this country. The number of abortions has declined from 1.6 million in 1990 to about 1.2 million in 2008. That is 1.2 million too many. But it is also a 25 percent decline. The consistent decline in the incidence of abortion is progress the pro-life movement could sometimes do a better job advertising.

So why has the abortion rate declined? It is due partly to the state level pro-life laws we have passed. I am probably the most dogged defender of the incrementalist strategy in the pro-life movement. I frequently cite numerous academic studies, including my own research, which shows that public funding restrictions, parental involvement laws, and properly designed informed consent laws all reduce abortion rates. I also detail how the strategies our opponents promote, like greater spending on welfare or contraceptive programs, have no effect on abortion rates—or are, in many cases, counterproductive.

However, I want to remind everyone that the abortion rate has fallen in every state—even deep blue states that have not passed any pro-life laws since 1990. Why is this? It is mostly because hearts and minds are changing. Ultrasound technology has developed that allows people to see clear pictures of sons, daughters, nieces, and nephews in utero. We have also developed an impressive network of pregnancy resources centers that provide vital assistance to literally thousands of women facing unplanned pregnancies.

Furthermore, we have become increasingly smart and savvy in our outreach efforts. There are too many good pro-life outreach efforts for me to name in this letter. However, I think that the Silent No More campaign has done a

great job communicating the regret of many post-abortive women. The 40 Days for Life campaign has inspired thousands of people to become more active in their pro-life work. The annual Students for Life of America (SFLA) conference during the March for Life weekend routinely attracts thousands of college students—making this the largest pro-life conference in the country. Finally the videos produced by LiveAction Films have done a great job exposing unethical and illegal activities at Planned Parenthood facilities across the country.

We have realized that we have to work smarter and work harder than our opponents. Many fail to realize the difficulties that *Roe v. Wade* has imposed on the pro-life movement. *Roe* not only legalized abortion on demand and made abortion policy resistant to change, it also changed society's sexual and cultural mores in such a way as to make subsequent restrictions on abortion more difficult to enact. It gave abortion rights mainstream political legitimacy. Moreover, it created a national network of abortion providers with a financial interest in easy access to abortion. Overall, through creativity and dedication, we have done a good job overcoming many of these obstacles.

Of course, I do not want to dismiss politics. After the 1998 election, many conservatives were disgusted that the Lewinsky scandal did not result in a greater political backlash against the Democratic Party. Some suggested that conservatives disengage from politics. However, I would never recommend that course of action. Winning elections and passing laws has certainly done some good. Furthermore, if nothing else, pro-lifers have to play defense. The unique problems posed by both the HHS contraception mandate and Obamacare will only be solved through political engagement.

Most important, I do not want pro-lifers to despair. The past 20 years have been good to us. It was just 20 years ago we received a very disappointing judicial ruling in *Planned Parenthood v. Casey*. A number of surveys indicated that the pro-life position was losing ground in the court of public opinion. The Republican Party was having serious discussions about removing the pro-life plank from their platform. Pro-lifers certainly had plenty of reasons for pessimism. But now everything has changed. Many surveys show that the pro-life position is gaining support, and no one disputes that the Republican Party will remain a pro-life party for the foreseeable future.

So please keep doing your pro-life work, with pride, conviction, and confidence. Our efforts have made a difference over the past 20 years. And I have every confidence that if we stay the course, the next 20 years will be even better.

Exit Polls: Who Voted For Romney/Barack Obama

Exit polling data has shown the number of evangelical voters was higher in 2012 than in the 2008 election—in what should have been a good sign for the pro-life movement and GOP candidate Mitt Romney. However, further analysis of the data shows that even though pro-abortion President Barack Obama lost among white evangelical Protestants and white Catholics, almost one-quarter of evangelicals voted for him despite his massive pro-abortion record.

A Pew analysis of the religion of voters reveals more details about how they voted: “Black Protestants also voted overwhelmingly for Obama (95%). At the other end of the political spectrum, nearly eight-in-ten white evangelical Protestants voted for Romney (79%), compared with 20% who backed Obama. Romney received as much support from evangelical voters as George W. Bush did in 2004 (79%) and more support from evangelicals than McCain did in 2008 (73%). Mormon voters were also firmly in Romney’s corner; nearly eight-in-ten Mormons (78%) voted for Romney, while 21% voted for Obama. Romney received about the same amount of support from Mormons that Bush received in 2004. (Exit poll data on Mormons was unavailable for 2000 and 2008.)”

White voters attending Protestant churches were more inclined to vote for the pro-abortion candidate. “Among white mainline Protestants in the exit poll, 54% voted for Romney, while 44% supported Obama. This is virtually identical to the 2008 election, when 55% of white mainline Protestants voted for McCain and 44% backed Obama,” it said. The Obama abortion-HHS mandate clearly had an impact on the Catholic vote, Pew maintained. “White Catholics, by contrast, swung strongly in the Republican direction relative to 2008. Nearly six-in-ten white Catholics (59%) voted for

Romney, up from 52% who voted for McCain in 2008. Three-quarters of Hispanic Catholics voted for Obama, and Catholics as a whole were evenly divided in 2012 (50% voted for Obama, while 48% backed Romney),” Pew noted.

Catholic voters who regularly attend Mass broke 67% for Romney to 32% for Obama.

This represented a swing of 35% in the direction of the GOP since 2008. Romney also won white Catholics by a margin of 59% to 40%, a margin of 19 points among a group that historically has voted for the winner. Nevertheless, Obama narrowly won the Catholic vote driven largely by over-performing among Hispanic Catholics.

To no one’s surprise Pew also indicated voters who more frequently attend church were more likely to vote for Romney over Obama. “As in other recent elections, those who attend religious services most often exhibited the strongest support for the Republican presidential candidate. Nearly six-in-ten voters who say they attend religious services at least once a week voted for Romney (59%), while 39% backed Obama. Romney received as much support from weekly churchgoers as other Republican candidates have in recent elections,” it said. But non-churched voters continue to be a problem for pro-life advocates and are the voters they need to do a better job of persuading. “Those who say they never attend religious services were again among the strongest Democratic supporters in the presidential election. More than six-in-ten voters who say they never attend religious services voted for Obama (62%). Voters who say they attend religious services a few times a month or a few times a year also supported Obama over Romney by a 55% to 43% margin,” Pew said.

What the Catholic Church is not Doing to Turn their Members to Pro-Life Candidates

The results are not surprising given that a final Gallup poll showed Catholics favoring Obama 52 to 45 percent.

That makes it appear the Catholic Church leaders need to do more to engage nominal Catholics who do not attend religious services frequently and may be less disposed to the pro-life views and teachings of the Church. Of course the question is if you can’t get them to church, how can you educate them.

“The collision course of the Obama Administration with the Catholic Church could have been averted, but now it is assured instead,” Father Frank Pavone of Priests for Life responded. **“Many in Church leadership failed to connect the dots between personnel and policy. They prayed and preached against the HHS mandate, but then were silent about the election, and called the police to remove citizens who leafleted the Church parking lot trying to inform voters about where the candidates stood on this issue.”**

But Catholic advocate Deal Hudson says progress was made. “Catholics, once again represented 25% of the

national vote, with Catholics voting for Obama by 49%, and for Romney by 48%, which represents a 5% loss for Obama and a 3% gain for Republicans from 2008,” he noted. “We needed a bigger shift of Catholic voters. We do not yet have the breakdown of religiously-active Catholic voters, but you can be sure it was close to 60% for Romney.”

“What held down the shift we needed? In our view, it is the growing influence of the Latino Catholic voter. Latinos represented 10% of the vote this year and went 69% for Obama, 30% for Romney,” he added. **“We also could have used louder voices among our clergy and our bishops—fewer alphabetical voter guides and more insistence on the issues at stake.”**

Bill Donohue of the Catholic League suggests more battles are forthcoming from a second Obama administration. “In 2007, Barack Obama told Planned Parenthood that the first thing he would do if elected president would be to sign the Freedom of Choice Act (FOCA). Because of opposition from many quarters, including the Catholic League, the bill

never got to his desk. But it may now come back, and if it does it could mean that Catholic hospitals would be required to perform abortions lest they lose federal funding,” he told LifeNews. “The fate of the Health and Human Services (HHS) mandate that would force Catholic non-profits to pay for abortion-inducing drugs is sure to reach the U.S. Supreme Court,” he said. “We can’t wait until FOCA and the HHS mandate are thrust upon us, so we need to act now.”

Penny Nance of Concerned Women for America said pro-life Catholics need to do more voter outreach.

“We are clearly a divided nation. Women of faith both Evangelical and Catholic voted their values, but we did not

have the conversation needed to convince our friends and neighbors,” she said. Hudson, a Catholic pro-life advocate and writer, concludes: “The fight for our Church and our Country, however, remain before us, and there is simply no giving up, none. I, for one, do not concede that the Catholic Church in this nation, or any for that matter, is going to allow a government to roll over its natural, God-given, right to believe, worship, and practice the faith. Even if it take not another four years but another 20 years—God willing!—I will be in that fight.”

Reason Obama Won:

Here’s an interesting plot twister; Republicans made the assumption that voters in states with high unemployment would kick the bums out. That is, that they’d vote Obama out of office and try to find someone who could solve the jobs problem in this country.

Turns out, the opposite has happened. Voters in high unemployment states actually like the President, and the reason is obvious; the Federal Government is paying the jobless, extending unemployment benefits, food stamps, and even underwriting disability payments from Social Security.

If you think we’re different from the Europeans? Think again. That’s what this election was all about. People voted for free stuff, free money, and free benefits. A chicken and health care in every pot.

It’s not just the people who lost money in the recession who are hooked on government money. The total number of people getting government money is rising. In fact, most of what you suspect about entitlements may be wrong. If you think the proportion of people getting government benefits has been stable over time, think again. In 1983, less than 30% of us got help. Today, it’s 49%.

So here’s where we are; nearly 200 years after Francis Scott Key penned the national anthem and immortalized the phrase, “Land of the Free.” We’ve become just that, but not in the way we quite expected. We’re the land of the free because an increasing number of us are getting a free ride. That, my friends, is not the American way.

Media Helped to win 2012 Election for Obama:

If, in celebrating his victory Obama wanted to give credit where credit is due, he might want to think about calling some of America’s top journalists, since their favorable approach almost certainly made the difference between victory and defeat. Reviewing the 2012 presidential campaign, here are five ways the media elite tipped the public relations scales in favor of the liberal Obama and against the conservative challenger Mitt Romney:

1. The Media’s Biased Gaffe Patrol Hammered Romney:

The media unfairly jumped on inconsequential mistakes—or even invented controversies—from Romney and hyped them into multi-day media “earthquakes.” Case in point: the GOP candidate’s trip to Europe and Israel in late July. All 21 ABC, CBS and NBC evening news stories about Romney’s trip found that virtually all of them emphasized “diplomatic blunders,” “gaffes” or “missteps.”

2. Pounding Romney with Partisan Fact Checking:

There’s nothing wrong with holding politicians accountable for the honesty of their TV ads and stump speeches, but this year the self-appointed media fact-checkers attacked Republicans as liars for statements that were accurate. For example, a *Milwaukee Journal Sentinel* reporter writing for *PolitiFact* branded VP candidate Paul Ryan’s convention speech anecdote about the closing of the General Motors plant in his hometown as “false,” even though Ryan was correct in all of his details. The slanted review became TV reporters’ talking points. The next day on NBC, correspondent Chuck Todd grumped that while what Ryan said was technically factual, by what he left out.

3. Biased Debate moderators: Moderators are supposed to ensure both sides get a fair hearing, not pick sides. By leaping into the fray, Candy Crowley epitomized the media’s itch to tilt the scales this year—again, in Obama’s favor.

4. The Benghazi Blackout: Instead of an “October Surprise,” the networks engineered an “October Suppression”—keeping a lid on the boiling Benghazi story until Election Day. Who knows how voters might have reacted if the media had covered this story as tenaciously as they did Romney’s “47% gaffe”?

5. Burying the Bad Economy: When Republican presidents have faced reelection, network reporters made sure to spotlight economic “victims”—the homeless man, the woman without health insurance, the unemployed worker, the senior citizen who had to choose between medicine and food. But this year, with an economy as bad as any since the Great Depression, those sympathetic

anecdotes have vanished from the airwaves—a huge favor to Obama and the Democrats. Given Obama’s record, the Romney campaign could have overcome much of this media favoritism and still prevailed. But taken together, these five trends took the media’s historical bias to new levels this year, and saved Obama’s presidency in the process.

Texas Will Keep Tax-Funding Planned Parenthood, For Now

The state of Texas announced that it will continue funding the Planned Parenthood abortion business through its women’s health program until it can verify it has enough alternatives to meet the non-abortion health needs of women in the state. Health and Human Service Commissioner Kyle Janek said Wednesday the state needs more time to sign up doctors and health centers for its new program that will provide family planning services without also doing abortions.

A state court last week issued a temporary restraining order against the ban on Planned Parenthood after a federal appeals court earlier ruled in the state’s favor on a similar issue. A state court hearing on the matter is scheduled November 8 following a new state lawsuit from Planned Parenthood.

Eric Holder Linked to Doctor Who Killed Patient in Abortion

New documents a conservative publication obtained link Attorney General Eric Holder with a Georgia-based abortion practitioner responsible for killing a patient in an abortion and who has been accused of Medicaid fraud. Human Events says Holder has ties to Tyrone Cecil Malloy and that they help explain why Holder has failed to prosecute abortion practitioners who run afoul of federal laws and why he has been eager to prosecute pro-life advocates who protest outside of abortion centers.

Documents obtained by Watchdog show that Holder's wife and sister-in-law co-own, through a family trust, the building where Malloy operated. A Georgia grand jury indicted Malloy on Medicaid fraud charges in 2011. A state medical board twice reprimanded the doctor. Holder and his wife, Sharon Malone Holder, an obstetric and gynecological doctor at Foxhall OB/GYN in Washington, D.C., failed to respond to several requests for comment.
