

What Is Happening to America Because of Abortion?

Few issues in America are as divisive and controversial as abortion. The 1973 Supreme Court ruling in *Roe v. Wade* marks the beginning of a 40+ year debate in the United States, one with incredible repercussions. The debate over abortion has called into question the meaning of human personhood, the rights of an individual over their own body, and even what it we mean when we say "human life." However, there are other effects of abortion, effects which have shaped America for both better and worse.

One of the worst effects of abortion is the fall of motherhood. Where the bond of mother and child was once inseparable and undeniably sacred, the spread and advocacy of abortion has made the child seem like a threat to its mother, and even more tragically, the mother is a threat to her own child. Under the flag of "feminism," motherhood is now seen as oppression and enslavement, rather than family and future. Mothers are no longer bound by responsibility towards their unborn children, but are encouraged to pursue their own goals, even at the cost of a human life.

Another effect of abortion is a loss of fatherhood. Many men see abortion as an escape from responsibility and duty to their partners, and feel free to selfishly pursue women without regard for their actions. Rather than being called to be responsible and protect the family, men are allowed to be selfish and neglectful towards both mother and child. While some may suggest that abortion ensures that mothers need not suffer from absentee fathers, few can deny that abortion actually calls men to greater responsibility for their actions. Abortion has ushered the decay of fatherhood, which in turn diminishes the dignity of men.

Finally, abortion has changed the face of minorities in America. Planned Parenthood, the largest abortion-providing organization in America, frequently places its facilities in minority neighborhoods across the country. Its founder, Margaret Sanger, was a well known proponent of eugenic practices, especially against minorities. Sanger has been quoted saying "We should hire three or four colored ministers, preferably with social-service backgrounds, and with engaging personalities. The most successful educational approach to the Negro is through a religious appeal. We don't want the word to go out that we want to exterminate the Negro population, and the minister is the man who can straighten out that idea if it ever occurs to any of their more rebellious members." Generations after Sanger, the racist trends in abortion are still very evident and concerning.


Even amidst the very concerning effects of abortion, there is still hope. Abortion has served to unify and mobilize increasingly large numbers of people who are willing to fight for the right to life. The 2013 March for Life, which marked the 40th anniversary of *Roe v Wade*, drew 650,000 people of all sorts to Washington, D.C., all united against abortion and its related atrocities. Most exciting is the incredible witness of the youth. Young people (like myself) are increasingly passionate about life issues and dedicated to the end of abortion. Abortion is not an issue without hope. Together, we can take a stand.

Together, we can change America for the better. Together, we can stop abortion.

Supreme Court Sides in Favor of Hobby Lobby

The most heated Supreme Court cases of the year—*Sebelius v. Hobby Lobby* and *Conestoga Wood Specialties Corp. v. Sebelius*—have been decided in a 5-4 decision that strikes down Obamacare’s HHS Mandate.

The Mandate would have required that all insurance plans cover prescriptions that include abortifacients. In both cases, the business owners objected on religious grounds and cited that the law was an infringement on their religious liberty. “Business owners should not have to choose between violating their faith and violating the law,” said Hobby Lobby founder and CEO, David Green.

In response to the decision, Bradley Mattes, Executive Director of Life Issues Institute, stated, “Today’s ruling upholds the system of checks and balances our founding fathers intended. Our religious rights were threatened by our own government, but in this case the justice system prevailed in protecting our freedoms. This is also a victory for life, as the protection of the unborn was both recognized and respected.”

Quote: Edmund Burke was right when he said, “*All that is necessary for the triumph of evil is that good men do nothing.*” It’s important that we help those who are indifferent to see that by not taking a stand, they’re enabling abortion to continue to kill the unborn and emotionally devastate their parents.

Senate Defeats Democrats' Bill to "Overturn" Supreme Court Decision Protecting Hobby Lobby

Note: Indiana Senator Coats voted to uphold Hobby Lobby decision while the other Indiana Senator Richard Donnelly voted to "overturn" decision.

Senate Democrats today lost their bid to approve legislation to "overturn" the Supreme Court's decision protecting Hobby Lobby and other companies from being forced to comply with the HHS mandate that compels them to pay for abortion-causing drugs for their employees. Republicans were able to sustain their filibuster against the bill and prevailed on a 56-43 vote, with Democrats voting to move to a vote on the pro-abortion bill and almost all Republicans uniting to vote against it.

The Supreme Court ruled that the Christian-run Hobby Lobby doesn't have to obey the HHS mandate that is a part of Obamacare. The high court issued a favorable ruling in *Sebelius v. Hobby Lobby Stores, Inc.*, a landmark case addressing the Constitutionally guaranteed rights of business owners to operate their family companies without violating their deeply held religious convictions.

The court ruled that the contraception mandate violated the Religious Freedom and Restoration Act, a 1993 law and it held that the mandate "substantially burdens the exercise of religion" and that HHS didn't use the "least restrictive means" to promote this government interest, tests required by RFRA.

Senators Mark Udall (D-Colo.) and Patty Murray (D-Wash.), both abortion advocates, are behind the new legislation and they said, "The Protect Women's Health from Corporate Interference Act would ban employers from refusing to provide health coverage—including contraceptive coverage—guaranteed to their employees and dependents under federal law."

Sen. Orrin Hatch said during a press conference that the bill is "not going anywhere." "This is the first time in American history that Congress will consider a bill intended to diminish the protection for the religious liberty of all Ameri-

cans," Hatch said. "It is part of a broader campaign to demonize religious freedom as the enemy, as an obstacle to certain political goals."

Not one Senate Republican has signed on to the legislation, which pro-life groups strenuously oppose. House Republicans will not take up the bill, making it so the legislation will not reach President Barack Obama, an abortion advocate who would sign it into law. In their ruling, the Supreme Court indicated Congress could change the law to require businesses to pay for the birth control and abortion drugs.

"There are other ways in which Congress or HHS could equally ensure that every woman has cost-free access to the particular contraceptives at issue here and, indeed, to all FDA-approved contraceptives," the opinion concluded.

Chief Justice John Roberts, Justices Antonin Scalia, Clarence Thomas and Anthony Kennedy joined in the majority decision. Justices Stephen Breyer, Elena Kagan, Ruth Bader Ginsburg and Sonia Sotomayor dissented.

Justice Anthony Kennedy wrote a concurring opinion saying that government itself could provide the coverage for contraception and the abortion-causing drugs if a company declines to do so.

A new Rasmussen Reports poll shows Americans agree with the Supreme Court's decision this week that the Christian-run Hobby Lobby doesn't have to obey the HHS mandate that is a part of Obamacare that requires businesses to pay for abortion causing drugs in their employee health care plans. "Half of voters agree with the U.S. Supreme Court that a business owner should be able to opt out of Obamacare's contraceptive mandate if it violates his or her religious beliefs," the polling firm reports about its new national survey.

A December 2013 Rasmussen Reports poll shows Americans disagree with forcing companies like Hobby Lobby to obey the mandate.

Abortionist Dr. LeRoy Carhart Closes Indianapolis Abortion Clinic

Timing of the Closure Corresponds to State Abortion Law Taking Effect

INDIANAPOLIS - Nationally known late-term abortionist, Dr. LeRoy Carhart, has closed his Indianapolis abortion facility. Carhart performed first trimester abortions at Affiliated Women's Services on Distributors Drive in Indianapolis. Affiliated Women's Services no longer appears on the state's list of licensed abortion facilities. The timing of the closure corresponds to the new state law requiring that abortion doctors report their admitting privileges credentials to the state, among other requirements.

Operation Rescue, a national pro-life organization that monitors abortion facilities, provided additional details on the Affiliated Women's Services closure: Financial woes and a lack of demand for abortions have shut down Affiliated Women's Services in Indianapolis, Indiana, where Carhart worked one day per week. Operation Rescue confirmed that the clinic owner, Lois Bennett, owes nearly \$20,000 in back property taxes on the abortion facility. The building is set to be sold by the county at public auction in

August in an attempt to recover the delinquent taxes. The abortion facility had been in operation for 32 years.

“After more than three decades in existence, the closure of Affiliated Women’s Services is significant,” stated Mike Fichter, President and CEO of Indiana Right to Life. “We are thankful that Dr. Carhart will no longer practice in our

state. We don’t know the specific reason for the facility’s closure, but the timing corresponds with new state law requiring abortion doctors to document their admitting privileges. If Dr. Carhart was complying with the law prior to having to prove his admitting privileges credentials, we don’t know who his back-up was.”

Members of Catholic Parish Rent Space in Building Abortion Clinic Leave

After years of prayer, a Catholic parish in Lansing, Michigan, found a way to get rid of an abortion clinic in their neighborhood: They leased an entire floor of the building that housed the clinic, forcing the doctor who committed abortions there to move out.

Father Steve Mattson, pastor of the Church of the Resurrection, said members of the parish had been praying for years in front of WomanCare, the only remaining dedicated abortion clinic in Lansing. Five times, the 40 Days for Life campaign gathered to pray on the sidewalk in front of the

clinic. Abortion opponents even raised funds to rent a billboard across the street, using the sign to offer assistance to women facing unplanned pregnancies

Bishop Earl Boyea, bishop of Lansing, has signed a lease on two suites totaling 4,100 square feet on the first floor of 1601 E. Grand River. Plans call for the south suite, where the abortionist had operated his business, to become the parish offices. The north suite will house a chapel and a new pro-life center. A blessing is being planned for their October one move-in date to rededicate the space to God.
