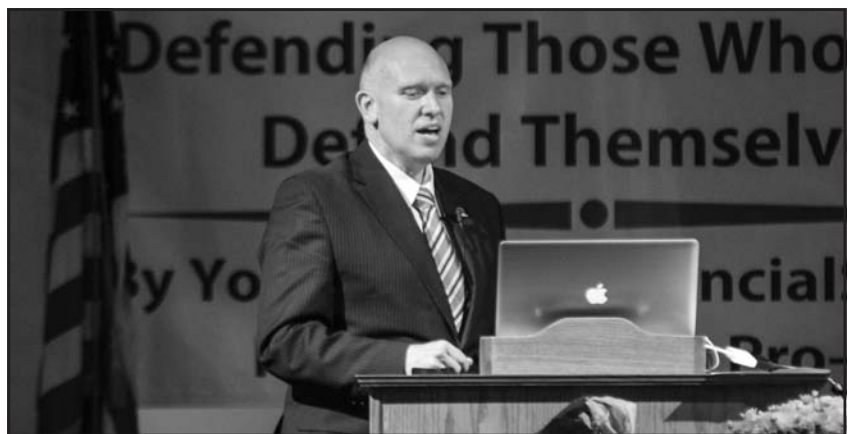


### **Jerry & Patti Schnarr Family Honored as the Adoptive Family at Annual Right To Life Banquet**

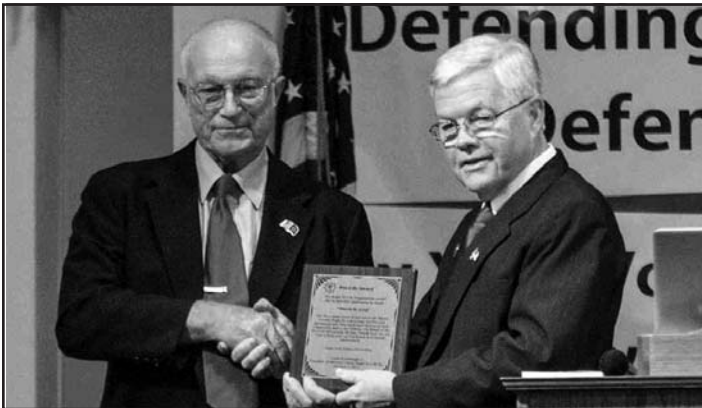
Garland was always right by Donna's side in all of those great moments, especially when Donna started the Pregnancy Care Center in Washington.

Daviess and Barr-Reeve school corporations. He was a current Daviess County councilman, serving over 30 years and was on the ballot for re-election this year.

He is survived by his wife, Alda "Til" (Graber) Graber, whom he married Feb. 14, 1964; one daughter, Jacqueline Graber-Thorne and husband Dr. Marcus Thorne of Washington. He leaves one brother, Willard Graber and four grandchildren.

Jack served as a table host for the Right To Life Banquets selling tickets for many years. Jack gave encouragement and support to the organization and he praised the organization for their support of adoption instead of abortion.

Jack was in failing health and got sick prior to the Banquet this year and was not able to attend. Jack will truly be missed as he was very involved in the community. May he rest in Peace!

# Huge Victory as Pro-Life Candidates Win Nationwide, Take Over Senate From Pro-Abortion Democrats

In a landslide election that saw pro-life candidates winning across the nation, pro-life advocates have been able to take over the Senate from pro-abortion Democrats, led by Senate Majority Leader Harry Reid.

Harry Reid's days as the pro-abortion leader of the U.S. Senate are now numbered as pro-life candidates picked up enough seats to take over the Senate. Reid has done pro-abortion President Barack Obama's bidding and ensured that abortion-funding Obamacare was passed through on a party-line vote, with not a single Republican voting in favor of the legislation. Reid made sure that no pro-life bills received a vote in the Senate—including measures to stop taxpayer funding of abortions and a bill to ban abortions after 20 weeks, when unborn babies can feel pain.

Republicans picked up seats in Montana, where pro-life Rep. Steve Daines was a winner and West Virginia, where Rep. Shelley Moore Capito votes 100% pro-life.

In South Dakota, the race slipped away from Democrats and pro-life Republican former governor Mike Rounds beat out pro-abortion Rick Weiland (D) and former GOP senator Larry Pressler. The final results in Arkansas showed pro-life Rep. Tom Cotton (R) beating pro-abortion Sen. Mark Pryor (D).

Colorado is a race where most political pundits expected pro-abortion Sen. Mark Udall (D) would retain his seat, but he ran a campaign obsessed with trashing his pro-life opponent, Rep. Cory Gardner, on abortion and turned himself off to voters to such an extent that Gardner led in almost every poll and eventually won the race handily. Iowa had a closely-contested race that has seen pro-life state Sen. Joni

Ernst (R) take on the phony war on women mantra in her race against pro-abortion Rep. Bruce Braley (D). Projections indicated that Ernst has won the race.

Kansas is a similar race that will go to the end, and it had pro-life Sen. Pat Roberts (R) taking on pro-abortion independent Greg Orman. The campaign appeared to be swinging back to Roberts after Orman had an early lead and Roberts has been projected to win. North Carolina rounded out this group of the closest Senate races that would determine whether Republicans have 52, 53 or 54 votes. Here, pro-abortion Sen. Kay Hagan fended off a competitive challenge from pro-life Republican Thom Tillis, and Tillis has a lead hearing into the final votes of the night.

In Georgia, pro-abortion Democrat Michelle Nunn lost a chance to get 50 percent of the vote and avoid an overtime battle as pro-life Republican David Perdue picked up steam in the final days on his way to winning.

In Kentucky, pro-life Senate Minority Leader Mitch McConnell kept his seat after battling pro-abortion Alison Lundergan Grimes.

In Alaska, pro-life Republican Dan Sullivan has led every poll for weeks and is expected to knock off pro-abortion Sen. Mark Begich (D).

Louisiana will go into an overtime runoff with pro-life Rep. Bill Cassidy against pro-abortion Sen. Mary Landrieu (D). Experts predict a pro-life pickup in the southern state.

With Republicans winning the Senate, pro-life advocates will have control of both the House and Senate and a real opportunity to pass pro-life bills or put pro-life language in must-pass legislation in a way that would force pro-abortion President Barack Obama to either sign the bills or veto them

# Tennessee Voters Approve Amendment 1, Will Allow Pro-Life Laws to Stop Abortions

Tennessee voters have given the Volunteer State a chance to enact the kind of pro-life laws that have dropped abortions to historic lows in state after state across the nation.

They approved Amendment 1 to help ensure nothing in the state constitution could be used to secure an unlimited right to abortion. With 86% of the vote counted, Amendment 1 won with a 54-46 percent margin.

The amendment is necessary because the Tennessee Supreme Court ruled 4-1 in 2000 that the state constitution allows unlimited abortions. It is necessary, pro-life advocates say, to be able to pass laws to limit and reduce abortions. The ruling claimed the Tennessee Constitution contains a fundamental abortion right even broader than *Roe v. Wade* or the federal constitution and it resulted in the striking down of numerous pro-life Tennessee laws that were helping women and limiting abortions.

Subsequently, the 2000 ruling was also used as precedent to strike state law requiring the inspection, regulation and licensure of abortion facilities in Tennessee, he explained. All of those pro-life protections—which have reduced abortions in some states by as much as 50 percent—could be restored now that the amendment has been approved.

Brain Harris, the Tennessee Right to Life president, told LifeNews previously that the 2000 ruling in *Planned Parenthood of Middle Tennessee v. Sundquist* made it so “common sense protections were immediately stripped from state law books including informed consent for women considering abortion, a 48 hour waiting period and a requirement that second and third trimester abortions be performed in regulated hospitals rather than out-patient abortion facilities.”

“We are grateful to God and to the good people of Tennessee for this victory,” Harris said. “Despite millions of abortion dollars flooding our airwaves with deceptive ads, the people of Tennessee saw through the falsehoods and made their voices heard.”

Harris told LifeNews that Yes on 1 coordinated a state-wide grassroots campaign heavy on volunteers and smaller financial contributions from individuals, churches and pro-life organizations.

“We recognized that we would never have the financial resources of the abortion industry so began planning long ago to build a team of advocates who could educate and

organize their local communities,” Harris said. “That effort paid off, especially in rural regions of the state where volunteers raised funds and awareness of both the amendment and the 2000 court ruling in *Planned Parenthood of Middle Tennessee v. Sundquist*, a decision which claimed a fundamental right to abortion.”

Harris also gave special credit to clergy and religious leaders throughout the state who made support for the Amendment a priority.

“In the end this could be characterized as pastors and pulpits in opposition to *Planned Parenthood’s* abortion-profiteering. We owe a debt of gratitude to men and women of faith who refused to accept Tennessee’s designation as an abortion destination and who actively used their influence to promote the protection of innocent human life.”

The text of the amendment returns authority for abortion regulation to the people of Tennessee and their state legislators and reads as follows: “Nothing in this Constitution secures or protects a right to abortion or requires the funding of an abortion. The people retain the right through their elected state representatives and state senators to enact, amend, or repeal statutes regarding abortion, including, but not limited to, circumstances of pregnancy resulting from rape or incest or when necessary to save the life of the mother.”

## After Losing Phony War on Women, Planned Parenthood Will Target African-Americans

# JaVale McGee: A Miraculous Story of a Fabulous Talent Almost Aborted

Editor's note. The National Basketball Association (the NBA) has just begun its 2014-2015 season. In light of that, I thought the following inspirational story would be very much worth re-telling.

## JaVale McGee

A tip of the hat to Jivin Jehoshaphat who posted a quote from and a link to a story in *Sports Illustrated* about professional basketball player JaVale McGee.

McGee was traded from our local team, the Washington Wizards, to the Denver Nuggets, in the process going from what was then a perennial loser to a team with a good shot at the playoffs.

The story, by Lee Jenkins, is extremely well written and is built around a common (because true) narrative about McGee: a raw talent whose prodigious potential is off the charts but who is among the league leaders in dumb plays. But from our perspective it is the first and the last paragraphs that matter most.

“On a Saturday morning in the spring of 1987, Pamela McGee sat on the shore at Dockweiler State Beach in Los Angeles, 72 hours from a scheduled abortion. ‘Do you want to be pregnant?’ the counselor at the clinic had asked her. ‘No,’ McGee replied. She was a single, 24-year-old professional basketball player, and she could not take maternity leave. And even if she could, she couldn’t imagine hauling an infant to Italy and parking the stroller next to the bench. But as McGee looked out over the Pacific, she began to reconsider. ‘I prayed and prayed and prayed and felt like I heard a voice from God,’ McGee says. ‘He was telling me, ‘This is your gift.’ The next day she went to Faithful Central Bible Church in Inglewood, and the pastor delivered a sermon about not aborting one’s blessings. O.K., God, McGee thought. You don’t have to beat it into my head. She called the clinic to cancel, and on Jan. 19, 1988, gave birth to a boy with physical abilities that would border on the supernatural.”

In between this remarkable beginning and the last paragraph is McGee’s story, inspiring on many levels. Although



he appears to the outside world to be the classic man-boy, there is an awful lot beneath the clownish exterior that leads you to believe that he will be as good a human being as he will be an outstanding basketball player.

But what gives the story that extra emotional punch—and it’s pretty powerful already, wouldn’t you say?—is that McGee’s near death was something he never knew about until recently. Here’s the last paragraph that ties the narrative together in an unforgettable manner:

“The day after last year’s dunk contest in L.A., JaVale called his mother at 8 a.m. and told her he wanted to go to church. Pamela was exhausted, with only five hours sleep, and surprised. But she knew just the place. During the sermon at Faithful Central Bible, JaVale looked over at his mom, tears streaking her cheeks. ‘Why are you crying?’ he asked. There, for the first time, Pamela told him about the clinic and the beach and the reason she cannot get all that upset about alley-oops gone awry. ‘For me,’ she told her son, ‘you’ve been such a blessing.’” Wow!!

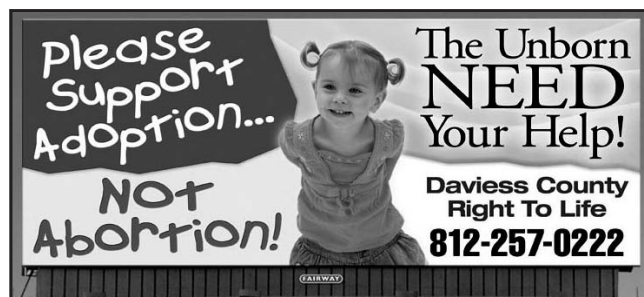
## New Right To Life Billboard, Hwy 50

## Ninety-one percent of Indiana Right to Life PAC-Endorsed Candidates Won

INDIANAPOLIS - Polling results show that the Indiana election results delivered a big win for unborn babies and their mothers. Indiana Right to Life Political Action Committee's (PAC) analysis shows:

- \* 100 percent of PAC-endorsed statewide candidates won (3 of 3). Three pro-life women, Connie Lawson, Secretary of State; Suzanne Crouch, Auditor; and Kelly Mitchell, Treasurer will all hold statewide office.
- \* 88 percent of PAC-endorsed U.S. House of Representatives candidates won. Incumbent Reps. Jackie Walorski (IN-2), Marlin Stutzman (IN-3), Todd Rokita (IN-4), Susan Brooks (IN-5), Luke Messer (IN-6), Larry Bucshon (IN-8) and Todd Young (IN-9) will all return to Washington, D.C.
- \* 100 percent of PAC-endorsed Indiana State Senate candidates won (20 of 20). The Senate will have eight pro-life freshmen, including two pro-life women, Senators-Elect Liz Brown (District 15) and Erin Houchin (District 47).
- \* 88 percent of PAC-endorsed Indiana State House candidates won (54 of 61). Three pro-abortion women, all incumbents, lost their seats in the House. All three seats

were picked up by PAC-endorsed candidates, including Representative-elect Julie Olthoff (District 19), the newest pro-life woman in the House.

Overall, 91 percent of PAC-endorsed candidates won their races. Only one endorsed incumbent lost, Indiana House Rep. L. Jack Lutz (District 35). A pro-life PAC-endorsed officeholder, with the exception of the Superintendent of Public Instruction, now holds every Indiana statewide office.

"We're thrilled with the election results," stated Mike Fichter, Chairman of the Indiana Right to Life PAC. "We believe the real winners are the unborn babies and their mothers in Indiana and across the nation. These pro-life officials will be able to strongly articulate and advance pro-life measures that inform women about their options and promote positive alternatives to abortion."

Indiana Right to Life PAC works to elect pro-life candidates to public office for the purpose of enacting public policy that protects the right to life of all persons, including the unborn. Indiana Right to Life PAC believes that the issue of life is paramount to all other issues because without the right to life, all other freedoms are without meaning.

## Pro-Life Eric Bassler Wins District 39 Senate Seat:

Washington City Councilman and Business man Eric Bassler won the Senate seat by defeating Steve Lindsey 61-39% in the Fall Election. Bassler who had Defeated State Senator John Waterman in the Spring Primary capped off his run for the State Senate with a resounding victory in the Fall Election. Bassler was endorsed by Indiana RTL PAC.
