We have been asked by new teachers if they should join the local teachers union. If you are a teacher in the public school system and belong to the Teachers Union, you most likely are affiliated with the Indiana State Teachers Association and the National Education Association. It is estimated that your dues are somewhere around \$750 per year, and that amount is split between the State Teachers Union (ISTA) and the National Union (NEA) with a very small amount going to the local teachers union.

The National NEA is a very pro-abortion organization and from what we understand the ISTA goes along with most of their agenda. Of the dues you pay per year, most of that money goes to fund these organizations which in turn

are used to lobby against Pro-Life Legislation. While Union leaders tell their members (that is when asked!) there is a check off box, so their dues do not go for political activities, but that does not prevent union leaders from lobbying against pro-life legislation.

These Organizations have supported agendas that conflict with many of your views. In closing, I would be very careful about joining your local teachers union. ## Teachers Union Is Pro-Abortion

Each year at the NEA convention, a stalwart group of pro-life advocates bucks the status quo of abortion-friendly union policies and protests the flow of their dues money to support abortion. They ask that the NEA become "abortion neutral." At the 2013 convention, a Bylaw Amendment was presented and voted on by delegates. Although it was voted down, it is a partial success for pro-life delegates because often the voices of those who oppose abortion are not heard at all. Several proposed actions have in past years been immediately "referred to committee," effectively killing them.

Bylaw Amendment 3 stated: "NEA will not use dues monies for politically supporting abortion."

In the Amendment impact statement, the union's legal counsel wrote: "NEA supports reproductive freedom, which encompasses the right of a woman to choose to have a baby or not to do so." The selection of the word "baby," in place of the usual term "fetus," disconcerted some delegates. There was concern that this might indicate union support for or condoning of partial-birth abortion or even the Gosnellesque practice

of killing babies born alive. Hoping for clarification, a delegate asked on the convention floor if this wording meant the NEA supports the death of a live baby. Union general counsel Alice O'Brien responded, "NEA supports family planning, including the right to reproductive freedom." No further comment was offered by union leadership.

Discussion was brief; only a few comments were allowed before a motion was made to end discussion. The following day the amendment was defeated in a secret ballot vote with a vote of Yes (33.79 %) and No (66.21%). The vote indicates that one-third of delegates support halting the union's use of dues for political support of abortion.

Delegates at the convention voted to support pro-abortion Texas state Senator Wendy Davis's 11-hour filibuster against a pro-life bill that would stop abortions after 20 weeks gestation. The union adopted this statement: "The NEA Representational Assembly commends Texas State Senator Wendy Davis for her courageous filibuster to protect women's rights."

## Kill the Child You Have Now or Kill the Child You Are Carrying, That is the Question

"I agree," the doctor replied. "But you seemed to be okay with it, so I thought maybe that was the best solution." The doctor smiled, realizing that he had made his point.

## Man Awakens After 12 Years in a “Vegetative State,” Says, “I Was Aware of Everything”



In the 1980’s, 12-year-old Martin Pistorious became seriously ill with what doctor’s believed was Cryptococci Meningitis. His health started deteriorating and Martin lost his ability to move, make eye contact and even speak to others. His doctors told his parents, Rodney and Joan Pistorious, to bring him home and let him die.

They told them he was as

good as a vegetable. However, he didn’t die. Joan said, “Martin just kept going, just kept going.”

According to NPR news, his father would get up at 5 o’clock in the morning, get him dressed, load him in the car, take him to the special care center where he’d leave him. Rodney said, “Eight hours later, I’d pick him up, bathe him, feed him, put him in bed, set my alarm for two hours so that I’d wake up to turn him so that he didn’t get bedsores.” For twelve years, Martin’s family cared for him without any sign that he was improving. Joan started to despair and even told her son, “I hope you die.”

Today she acknowledges that was a horrible thing to say but says she just wanted some sort of relief. Remarkably, now Martin is 39-years-old and says he was totally aware of everything going on around him.

He said, “Yes, I was there, not from the very beginning, but about two years into my vegetative state, I began to wake up. I was aware of everything, just like any normal person. Everyone was so used to me not being there that they didn’t

notice when I began to be present again. The stark reality hit me that I was going to spend the rest of my life like that—totally alone.”

Unfortunately, Martin was even aware of his mother’s harsh words and began believing that no one would ever love him. He said, “You don’t really think about anything. You simply exist. It’s a very dark place to find yourself because, in a sense, you are allowing yourself to vanish.”

Martin spent most of those days at a care center where his caregivers played Barney reruns over and over again. They did this because they believed he was a vegetable too. He said, “I cannot even express to you how much I hated Barney.”

But eventually, Martin became frustrated with being trapped in his own body and started to try and take control of his life. He learned to tell time by the rising and setting of the sun and would reframe even the ugliest of thoughts that haunted him like his mother’s wish for him to die. “As time passed, I gradually learned to understand my mother’s desperation. Every time she looked at me, she could see only a cruel parody of the once-healthy child she had loved so much,” said Martin.

Now Martin is married and has penned a memoir about his life. He has gained control of his body and in his book *Ghost Boy*, he writes, “My mind was trapped inside a useless body, my arms and legs weren’t mine to control and my voice was mute. I couldn’t make a sign or sounds to let anyone know I’d become aware again. I was invisible—the ghost boy.”

Martin’s survival is a testament to how little we actually know about the human brain and a good reminder that we should value all life—even when we hear the terrifying words “your loved one is a vegetable” or in a “vegetative state” from a medical professional.

# Rhode Island Bishop Refuses to Attend Inauguration of Pro-Abortion Governor

Good for Bishop Tobin. I can't stand pro-abortion politicians using the presence of bishops as an imprimatur for their pro-death politics. Roman Catholic Bishop Thomas J. Tobin said Monday as he rejected an invitation to attend Governor-elect Gina Raimondo's inauguration because of her stance on "the grave moral evil" of abortion.

"Over the weekend I did receive a formal written invitation to the Inauguration, the courtesy of which I appreciated," Tobin wrote in an email Monday night in response to a *Providence Journal* inquiry.

"However, as previously announced, I will be offering Holy Mass at the Cathedral at that same time to ask for God's blessings upon our state and nation and our public servants. "I should add, though, that in conscience, it would

always be a problem for me personally to attend the inauguration of any public official who promotes or supports abortion, which we consider to be a very grave moral evil," the bishop wrote. Tobin had sharply criticized Raimondo during her campaign for her support for abortion rights.

As he did four years ago, Tobin will offer a noon Mass at the Cathedral of SS. Peter and Paul to offer prayers for newly elected leaders, as "a Prayer to Our Nation." Raimondo is Catholic and in fact, her daughter is an altar server at her local parish. Bishop Tobin suggested that Catholic voters, instead of voting for Raimondo or other pro-abortion candidates write in "Mother Teresa" rather than cast a vote. He called the election "a pathetic spectacle."

## Roe v. Wade: Absurd, Deadly, Catastrophic – Roe V. Wade Is Simply Bad Law

In *Roe v. Wade* the U.S. Supreme Court ruled that the right to liberty protected by the Fourteenth Amendment of the Constitution includes an unstated "right to privacy" that is in turn "broad enough to encompass" a right to abortion (which is also never mentioned in the Constitution) and this entails that states are constitutionally required to permit abortion on demand. Got it?

There was no reason to think the Constitution contains a right to abortion, and every reason to think it doesn't. Most obviously damning are all the state abortion bans enacted in the latter half of the 19th century, about the same time the Fourteenth Amendment was put into place. As Justice William Rehnquist wrote in his *Roe* dissent, "To reach its result, the Court necessarily has had to find within the scope of the Fourteenth Amendment a right that was apparently completely unknown to the drafters of the Amendment."

Absurd? Completely.

The consequence of *Roe* (and its companion decision, *Doe v. Bolton*) was a Court-mandated, nationwide policy of

abortion on demand at virtually any stage of pregnancy. Almost forty-two years later, this policy has resulted in the legal and deliberate killing of more than 56 million unborn human beings. That's more than 56,000,000 innocent members of the human family.

Abortion, under the *Roe* policy, is the leading cause of human death. The number of Americans killed because of *Roe* dwarfs the number of American casualties from every war in our history combined.

But those comparisons can be misleading. Abortion isn't death in the service of national defense, freedom and justice, or death as a result of natural causes, like heart disease (as tragic as those deaths are). Abortion is intentional killing for the convenience or supposed benefit of others; it is the elimination of those very young, defenseless and voiceless human beings who get in the way of what we want. Abortion, in other words, is precisely the kind of injustice that our soldiers have fought and died to defeat.

# DESPITE RECENT PRO-LIFE GAINS, IT IS NOT TIME TO CELEBRATE YET

## Editorial: Keep the Pro-Life Momentum Going

The pro-life movement in the United States is riding a momentum swing right now that is among the strongest it has experienced in decades. No small part of that has been recent exposure of fraud, coercion, illegal activity and even atrocities like murder of pregnant women and infanticide in the nation's surgical abortion industry. The worst of the revelations were in a grand jury report in Pennsylvania against abortionist Kermit Gosnell. His facility was raided in a prescription-drug investigation; authorities were shocked also to find plastic bins of baby body parts. Equally disturbing was the report's allegation that state regulators had known for years of complaints about Gosnell's practice but simply sat on their hands.

The movement's seemingly invincible nemesis, Planned Parenthood, the largest abortion provider in the country, is also staggering under repeated blows to its reputation. A series of undercover videos shows Planned Parenthood employees apparently callous to the well-being of young pregnant women caught in sex-trafficking rings, and willing to engage in illegal activity to cover up rape and keep parents in the dark. The resulting media attention prompted the organization to fire one of the employees, calling her actions "repugnant and wrong," and to order training for its staff nationwide.

There's other bad news, too, for the pro-choice movement. In Kansas, a criminal case is moving ahead against Planned Parenthood with more than 100 counts, including 23 felonies that include performing illegal late-term abortions. And a pro-life group in Washington state has uncovered a police report showing a Planned Parenthood employee resisting even a police officer's demand that they release a 14-year-old girl (impregnated by a 20-year-old man) to her father's custody.

The revelations have boosted the most significant move to cut government funding—now more than \$360 million a year—to Planned Parenthood. In late February the House overwhelmingly passed a defunding measure, which Planned Parenthood's president decried in an email to supporters as "the most dangerous legislative assault" it had ever faced. Though the measure is unlikely to make it past Barack Obama's desk, even the president showed only lukewarm support for Planned Parenthood in an NBC interview in which he was asked about the video sting. Around the country, there have also been defunding efforts in state legislatures.

A telling display of the confusion and disarray among pro-choice ranks is a recent opinion piece in the *Washington Post* by Frances Kissling, former president of Catholics for Choice, a pro-choice advocacy group. Noting that a majority of Americans now identify themselves as "pro-life," she said it was time for pro-choicers to abandon their absolutist stance—which includes fighting any regulation of abortion—because "those arguments may have worked in the 1970s, but today, they are failing us, and focusing on them only risks all the gains we've made."

All these pro-life gains are a testament to the patient, peaceful and prayerful dedication of untold numbers of pro-lifers over the decades. But it is not time to celebrate yet. Among the threats on the horizon, special vigilance must be directed at two: the erosion of conscience protection for health care workers and facilities, and the potential for funding for abortion or other attacks on human dignity in the implementation of the health care reform bill. In both these areas, many pro-life leaders has played an admirable role in pressing the pro-life case on Capitol Hill. But it will be up to all pro-lifers to keep the momentum going.

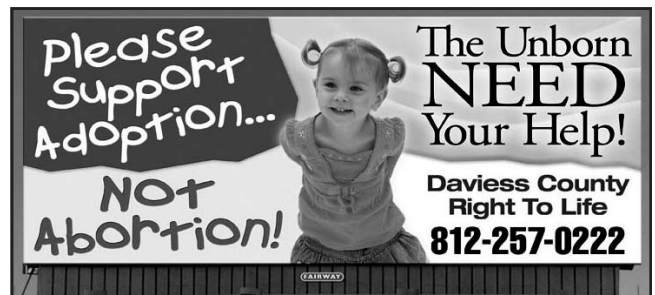
## New Right To Life Billboard, Hwy 50

# Pastor Says This One Sin Haunts Him With Grief and Shame Like No Other

In the pro-life movement, we hear a lot about abortion's negative effects on women and their mental health. However, we don't usually hear abortion stories from men and we certainly don't hear them from pastors. This is probably because, just like post-abortive women, post-abortive men can feel guilt and shame as a result of their involvement.

Shane Idleman is the founder and lead pastor of Westside Christian Fellowship, in Lancaster, California; and he recently opened up about his participation in an abortion on his church's blog: "Approximately 23 years ago, as a prodigal, I conceded to my girlfriend's request to abort our child around the 5th week of conception. The pain of that decision still haunts me today. What would they look like? Was it a boy or a girl? I can picture walking and talking with my child ... watching his or her first steps ... holding them when they cry and rejoicing with them when they succeed. But these are just dreams in my mind; dreams that often leave me heartbroken. Regret is one of the hardest pains to deal with because it is a constant reminder that we failed ... failed God, others, and the aborted child.

Groups such as Planned Parenthood say that there are little, if any emotional scars for the women involved ... the baby is just tissue. This is very deceptive—the emotional scars can last a lifetime. And it's not just women who feel the pain, the men often carry tremendous guilt as well.

This article was extremely difficult for me to write—I shed many tears, contemplated deleting it, and prayed diligently for direction. But I cannot, and will not, remain silent. There is a reason why "mother," "baby," and "abort" have been changed to "a woman's right to choose"; it's a marketing ploy designed to hide a brutal practice."

Although there isn't much research about abortion's impact on men, there is substantial evidence that indicates that post-abortive men suffer silently after abortion. According to the Silent No More Awareness Campaign, a group that works to help post-abortive men and women, men who are opposed to abortion but supported their partners' decisions may have an immediate reaction to the death of their child. They may feel sadness, grief, anger and a sense of not being able to protect

Additionally, as LifeNews previously reported, abortion is known to damage and even destroy romantic relationships. Brian Fisher, the President of Online for Life commented on the consequences of abortion for men. He said, "We are just now considering, though, that we victimize ourselves. Depression, guilt, shame, a loss of self, a loss of honor, and destroyed relationships are common male consequences of abortion. In our heart of hearts, we are coming to grips with what we're doing. We are willfully taking the lives of those we are wired to protect."
