## Spring Primary in Indiana on May 3<sup>rd</sup>

I know many pro-life people are asking themselves “How will we ever elect a pro-life president with all the bickering taking place within the Republican Party?” It is evident that on the Democrat side there are no pro-life candidates to be found, but on the Republican side there are many that have very good pro-life credentials; but with the way they are fighting each other you wonder if there will be anyone standing after the primary battles are over. Donald Trump continues to lead the pack and is drawing support from many Americans who feel we have gone too far on political correctness and are not strong enough on the protecting of our American citizens. His stand on the pro-life issue is in question; but as some pro-life leaders have said privately, he has to be better than Hillary Clinton. Ted Cruz is giving a strong challenge to Trump but has been fighting from behind for months and it is anyone’s guess how it will turn out. On the Democratic side, Hillary Clinton is expected to be the nominee – that is if the email scandal does not drag her into court. It is not expected the

Obama administration will do anything to hurt her chances, but independent investigations could cast a dark shadow on how she handled her office while serving as Secretary of State.

At this time the National Right to Life has not put out a voter guide on how the candidates stand on the pro-life issues. If that happens, we put it on our web site at [www.daviesscountyrtil.com](http://www.daviesscountyrtil.com). The nominee for both parties could be decided before the Indiana Primary, which will be on May 3. The question asked by many people is: who will the National Right to Life Political Action Committee endorse for president? I can’t answer that. Ted Cruz has a 100 percent pro-life voting record, and it appears he may be the most likely candidate to endorse; but because the campaign has got so nasty, they may be waiting to see exactly what happens at the convention. It appears more likely all the time that no candidate will get the required majority of delegates before the convention and it may be an open convention. So stay tuned.

We do have some interesting races here in Indiana – especially the race for U.S. Senator to replace Senator Dan Coats, who is not running for re-election. Two congressmen from Indiana are running to replace Coats. They are Marlin Stutzman (Dist. 03) and Todd Young (Dist. 09). Both men have good pro-life voting records while serving as congressmen from Indiana, and most likely Indiana Right to Life PAC will endorse both men for that office.

Another big race is the governor's race, which will have the incumbent pro-life Governor Mike Pence running for re-election against the former speaker of the Indiana House, John Gregg. Pence defeated Gregg four years ago in a close race. Governor Pence, along with other pro-life elected officials in both houses, passed legislation that has positioned Indiana as one of the most pro-life states in the country. This was done as both houses were controlled by pro-life republicans along with the governor's chair.

John Gregg, while speaker of the Indiana House seemed to put a hold on pro-life bills. He will not admit it, but while Evan Bayh was governor it appeared that Mr. Gregg assigned bills to committees that he knew would kill the bill. It was also widely suspected that a pact was made between Governor Bayh and Speaker Gregg to not bring up pro-life bills so Democrats would not have a recorded vote that might go against them in future elections.

Daviess County Right to Life plans to have a voter guide with information on how the candidates stand on the abortion issue by the spring primary on all the races here in Indiana for state and federal offices. In the meantime, the pro-life movement continues to pray that somehow sanity will prevail and a pro-life president will be elected in the end. Let us continue to fast and pray for that outcome.

# Indiana Passes Bill to Make it Second State to Ban Abortions Based on Down Syndrome

On Thursday March 24 Indiana Governor Mike Pence signed this legislation into law in spite of the negative press from the pro-abortion media and the abortion industry. An Indiana bill to protect unborn babies from being aborted simply because of a disability, race or sex was sent to Governor Mike Pence's desk in early March. The Indiana House gave final approval to House Bill 1337 on a 60-40 vote, sending it to the pro-life governor's desk. The state senate passed the bill in February.

Indiana House Bill 1337 would ban abortion doctors from knowingly aborting an unborn baby solely because of a genetic disability such as Down Syndrome, the unborn baby's race or sex. The bill also has several other abortion-related measures, including a requirement that aborted or miscarried babies' bodies be cremated or buried and another requirement that abortionists who have hospital admitting privileges renew them annually. The burial/cremation requirement backs up a law passed in 2015 by Governor Pence requiring that aborted babies' bodies be disposed of in a humane way.

State Senator Travis Holdman previously said the measure would basically make it "a criminal act" for an abortion doctor to knowingly end an unborn child's life because of discrimination against sex, race or disability. Indiana state Senator Liz Brown, who worked with Holdman on the measure, said previously that many families face pressure to abort from doctors or other health care professionals when their babies are diagnosed with an illness or disability in the womb. LifeNews has documented numerous cases of families saying the same thing.

"If you are born, we will love you, and we think you have equal rights and should be a member of society. In fact, we have

the Americans with Disabilities Act and have to make accommodations. But we don't want to make the accommodation before you're born, and in fact, it would really be easier if you were not born."

Indiana Right to Life President and CEO Mike Fichter praised the pro-life legislators for passing the bill. "We are truly thankful for the passage of this historic legislation by the Indiana House and applaud the new civil rights protections this bill creates for unborn children, as well as the new provisions this bill establishes for the humane final disposition of aborted babies," Fichter said. "The House leadership listened to our concerns and the concerns of pro-life Hoosiers across Indiana and made it a priority to concur on this bill before tomorrow's end of the session. "We Thank Governor Pence for signing the bill into law and establishing a new respect for unborn human life in Indiana," Fichter continued.

During the House debate, state Rep. Casey Cox, R-Fort Wayne, said the bill will give the most vulnerable a chance at life. "Ours is a policy that values life no matter who you are, where you come from or what your disability might be," Cox said.

According to the local news report, Indiana House Speaker Brian Bosma made an unexpected move when he also voted in support of the bill. Bosma reportedly does not often vote on bills; however, in this case, the Republican legislator said he wants to "protect the rights of the unborn."

In 2013, North Dakota became the first state to pass a similar bill to protect unborn babies from abortions because of disabilities. A handful of states also ban abortions based solely on the baby's sex.

## 8th District Pro-Life Leaders Meet with Committee Members Investigating Selling Aborted Baby Parts *By Louie Kavanaugh Jr.*

On Friday March 18 several Right to Life Leaders met with Congresswoman Marsha Blackburn and Congressman Larry Bucshon concerning their committee hearing on the sale of aborted body parts. Both Members of Congress sit on that committee with Congresswoman Blackburn serving as the chairman.

When this committee met for the hearings, pro-abortion Democrats on the committee did everything they could to derail the committee's research and investigation. The purpose of the committee was to find out what is taking place in the sale of aborted body parts and the connection to the abortion industry. It not only is investigating Planned Parenthood connections but the whole abortion industry.

The testimony thus far has been eye opening and shocking to say the least. It has been reported that those buying and reselling these body parts from the abortion industry have raised their profits by 1000 percent per year over the last several years. Now to set the record straight, it is illegal to sell body parts in any way shape or form. Expert witnesses that have appeared before the committee have given testimony that has been shocking, and it could have long range effects on the abortion industry. Members of the committee on both sides of the issue were shocked and taken aback by what some of the witnesses have stated thus far in this committee hearings. For the pro-abortion Democrats and the pro-abortion industry it was testimony they did not want to be made available to the public but rather kept secret. It was damaging, to say the least, for their profits and for their industry. Planned Parenthood is a big part of this problem, but they are not the only business involved in this messy story of selling body parts. It involves the whole abortion industry and it is not a pretty sight.

This is where you come in. The results are not being reported in the major media. Fox News has been the only major media to report anything on the hearings thus far. In fact, members of the press are spreading the pro-abortion **//continued on PAGE 7**

## Pro-Abortion Activists Say Aborted Baby Parts are Needed to Combat Zika Virus, But Research Proves Otherwise *By Micaiah Bilger*

Desperate to paint pro-lifers in a bad light, abortion supporters have been doing their best to claim that aborted babies' body parts are necessary to scientific advancements. However, a mounting list of evidence is proving that this is not the case.

Earlier this month, during a U.S. Congressional hearing on bioethics and fetal tissue, pro-abortion witnesses for the Democrats repeatedly claimed that progress on the Zika virus would require fetal tissue research. The Select Investigative Panel on Infant Lives, which conducted the hearing, is investigating abortion industry practices in the wake of the undercover videos showing Planned Parenthood officials trying to sell aborted babies' body parts.

U.S. Rep. Marsha Blackburn, a pro-life Republican from Tennessee who chairs the panel, pointed to new evidence that disproves the pro-abortion witnesses' claims. In a news release, Blackburn stated:

"I am extremely pleased with recent studies showing potential cures for Dengue fever and the Zika virus. Both diseases are causing untold pain and suffering to thousands of people. Both of these scientific breakthroughs show a solution to end these crippling diseases is on the horizon," Blackburn said. "I find it very interesting that this news comes in direct contrast to accusations made by Democrats and their witnesses during our March 2nd hearing on bioethics and fetal tissue where they claimed that the work of our panel would slow down progress on efforts to find a vaccine for the Zika virus."

When asked about the need for fetal tissue in understanding the implications of the Zika virus, Dr. Lawrence Goldstein told the select panel that "if you want to understand the Zika virus, the most efficient place to start is with the fetal tissue that is infected. That just seems self-evident to me."

Only days later, *The Washington Post* cited an academic article that reported a breakthrough about how the Zika virus infects the brain of preborn children. The discovery had been made through research using not fetal tissue, but induced pluripotent stem cells – an adult stem cell research tool that won the Nobel Prize in 2012.

The Democrats and their witnesses repeatedly cited vaccines as also requiring fetal tissue. But today it was reported that the first level trial on human subjects of a Dengue fever vaccine has been a success. The vaccine was developed using monkey and mosquito cells – not the organs of unborn babies.

"Loud and clear, Democrats have abused the hopes of those who are suffering with the claim that our investigative efforts would interfere with potentially life-saving research. This kind of political rhetoric demeans our commitment to an open and honest discussion and these recently reported discoveries show their claims to be patently false," said Blackburn.

A number of scientific researchers also have publicly stated that aborted babies' body parts are not essential to medical advancements. In an op-ed in the *Milwaukee Wisconsin Journal*

*Sentinel* last September, six doctors explained why using fetal "tissue" for research is unethical and unnecessary for scientists.

"The argument that fetal-derived tissues must be used in research to develop medical treatments is false," they wrote. "Many therapies have been developed using cell lines not of fetal origin, including insulin for diabetes (produced in bacteria), Herceptin for breast cancer and tissue plasminogen activator for heart attack, stroke and pulmonary embolism (both developed in Chinese hamster ovary cells)."

The evidence that abortion groups are profiting off aborted babies' body parts has prompted a number of states to introduce legislation to ban the sale and/or donation of aborted babies' body parts. However, abortion activists have been attacking these bills as "anti-science."

The federal law that technically prohibits the sale of aborted babies and their body parts was written by a pro-abortion congressman decades ago and essentially spells out a process by which sellers of aborted baby body //continued on PAGE 7

# Mother Angelica, Founder of the Eternal Word Television Network (EWTN), Dies Easter Sunday at 92

Mother Angelica, whose vision for a global Catholic television network was unprecedented, will be mourned by millions of people whose lives have been touched by her indomitable and God-centered spirit. Mother Angelica made “pro-life” the cornerstone issue in all aspects of EWTN’s programming.

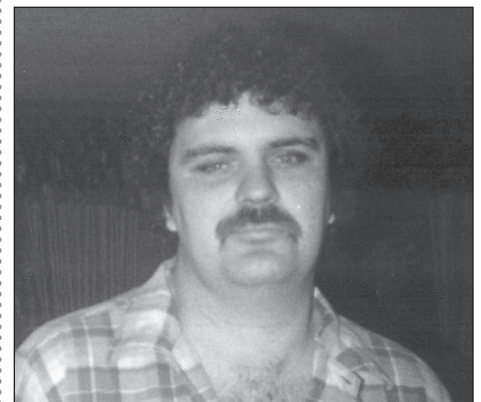
“A great pro-life visionary has gone to God,” said Carol Tobias, president of National Right to Life. “But the work Mother Angelica started has had a tremendous impact on the world and will continue to do so. EWTN is a great friend and ally to pro-life people of every faith. We are deeply grateful for her love and caring for all God’s children.”

After moving to the South, Mother Angelica’s vision took form in Irondale, Alabama. Her natural and distinctive approach to teaching the Catholic Faith led to parish talks, the publication of pamphlets and books, then radio and television opportunities. By 1980, the Nuns had converted the garage of their monastery into a television studio. With only a high school education, no television experience, and only \$200 in the bank, Mother Angelica officially launched the *Eternal Word Television Network* on August 15, 1981. She served as EWTN’s first Chairman and Chief Executive Officer. It was a long hard road and Mother Angelica faced bankruptcy several times. But she refused to allow paid advertisements to fund EWTN, relying solely on viewer donations. In 1981 when Mother Angelica launched EWTN, it had approximately 20 employees. Today, EWTN’s staff of nearly 400 employees prepares and transmits 24-hour-a-day programming to more than 264 million homes in 144 countries. In addition, its religious network broadcasts terrestrial and shortwave radio around the world, operates a religious goods catalog, and publishes the National Catholic Register and Catholic News Agency, among other communication enterprises. Mother Angelica is living proof that one determined person, with God’s grace can change the world.

## The People RTL Needs the Most Just Won't Help *By Louis Kavanaugh Jr.*

Over the thirty some years I have worked in the pro-life movement it has had its ups and downs. One of the biggest complaints I hear from fellow pro-life people is that the very people that should help the pro-life movement the most are turning a deaf ear or just turning their backs on us. What I hear the most is that some churches and clergy just will not help, and they forbid any co-operation with the pro-life movement. I do want to say that this is not true in all cases, as we have a good relationship with many clergy and churches in our area. What I am talking about was brought home to me recently when I read a letter from Father Frank Pavone, who is head of Priests for Life. In this letter he laments the problems that he has in his church and the roadblocks that he has to endure.

***This is what Father Frank Pavone had to say in the part of the letter that caught my eye:***

“In a nutshell, the obstacle we have is that many of those who should be our allies are under the very misguided impression of what the law permits the church to do regarding elections. Priests, bishops and other officials in the church have often gotten very bad advice, which in turn leads to massive self-censorship regarding what to say and do during elections.

“Tragically, too many advisors have instilled a tremendous fear of the IRS in too many of our bishops. So much so that when one of your fellow pro-life warriors asks his pastor for permission to speak to Catholics in the pews, inform them about what’s happening to babies in the womb, urge them to get

involved in the political process and tell them how important it is that they take their Catholic pro-life principles with them when they enter the voting booth, the pastor – often under orders from the chancery office (his bishop) usually refuses to give permission because he’s been told that such activities would jeopardize the church’s tax-exempt status and violate the law.

“Now some individuals giving this advice to our bishops do so because they truly believe they are keeping their bishops out of trouble with the government and out of the IRS crosshairs. Others do so out of pure ignorance of the law and the rules. And still others are politically motivated in favor of the Democrats. But whatever the reason behind the advice, the fact is that so much of the advice that is being given and that finds its way into official memos at election time.”

He goes on to say that **SILENCE** from the pulpit is allowing abortion-on-demand to remain the law of the land. ***This is what needs to be done:*** All churches can and must inform their members not to vote for people running for office who are pro-abortion. Churches don’t have to endorse candidates,

just inform the voters who is pro-life. This is not happening and our country is suffering because of it. Those individuals who say neither party is pro-life just do not know what they are talking about. One party may not be as pro-life as we would like, but we know how the President and his party stand on abortion. They are pro-abortion from top to bottom. Let us do our best in this election year to get our message out. The unborn are depending on us. So vote pro-life!

## Students Call Georgetown University’s Hosting of Planned Parenthood CEO a “Slap in the Face” *Life-News, Adam Cassandra*

Pro-life students at Georgetown University are planning events and demonstrations on campus in protest of the University’s scandalous hosting of Planned Parenthood CEO Cecile Richards, saying the event is in direct conflict with Georgetown’s Catholic and Jesuit identity, and is a “slap in the face” from the administration. “Our school community is a thriving and enriching one — our Jesuit values animate our campus, inspiring us to care for the whole person and celebrate life and all its beauty. The ‘throw-away culture,’ in the words of Pope Francis, that Ms. Richards endorses is neither consistent with our values nor our school character,” the student group Georgetown Right to Life said in a statement sent to The Cardinal Newman Society.

“Planned Parenthood is our nation’s largest abortion provider, performing [over 320,000] abortions in 2015 alone. This event featuring Planned Parenthood’s president, which would be unprecedented for a Catholic school of Georgetown’s stature, stands in direct contrast to our school’s mission and our Catholic and Jesuit identity,” the students continued. “This invite is a slap in the face to

all that we stand for, and we hope Georgetown reconsiders.”

The student group started a petition effort demanding that Georgetown rescind the invitation to Richards, and is drafting a separate letter to campus administrators about the scandal.

The exact date of Richards’ address has yet to be publicly announced, but Khan said that pro-life students on campus are planning to host a panel discussion the day before the event entitled “Life-Affirming Alternatives to Planned Parenthood” featuring at least one member of Congress along with pro-life health experts. Khan said Georgetown Right to Life is inviting a number of pro-life advocates to the University as well.

Students are also planning to place 3,300 flags on campus representing the total number of abortions committed in the U.S. each day. The Newman Society has continued to point out in its coverage of this scandal that according to Planned Parenthood Federation of America’s records of “abortion services” disclosed in annual reports, Richards has overseen the deaths of over 2.8 million babies since taking charge of the organization in 2006.
