Marvin served for many years as president of Martin County Right to Life and worked closely with Daviess County Right to Life along with Indiana Right to Life and other pro-life groups.

He designed and made the pro-life wooden signs that dot the highway landscape along Daviess and Martin County highways. In fact it was in September of 2018 while putting up one of the signs that Marvin thought he was having back trouble, but it turned out to be much worse. It was late November before he was diagnosed with stage four cancer.

As an individual Marvin worked in the election campaigns of numerous pro-

life candidates and was instrumental in the election of pro-life Congressman John Hostettler and many others. He worked tirelessly for the unborn in whatever way he could. Marvin worked for many pro-life candidates over the years, and when he was 80 years old he retired as president of Martin County Right to Life but continued to work for the pro-life movement in various roles.

We thank him for his many years of service and he will be missed. We are thankful for the many contributions that Marvin

made to the Right to Life and for his dedication in saving the lives of the unborn. Marvin was 84 years old when he passed and would have been 85 in January. He was a fine Christian man that strongly believed in the Right to Life for all God's children. He was a veteran and was a patriot for his country. We say "Well done, good and faithful servant". May the angels welcome you into Paradise.

Yes, he had help, but he was the mastermind to design how each would fit into place and how we could swap out the old signs and put in new ones with little trouble. I worked with the printer to design the content of the signs and would pick them up, but Marvin and Van or Alan McAtee would help to get them in the ground. It was a team effort, but Marvin was the team leader.

Marvin also drove in many parades for the Right to Life and also for the John Hostettler campaign. One thing he mentioned was that when John came around he always would call Marvin by his first name. Marvin always appreciated that because that doesn't always happen. Marvin drove in several parades and more than one a day for the Hostettler campaign.

As the saying goes, nothing stays the same, and there comes a time when we have to say goodbye to our dear friends. It happened in 2011 when Donna Gentry died suddenly while we were honoring her, and it took some time for us to regroup and go on. I am sure this will not be easy, but Marvin would want us to go on and continue the work that he began years ago. We don't know how many lives have been saved by the work that Marvin has done over the years, but as his friend Van McAtee told me, he felt a host of little angels were singing and met Marvin as he entered the heavenly kingdom that day.

Planned Parenthood Abortion Biz Remains Funded Despite Shutdown. Here's Why.

O ne of the most frequent questions and comments we get at LifeNews is a question about why pro-life Republicans never shut down the government to defund Planned Parenthood. As we have explained, shutting down the government doesn't shut down Planned Parenthood funding. And the current government shutdown over the battle related to securing the border proves that to be the case. While portions of the government are currently "shut down," the abortion giant continuous receiving taxpayer funds. Why?

There are few answers. One is because Planned Parenthood taxpayer funding comes in multiple forms. There isn't just one line in some government budget saying that Planned Parenthood will receive X number of dollars that can easily be deleted and a magic wand waved to defund Planned Parenthood. There are multiple funding mechanisms under which Planned Parenthood receives tax dollars. Many of those come in the shape of federal grants in family planning or sex education programs. The federal government funds those programs in general and then any eligible medical provider is qualified to apply for funding, as Planned Parenthood aggressively does.

President Trump is working on rooting out Planned Parenthood funding but it is a difficult process because, again, there is not just one funding line item that can be taken out of a bill to defund Planned Parenthood. Funding rules have to be promulgated and enforced that restrict grants to organizations that kill babies in abortions or that show preference for abstinence education, for example. And in each funding case where the Trump administration is putting those defunding rules in place, Planned Parenthood is taking the Trump administration to court to claim it is unfairly discriminating against the abortion business when it doles out taxpayer funds under those programs. And in these cases, these government programs are funded for future fiscal years, meaning the funding will continue until the fiscal year ends, making it so a temporary shortterm government shutdown doesn't affect the programs.

Dozens of Catholic Members of Congress are Abortion Activists. Here's a List.

The 163 Catholics in the new Congress are split on abortion: almost all Republicans are pro-life and almost all Democrats are abortion-rights advocates. For incumbents, we checked their voting record as scored by NARAL and National Right to Life. Typically, those who received a 100% NARAL score garnered a 0% rating from National Right to Life (which would be most Democrats), and vice versa (which would be most Republicans). For Freshmen, we checked their stated positions on abortion, and the endorsements they received from pro-life and abortion-rights groups.

YOU CAN'T BE CATHOLIC & PRO-ABORTION

There were a few notable exceptions. Among them are Rep. Daniel Lipinski, a Democrat from Illinois: he received a 51% rating from NARAL and a 75% score from National Right to Life. More Republicans than Democrats differed with the majority in their own party.

For example, Sen. Lisa Murkowski of Alaska agreed with NARAL 42% of the time, and with National Right to Life 28% of the time. Sen. Susan Collins of Maine received a 45% score from NARAL and a 42% score from National Right to Life. Rep. Walter B. Jones of North Carolina garnered a score of 51% from NARAL and a rating of 85% from National Right to Life.

It is obvious that religion is not a reliable predictor of the way a Catholic member of the Congress will vote on abortion. Party matters—not religion.

President Trump Has Kept His Promise, Nominating Dozens of Good Conservative Judges

WASHINGTON — President Donald Trump has gotten more judges confirmed to federal appeals courts in his first two years in office than any president in modern history. With 30 new circuit judges on the bench, and a dozen nominees pending in the Senate, Trump has more than made good on a campaign promise to reshape the judiciary.

To give perspective, what President Trump has already accomplished in two years with what President Obama succeeded in doing during his entire first four years: There are 167 judgeships on the regional appeals courts, not counting senior judges who handle a smaller docket and don't normally participate when the full court hears cases. Trump has already gotten 30 appeals judges confirmed, making up 18% of those seats.

That's how many appeals judges were confirmed during Obama's entire first term. A good reminder, yet again, that elections do have consequences.

Supreme Court Could Agree to Hear as Early as January 4 a Challenge to Indiana Law Banning Abortions of Babies Diagnosed with a Disability

This week the legal publication, *The Indiana Lawyer*, posted a story reminding us that the justices of the Supreme Court will meet for their first conference of 2019 on January 4. At that time they begin consideration of what cases the High Court will hear in 2019, which would include Indiana's HEA 1337. That law, signed by then-Governor Mike Pence, bans abortion for the sole reasons of the child's race, sex, or a potential disability such as Down syndrome. HEA 1337 requires that women be informed of this prohibition as part of Indiana's informed consent process. HEA 1337 also requires that abortion clinics bury or cremate the remains of aborted babies in a dignified fashion. Four of the nine justices must vote to accept a case, according to the Supreme Court rules.

Catholics Want Andrew Cuomo Excommunicated for Signing Law Legalizing Abortions up to Birth By Micaiah Bilger, Washington, DC

Catholics are urging church leaders to publicly excommunicate New York Governor Andrew Cuomo after he signed a radical pro-abortion bill into law this week. The Democrat governor claims to be a devout Catholic and even quoted Pope Francis to back up his opposition to the death penalty. But he also is a radical abortion activist who threatened to hold up the state budget until the legislature passed a law legalizing abortion for basically any reason up to birth.

On Tuesday Jan. 22, state lawmakers did, and Cuomo celebrated. To mark the expanded killing of the unborn, he ordered that the One World Trade Center and other state landmarks be lit in pink "to celebrate this achievement and shine a bright light forward for the rest of the nation to follow." The so-called Reproductive Health Act goes beyond Roe v. Wade, allowing unborn babies to be aborted even when the U.S. Supreme Court has said states may restrict abortions. The law's broad language will allow late-term abortions on viable, healthy unborn babies for basically any reason up to birth in New York.

Now, Catholics are demanding that Cuomo be excommunicated for supporting the slaughter of babies in the womb.

Every Senate Democrat Except Two Just Voted for Taxpayer Funded Abortions

Pro-abortion Democrats in the U.S. Senate blocked a bill Thursday that would have permanently ended taxpayer-funded abortions. The vote was another indication that Democrats are beholden to abortion, despite polls showing that even a sizable percentage of Democrats oppose abortion. The vote was 47-46 in favor of the "No Taxpayer Funding for Abortion and Abortion Insurance Full Disclosure Act of 2019," but it needed 60 votes to end debate and move forward.

Senate Bill 109 would have established a permanent, government-wide prohibition of taxpayer funding for abortions. Similar policies, such as the Hyde Amendment, currently require annual passage and do not apply to Obamacare. Despite strong public support for such legislation, just two Democrats voted in favor of the bill: U.S. Sens. Joe Manchin, of West Virginia, and Bob Casey Jr. of Pennsylvania. Both have mixed pro-life voting records. All other Democrats voted no. The bill needed 60 votes to invoke cloture (end a debate or filibuster), and proceed forward in the U.S. Senate. Most Democrats vote with the wealthy abortion industry rather than for their constituents' interests when it comes to the abortion issue. "It's time to end the charade, even the lie, that Andrew Cuomo and others like him are Catholics in good standing," Monsignor Charles Pope wrote at the National Catholic Register this week. He said New York bishops have not done enough to condemn the heinous actions of so-called Catholic politicians like Cuomo.

Editor's Note: It is time for our Catholic Bishops to show their members in the church pews they will not allow Catholics who hold public positions in the community to create scandalous activity by promoting the killing of the unborn. It is time for action that has been long overdue. Elected officials like Governor Cuomo have given the impression that it is OK to support the killing of the unborn when in fact the church is very much opposed to abortion. If Andrew Cuomo can push abortion without any consequences, what message does that send to other Catholics in the church? San Antonio, Texas Abortion Clinic Will Close Down Next Week, Saving Babies' Lives

An abortion facility in San Antonio, Texas appears to be closing this December after dedicated pro-lifers worked for years to save babies from abortion there. Several pro-life groups that do sidewalk counseling outside Whole Woman's Health on East Southcross Boulevard in San Antonio confirmed this week that the abortion facility plans to close.

"We have confirmation from a woman that called to schedule an abortion and they told her today that they will be closing by the end of the year but referred her to Planned Parenthood or to Alamo Reproductive Services," Texas Family Action wrote Thursday on Twitter. The prolife group said it does not know why the abortion facility is closing. Tigers for Life, the student pro-life group at Trinity University, and Life Chain San Antonio also shared the news online. The students gave credit to A Woman's Haven, a pro-life pregnancy center, and its mobile ultrasound van that provides women with free information and support outside the abortion facility.

40 Abortion Clinics Closed in 2018, 79% of All Abortion Clinics Open in 1991 Have Shut Down Cheryl Sullenger, Washington, DC

The number of abortion clinics in America continued to decline in 2018, following a trend that has seen an overall decrease of 159 abortion facilities since 2012.

Overall, in 2018, 40 abortion facilities closed or no longer qualify as abortion clinics. Today, there are a total of 697 abortion centers left in America – seven fewer than there were at the end of 2017.


Operation Rescue defines "abortion clinics" as those businesses that conduct abortions outside a hospital setting. There are two categories of abortion clinics:

- Surgical Abortion Clinics: These offices conduct surgical abortions. Almost always, surgical facilities also distribute abortion-inducing drugs.
- Medical Abortion Clinics: These offices supply abortions through the administration of drugs (pills) or other chemical means. They do not conduct surgical abortions.

In 2018, *eight* medical abortion facilities closed permanently. Although the number of medical abortion facilities has increased, they merely occupy a larger piece of an ever-shrinking pie. Unable or unwilling to meet new surgical facility safety regulations, some have resorted to dropping surgical abortions as perhaps their only means of staying open – especially in states that do not regulate med-

ical abortion clinics or that allow non-physicians to dispense the drugs. But that does not mean that Planned Parenthood is

doing more abortions than the 49 percent of clinics that are not affiliated with them. On the contrary, a report released in November 2018 by the Abortion Care Network claims that independent abortion facilities conduct 60 percent of all abortions in the U.S., while Planned Parenthood facilities account for only 35 percent. "We cannot afford to forget about the non-Planned Parenthood abortion facilities because they do the vast major-



ity of abortions," said Newman. "Independent clinics generally tend to be for-profit businesses, and that motivates them to conduct as many abortions as possible."

Nick Sandmann's Family Hires Lawyer to Go After Liberal Media with Libel Lawsuits Steven Ertelt, Washington, DC

The liberal media outlets that went after Nick Sandmann may soon be paying the price. His family has hired a lawyer who specializes in libel lawsuits to go after the liberal media outlets that viciously attacked him and other pro-life teenagers. Sandmann is one of a group of pro-life teens from Covington Catholic High School that were subjected to hatred, harassment and intimidation from liberal activists and the liberal media.



They were falsely accused of harassing a Native American man hours after the March for Life ended.

Liberal media outlets went as far as comparing Sandman and his pro-life friends to the KKK for wearing hats supporting president Trump. But according to news reports, Sandmann's family are not taking the attacks lying down: The family made the announcement in a statement released by the Hemmer DeFrank Wessels law firm, *The Enquirer* reported. "Todd McMurtry, the family's legal counsel, conducted an extensive search to find a nationally-recognized attorney skilled in the fields of libel, defamation, and the First Amendment," the release said. "Mr. Wood brings an unrivaled record of success in the courtroom, having represented such clients as the family of JonBenet

Ramsey, former Rep. Gary Condit and Richard Jewell in lawsuits against the media," McMurtry wrote. "Mr. Wood visited with the family today in northern Kentucky. He is committed to bringing justice to 16-year-old Nick Sandmann and his family. Further announcements should be expected in the next few days."

Liberal Media Ignore Pro-Life March for Life, Promote Pro-Abortion

A BC, NBC and CBS's morning news shows all ignored the 46th annual March for Life happening today in Washington D.C., the largest pro-life gathering in the nation, where an estimated hundreds of thousands of people are expected to show up to protest the legalization of abortion. Even as President Trump is expected to address the crowd via video for the second year in a row, the liberal networks still couldn't find time to report on the march. Still it seems an anti-Trump march happening tomorrow is more interesting to the networks. CBS gave a whole segment to the feminist, anti-Semitic "Women's March" scheduled for Saturday but didn't even give a passing mention to the March for Life.

ABC and NBC had plenty of time to give to fluff stories Friday morning, from Meghan Markle's fashion, to "nomophobia" which is an addiction to one's phone. Yet the networks shunning the pro-life movement is nothing new. Even President Trump called out ABC in 2017 for habitually ignoring the annual protest, leaving reporter David Muir speechless. In 2018, MRC Culture did a five year study showing just how little time the networks had given to the march, giving three times more coverage in just one year to the Women's March.

They gave a whopping 13x more coverage to Parkland's "March for our Lives" which was backed by several radical gun control groups, even as the two marches both claimed to seek the same goal, saving lives.

Even when the media covers the pro-life march, it's only to smear it, such as *The Washington Post* sneering pro-lifers were "anti-science."

A Tale of Two Marches: The Two Sides of the Abortion Debate

Today, tens of thousands are descending on Washington, D.C., for the forty-fifth year in a row to demand an end to legal abortion. Every year since *Roe v. Wade*, the March for Life has served as a public witness to the whole nation of the millions killed in the womb in the name of sexual freedom.

But this year, the March for Life will be immediately followed by another and very different demonstration. Tomorrow the Women's March—which gained notoriety in 2017—will take to the National Mall in support of causes that have expanded far beyond just women—and they're all progressive causes. But the central cause of the Women's March is unquestionably abortion.

The Women's March started as a protest against President Trump and his checkered history with women. But since then, it has morphed into an openly pro-abortion demonstration. There is no room at the event for any other view, as Kristen Day found out last year when she was chased off for holding a pro-life sign.

Devotion to abortion has hijacked not only this women's movement, but an entire political party. Democratic delegates cheer *Roe v. Wade* at their national conventions and have officially adopted abortion at any time for any reason into the DNC platform. Funding international abortions was among the first priorities of the new majority in the U.S. House this year, and supporters of the so-called "right to choose" have gone from defending abortion as a tragic necessity to openly celebrating and even joking about it.

Shout Your Abortion is an organization that produces videos and testimonies from women in an effort to remove the "stigma" of abortion. In a recent sickening video, the founder of Shout Your Abortion sat down with middle school children and explained to them why killing an unborn baby is just like having a bad "dentist appointment."

She described to two young girls how an abortionist "suck[ed] the pregnancy out" of her womb, and shot down another student's suggestion that adoption might have been a better option. If you're not already queasy, the founder of Shout Your Abortion plans to keep on shouting in a soon-to-be-published children's story book.

Even Planned Parenthood has gotten bolder about what they do. They've now dropped their long-used strategy of insisting that dismembering babies is just "3 percent" of their business. But it wasn't because they were repeatedly called out for their dishonesty (even the *Washington Post*, by the way, gave them three Pinocchios for that claim).

No, earlier this month, Planned Parenthood's new president, Leanna Wen, announced that providing and expanding abortion is her organization's "core mission."

The pro-choice movement is now officially and unashamedly the pro-abortion movement, and they will not tolerate anyone unwilling to join their celebration of death. Pro-life activist Lila Rose thinks this has a lot to do with how hard our movement has pushed their movement. She told me this week on the BreakPoint Podcast that abortion proponents are on the defensive right now. With two new justices on the Supreme Court and another looking increasingly likely, it's no wonder.

But something deeper is fueling the anger on display at the Women's March and by abortion defenders. On Tuesday, Lila and several other leaders at a panel discussion in Washington, D.C., suggested that 45 years and sixty million abortions have left behind a wake of wounded souls. In other words, all this shouting about abortions is only an attempt to drown out the voice of conscience welling up inside millions of men and women who have made a terrible choice.

And if that's true, neither the pro-choice demonstrators at the Women's March nor the execs at Planned Parenthood are really our enemies. No, they're broken people in need of repentance and forgiveness. So as we march for life in Washington for the 45th time, let's pray that God uses our efforts to break the hold of death on our culture and our laws, but also to usher the many victims of abortion into eternal life.

Pro-Abortion Justice Ruth Bader Ginsburg Will Miss Supreme Court Arguments for First Time

The Supreme Court says Justice Ruth Bader Ginsburg is missing arguments for the first time in more than 25 years as she recuperates from cancer surgery last month. Court spokeswoman Kathy Arberg said Monday the 85-year-old Ginsburg is continuing to recuperate and work from home after doctors removed two cancerous growths from her left lung on Dec. 21.

The elderly pro-abortion Supreme Court Justice instantly becomes a trending topic on social media anytime her health is in the news. Political observers on both sides are carefully watching her health to determine if she is able to continue as a Supreme Court Justice or if President Donald Trump will get yet another nomination to the nation's highest court.

After the confirmations of Justices Neil Gorsuch and Brett Kavanaugh, pro-life advocates are hopeful that the Supreme Court is closer to overturning *Roe v Wade* and once again allowing states to legally protect unborn babies from abortion. Should Ginsburg pass away or no longer be able to serve on the Supreme Court due to health concerns, a replacement justice would almost definitely shift the court in the pro-life direction.

Over the summer, Ginsburg said she has no plans to retire any time soon.

A reliable supporter of abortion on demand, Ginsburg is 85 years old. But during a public appearance, she told CNN she plans to stay on the court until she is 90. "I'm now 85," Ginsburg said. "My senior colleague, Justice John Paul Stevens, he stepped down when he was 90, so think I have about at least five more years." Ginsburg is beloved by abortion activists because of her decisions on the high court since the 1990s. A new film, scheduled for release on Christmas, will glorify her liberal activism. "A woman's control of her own body, her choice whether and when to reproduce, it's essential to women and it's most basic for women's health," she once said. In 2016, she was one of the five justices who sided with abortion activists in *Whole Woman's Health v. Hellerstedt*, which struck down Texas abortion clinic regulations.

In a rare interview with the *New York Times* in 2016, Ginsburg said laws should not deny a woman "her right to choose" to abort her unborn baby. She and four other justices ruled that these safety regulations were an "undue burden" on women's access to abortion. There has been speculation that Ginsburg might retire while President Donald Trump is in office, and open up the opportunity for Trump to appoint three conservative justices to the high court. However, Ginsburg has repeatedly stated that she will not retire while she still is able to serve.

 \mathbf{V} ice President Mike Pence made a surprise visit to the March for Life on Friday, giving pro-life advocates hope that one day "we will abolish abortion." Joined by his wife, Karen, on stage, the pro-life vice president introduced them, saying, "We're the Pences, and we're pro-life." "We've got a record of extraordinary progress on the right to life," Pence said, referring to various pro-life actions by the Trump administration. "This will be the generation that restores the right to life in America." Pence praised pro-lifers for being a movement "defined by compassion and love." He thanked pregnancy center volunteers who help mothers and babies, families who have adopted children in need, and pro-life politicians who are fighting for the rights of the unborn. After addressing the large gathering, Vice President Pence introduced the president, who addressed the group with a recorded message. The president pledged to the marchers he would veto any bill promoting abortion. This president has followed through on his commitment to the pro-life movement.
