# House Democrats Continue to Block Republican Bill to Stop the Killing of the Unborn at Birth

Its goals include defeating President Donald Trump and pro-life lawmakers who defend the rights of unborn babies.

Two of the pro-abortion group's big targets are Michigan and Minnesota, according to Michigan Public Radio.

### National Right to Life Endorse President Trump for Re-Election

A head of its 49th annual convention, the National Right to Life Committee endorsed pro-life President Donald Trump for his re-election. "As our nation celebrates Independence Day, we are proud to endorse the only presidential candidate who stands for the unalienable right to life," said Carol Tobias, president of the National Right to Life Committee. "From his first day in office, President Trump and his administration have been dedicated to advancing policies that protect the fundamental right to life for the unborn, the elderly, and the medically dependent and disabled."

NRLC said Trump has taken steps as president to ensure that Americans are not forced to fund abortions or the abortion industry. "One of the president's first acts in office was to restore the Mexico City Policy, which prevents tax funds from being given to organizations that perform abortions or lobby to change abortion laws of host countries. Later, the president expanded this policy to prevent \$9 billion in foreign aid from being used to fund the global abortion industry," the organziation said. "The Trump Administration also cut off funding to the United Nations Population Fund because of that agency's involvement with China's forced abortion program," NRLC added. President Trump pledged "to veto any legislation that weakens current pro-life federal policies and laws, or that encourages the destruction of innocent human life at any state."

His administration also intervened to stop the United Nations from supporting abortion in a resolution about sexual violence. In 2018, under his leadership, the State Department removed references to the so-called "right" to abort an unborn baby from a global human rights report as well. This spring, the administration also finalized a new Title X rule that requires health care entities to completely separate abortion from their taxpayer-funded services. Planned Parenthood, which already has said it will not comply, could lose about \$60 million annually through the policy change. However, the abortion group is suing to block the cuts.

Trump has appointed dozens of conservative judges to federal courts as well, including two to the U.S. Supreme Court.

# 75% of Americans Oppose Democrats' Agenda for Abortion Up to Birth at Taxpayer Expense

"The Democratic establishment would do well to listen to the American people – or even just their base – instead of caving in to the pressure of the abortion lobby," she said.

### Joe Biden's Demand for Taxpayer-Funded Abortions Turns off Voters, Poll Shows

Pormer vice president Joe Biden's newfound opposition to the Hyde amendment, which prohibits the direct federal funding of abortion, has brought the contentious issue of tax-payer-funded abortion into the spotlight again. The politics of covering abortion through Medicaid has received mainstream-media coverage during the last few months. In *Slate*, Will Saletan recently summarized public attitudes toward tax-payer funding of abortion. Public-opinion scholars know that polling on life issues tends to be sensitive to question wording, but, as Saletan astutely points out, most data show that regardless of wording, there is substantial public opposition to taxpayer-funded abortion.

Biden's reversal on Hyde — which he consistently supported during his decades as a U.S. senator from Delaware — has had an interesting effect on his public support. A Morning Consult poll suggested that his shift will benefit him in the primary, as 30 percent of likely Democratic-primary voters said they would be more likely to support him, while only 19 percent said they would be less likely to do so. But the same poll found that his opposition to Hyde could hurt him in the general election, finding that only 19 percent of general-election voters said they'd be more likely to vote for him, while 24 percent said they'd be less likely to do so.

His switch on the issue is evidence of the changing demographics within the Democratic party, as an older generation of voters is being replaced by a younger cohort that tends to be more liberal on social issues. Biden, along with his fellow primary contenders, clearly believes he must support taxpayer funding of abortion to be competitive on the left, despite the fact that polling data indicates this position is unpopular with the public. Republican politicians should aim to make their own opposition to publicly funded abortion a salient campaign issue during the 2020 election.

## Immigration: What's Legal and What's Not

## Raped at 18, This Brave Mother Kept Her Baby Instead of Having an Abortion Michael Miller Washington, DC

When even some pro-lifers are willing to grant abortion exceptions in cases of rape, Nicole\* and her daughter, Zoe, disagree. Nicole, now a member of Samaritan Ministries International, one of the country's leading healthcare sharing ministries, was raped by a high school acquaintance in 1998 in Florida. Nine months later, she gave birth to Zoe, who turned 20 this past winter.

"It wasn't her fault," Nicole says. "I think a lot of people think abortion is an easy out because it takes away the 'problem,' but the problem is not the child. The child didn't do anything.

The problem is you have to deal with the grief and the loss and the pain from what happened to you, and you deal with having to forgive somebody who has wronged you. But that person is not this innocent little baby." Zoe, now a wife and mom herself with a job in a church preschool teaching 2-year-olds, said she is thankful for her mother's brave decision. "I am really glad that she decided to keep me and really grateful for my grandparents being there and supporting her," Zoe says.

Nicole married when Zoe was about 4 years old, and she and her husband, who adopted Zoe, have had four additional children. With the help of such resources such as Bible studies, Nicole has been able to work through the pain of the rape. But it has taken years. Nicole's attack occurred when she and a boy went to his house to pick up a prop for a school play they both were performing in.

"He started coming on to me," Nicole says. "I (said) 'No, no, no. You have a girlfriend and I don't want to do that.' He kept persisting and becoming forceful and then he raped me. Then he acted like nothing happened ... I was just sitting there mortified. To him it was no big deal." But it was a big deal to Nicole, who wasn't able to tell anybody besides her parents what had happened until a couple years after Zoe had been born. After scaling back her college plans due to the baby, she moved back in with her parents.

"I was too ashamed to say anything for a long time," Nicole remembers. "That was also hard because you're carrying that secret with you because it's just embarrassing." Nicole even found herself wishing for a miscarriage, "because then I wouldn't have to deal with it." "I know that sounds terrible, but it was out of fear," Nicole says.

The thought of having an abortion was "a brief blip." "I was thinking, 'Oh, if I had an abortion, no one would know, everything would be fine," Nicole says. "I think it was really just Satan trying to put that thought into my head, because I'm not pro-abortion at all and wasn't back then. We had done foster care with my parents. I think it was just Satan trying to get me



while I was vulnerable. ... I don't think I could live with myself if I actually went through with (abortion)." Nicole says her parents, both devout Christians, were "very supportive" of her choice to raise the baby. Besides her parents, financial support came later from a job at a department store as well as a settlement from a car accident that happened when she was a girl.

"I think God worked this out," says Nicole, who also eventually earned an associate degree in criminal justice.

God wasn't nearly done working in her life, though. When Zoe was 3 and the mom and baby had found their own

apartment, Nicole met a Christian man who was very kind to Zoe. He and Nicole were married, and the family of three began to grow. Eventually, Zoe wanted to know more about her history.

"We never really kept it a secret," Nicole says. "I just said, 'Somebody did something bad to Mommy. But I've always loved you. I never regretted having you. You've always been a blessing to me."

Zoe made one unsuccessful attempt to contact her birth father in her teens but got no response.

"It was a huge hurt in my life for so long that I still haven't really gotten over it yet," she says. "Rape hurts the kid, too, and not just the woman. But it's still possible to overcome."

The rejection added to typical adolescent woes, but Zoe survived them. Helping was her adoptive father. Zoe says he has always treated her on equal footing with her siblings. "He has always treated me like his biological daughter," she says. "We went to daddy-daughter dances and Girl Scouts. He's never treated me differently. I really commend him for that." Zoe and her mother are both actively pro-life and encourage pregnant moms in difficult circumstances to persevere. "Having a baby alone is very scary, but it's such a short time in your life that it's not worth doing something that drastic, something that you have to live with forever," Nicole says. "You can't take back an abortion. Ever. It's so special that I have Zoe in my life, and she's such a blessing. I don't regret it. I've never regretted it for a day."

Zoe uses her situation to encourage women to keep their babies in all situations. "I can say I'm a product of (rape)," she says. "I'm not less of a person because my biological father did a horrible thing. That doesn't mean I should have to die for that. I don't think the baby should be killed just because the father was a horrible person." Abortion doesn't solve a woman's pregnancy predicament, the mother and daughter say, even in the case of rape. In fact, it makes it worse. "One wrong doesn't right the wrong that has been done to you," Nicole says. "Having an abortion doesn't fix the pain and humiliation you feel from the rape. It just magnifies it."

## **Teachers Have Alternatives to Pro-Abortion Unions**

The National Education Association (NEA) has come out of the closet, so to speak, and made official what we've suspected all along. After trying to hide it for over thirty years, the NEA is now officially on record supporting an extreme position of abortion on demand throughout pregnancy.

The good news is that tens of thousands of pro-life educators represented by NEA now have alternatives, and a recent US Supreme Court ruling backs them up. The NEA is the nation's largest teacher's union which boasts a membership of 3.2 million educators. At their annual business meeting in Houston, delegates passed New Business Item 56. In part it reads, "The NEA vigorously opposes all attacks on the right to choose and stands on the fundamental right to abortion under Roe v. Wade."

Abortion is the violent killing of unborn babies. It can inflict horrific physical damage on a woman's body and often burdens the mother and father with emotional grief and remorse. It's ironic that a teacher's union is advocating the deaths of millions of future students. Pupils that will help ensure their employment and profession. Not all educators share this prodeath agenda. There are scores of pro-life teachers who want to benefit from effective representation but wish to avoid supporting a pro-abortion advocate like the NEA.

Now they don't have to: Last year's Supreme Court decision, Janus v AFSCME, ruled against forced unionism, agency fees, and coerced dues for all public employees. This means prolife teachers have rights. With those rights come alternatives to the NEA. According to their website, members of Christian Educators Association International enjoy \$2 million professional liability coverage, representation by a local attorney, unlimited educational, and legal consultation and mentorship in how to walk out their faith legally in public schools. The Association of American Educators is a non-union professional educators organization that sees the need for a professional educators organization that focuses on student achievement without an emphasis on partisan politics. Pro-life educators can also benefit from Teachers Saving Children, individuals associated with the education profession whose primary purpose is advocacy for all innocent human life from conception to natural death.

#### Trump Admin Puts into Action New Rule Cutting \$60 million from Planned Parenthood



Editor's Note: This is an on again and off again battle as liberal judges rush to protect PP from losing millions of dollars in funding while the Trump administration is determined to cut their funding that is used to promote abortion. This is another indication that President Trump is keeping his word.

WASHINGTON, D.C., (LifeSiteNews, by Calvin Freiburger) – The Trump administration has announced the imminent enforcement of a rule that threatens to cut a tenth of Planned Parenthood's federal tax funding, after receiving the go-ahead from a federal appeals court.

In February, the administration finalized a rule that will require "clear financial and physical separation between Title X-funded projects and programs or facilities where abortion is a method of family planning," ban "referral for abortion as a method of family planning," eliminate a "requirement that Title X providers offer abortion counseling and referral," and require "more complete reporting by grantees about subrecipients and more clarity about informal partnerships with referral agencies."

The rule is projected to cut almost \$60 million from the \$563.8 million Planned Parenthood received during the most recent fiscal year, and redirect it to women's health providers that aren't involved in abortions. This has provoked intense anger among abortion supporters and lawsuits from 21 states and the District of Columbia, as well as Planned Parenthood and the American Medical Association (AMA).

In April, U.S. District Judge Stanley Bastian issued a nationwide injunction against the rule, claiming it lacked "proper consideration of sound medical opinions and the economic and non-economic consequences" and likely "creates unreasonable barriers for patients to obtain appropriate medical care." Last month a 9th Circuit panel reversed the injunction by a 7-4 vote, and last week the full court reaffirmed that decision, allowing the rule to take effect while the case on the merits is litigated. Following the ruling, the U.S. Department of Health & Human Services (HHS) informed the affected entities that the rule would take effect starting July 15, *The Hill* reports.

# Abortion Activists Vandalize Van Offering Free Ultrasounds to Pregnant Moms Micaiah Bilger

A pro-life organization offering free ultrasounds to pregnant mothers in need was vandalized Saturday, July 13, in Charlotte, North Carolina.

The mobile ultrasound unit, which is owned by Human Coalition, was parked near a huge, new Planned Parenthood abortion facility in the city, the *Catholic News Herald* reports. Trained medical workers use the vehicle to offer free pregnancy tests, ultrasounds and other information and support to pregnant moms.

During the night of July 11, the words "PRC LIES TO WOMEN" were painted in red across the side of the vehicle, according to the report. Local pro-life advocates informed the police, who are investigating.

Brian Fisher, president of Human Coalition, said they use the mobile ultrasound units to reach women in crisis.

"These mobile clinics are necessary because some women can't get to our brick-and-mortar clinics when they are in crisis. They may not have transportation or may live too far away. So our mobile clinics go to them," he explained in an email to supporters. "But not everyone appreciates the compassionate care we provide for women."

He said their pro-life organization regularly faces attacks from the pro-abortion movement. Fisher described how they have been censored on Twitter and the Apple App Store and volunteers and staff have been subjected to verbal abuse and threats – including one staff member who had a gun pulled on her.

"And the abortion movement has made it clear how they feel about us offering true hope and help to women in Charlotte," he noted, referring to the vandalism.

For decades, Planned Parenthood's Charlotte facility did not provide abortions; it only referred women to other facilities for them. However, that will change when it moves into its \$10 million new building.

The abortion chain wants to begin aborting unborn babies this summer in the city; however, the state Department of Health and Human Services had not approved its abortion clinic application as of July 10, according to the *News Herald*.
