Daviess County Right To Life would like to Remember Robert “Bob” Wichman for his many years of Service to the Right To Life Paper Drives.

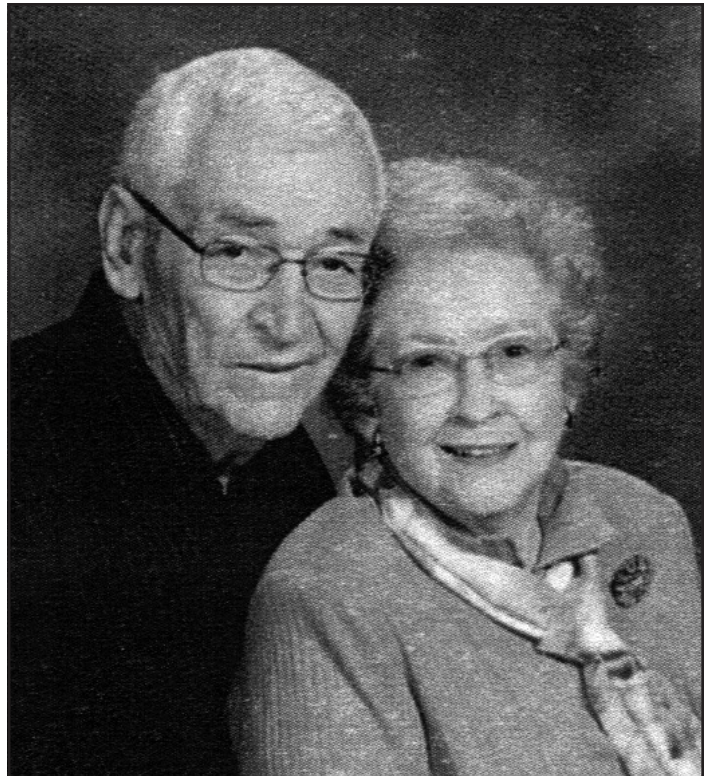
Shown in this picture is Bob along with his wife Rosemary. Bob is the last of his Family who all worked or helped the Right To Life in various ways.

“What Is Happening to America Because of Abortion”

Cecile Richards Defends Planned Parenthood Selling Aborted Baby Body Parts, Calls Pro-Lifers Killers —By Steven Ertelt

In her first public interview since two top Planned Parenthood doctors were caught arranging for the sale of body parts of aborted babies, Planned Parenthood CEO defended selling aborted babies and attacked pro-lifers.

In the wake of the two shocking videos showing top Planned Parenthood doctors arranging the sale of body parts from aborted babies, the Senate will vote soon on legislation that would de-fund the Planned Parenthood abortion business. A total of nine states have already launched an investigation including Massachusetts, Kansas, Missouri, Arizona, Indiana, Ohio, Georgia, Texas and Louisiana and members of Congress have launched an investigation as well.

In an interview with ABC News, Richards slammed what she called “highly-edited videos” released by “militant pro-life activists,” who she said were killers because they supposedly bomb abortion clinics.

Never mind that the full, unedited videos have been released, and the pro-life advocates involved in the undercover work to expose Planned Parenthood have never engaged in violent or illegal activities.

United Way Defends Funding Planned Parenthood Abortion Biz: It’s Just a Small Amount —By Steven Ertelt

Officials with United Way are defending the nonprofit agencies funding of the Planned Parenthood abortion business in the wake of a scandal involving the abortion giant selling the body parts of aborted babies. A United Way spokesman says the funding really isn’t a big deal because such a small percentage of United Way affiliates send money to Planned Parenthood.

On the heels of a shocking video showing the Planned Parenthood abortion business selling the body parts of aborted babies, a new expose’ from a group that monitors corporations that finance the abortion giant reveals the United Way is a major donor.

The consumer advocacy organization 2nd Vote has informed LifeNews.com of the release of the Pro-Life Guide to United Way, a new guide that lists the over 1,200 United Way affiliates across the United States and specifies the organizations that contribute to the world’s largest abortion company.

“United Way has done many good things through fundraising efforts and partnerships that help communities across the country,” said 2nd Vote spokesman Robert Kuykendall. “However, the fact that United Way affiliates give almost \$2 million annually to Planned Parenthood is concerning for Pro-Lifers that would want to support these good causes but

In the interview, Richards says she’s not worried about the dozen videos the pro-life muckraker behind the undercover investigations says are still to come because this is a “three-year, well-funded effort by the most militant wing of the anti-abortion movement in this country to try to entrap doctors, and of course, highly-doctored videos.” Richards claims David Daleiden of the Center for Medical Progress and the people behind the videos are “part of the most militant anti-abortion movement that has been behind the bombing of clinics, the murder of doctors in their homes and in their churches, and that’s what actually needs to be looked at.”

“These activists don’t care about women’s health care,” she says – claiming that all pro-life people care about is trying to “entrap doctors.” The most damaging aspect of the interview is perhaps the section during which Richards tells the host that Planned Parenthood is not making a profit over the sale of the aborted baby body parts. When the host shows her part of the video where Planned Parenthood’s doctor is haggling about the sales prices of aborted baby body parts, Richards lies and says it’s the buyer doing the negotiating.

also want to make sure that their dollars do not help fund abortion services.”

As a news report indicates, local United Way agencies are fielding calls from concerned supporters who don’t want their donations to United Way going to the abortion company following a LifeNews report exposing how affiliates of the non-profit support Planned Parenthood.

“I want our local communities (in Rogers and Mayes counties) to know that we most definitely do not fund Planned Parenthood,” said Catherine Woldridge, executive director, United Way of Rogers and Mayes Counties. “We have already had several calls asking us about this, but we do not support Planned Parenthood.” While not all United Way affiliates support Planned Parenthood, a national spokesman defended those that do.

“United Way Worldwide, the leadership and support organization for the network of local United Ways, does not provide financial support to Planned Parenthood,” said Neil Parekh, United Way Worldwide director of network communications.

“All funding decisions by local United Ways are made by individual United Ways based on an assessment of local needs,” he said. “United Way Worldwide does not dictate

funding decisions to local United Ways. Out of nearly 1,200 local United Ways in the United States, only a small number – less than 6 percent – provide support to Planned Parenthood.

“The amount of financial support represents less than one tenth of one percent of total United Way revenue,” he said. “In many of these instances, funding for Planned Parenthood is the result of specific requests from individual donors.

Although the United Way’s website contains language claiming a neutral stance by the organization on the abortion issue, Kuykendall tells LifeNews that some United Way affiliates donate to the Planned Parenthood abortion corporation anyway. “According to United Way, only 5% of its affiliates

contribute in any way to Planned Parenthood,” Kuykendall said.

How can pro-life advocates find out if their local United Way agency donates to the abortion giant? The group tells LifeNews that its handy guide makes it easy to figure out which ones partner with Planned Parenthood. The “Pro-Life Guide to United Way” was released on 2nd Vote’s website and contains a state-by-state list of every United Way in the United States. Each entry shows the amount of money donated to Planned Parenthood by that affiliate with a link to tax forms documenting the expenditure.

Democrats and Late Term Abortions

By now almost everybody has heard about the video sting of Planned Parenthood bigwigs discussing prices and harvesting techniques of fetal organs. In his WSJ column on the topic, The Political “Science” of Planned Parenthood, William McGurn put his finger on the “science” driving the abortion controversy.

Finally, there is the president’s apparent willingness to put Planned Parenthood’s funding – slightly less than half of its \$1.3 billion in annual revenue comes from taxpayers – above all else. Back in 2011, President Obama informed Republicans he would rather see the entire federal government shut down than cut a nickel from Planned Parenthood.

To Obama it’s money well spent. According to OpenSecrets.org, in the 2014 elections cycle Planned Parenthood contributed nearly \$1.6 million in hard money to candidates, parties, and other political organizations. **All of it for Democrats.** It spent about \$6 million in soft money, \$2.6 million for Democrats and \$3.4 million *against* Republicans. It’s become pretty clear why Planned Parenthood and their Democrat allies oppose any restrictions on late term abortions. Fetal organs need time to develop if they’re ever going to be worth anything. You might say that Planned Parenthood and the Democrats are winning hearts and livers of potential future voters, and doing it on the taxpayers’ dime.

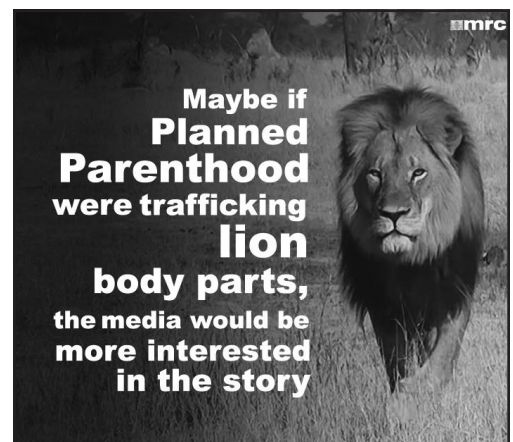

“There are no words,” Spencer added at the end of the segment. Again, we’re talking about a lion. For CBS’ This Morning, co-anchor Gayle King commented, “The more you hear about it, the more upsetting it is.” For the shooting of a lion, yes. For the weekly videos exposing the trafficking of baby parts, no. (According to the media, that is.)

In summation, in two weeks the networks have given the Planned Parenthood atrocity 11 minutes of coverage. In a single day, the death of an animal has earned 14 minutes of coverage. Our media is useless, corrupt, and evil.



Justifying “some of the practices of Planned Parenthood” are a “tricky issue for the left”

The reliably pro-abortion National Public Radio ran a piece today under the headline “Planned Parenthood Controversy Proves Complicated For Democrats.” It’s actually fairly balanced – at least for NPR – and includes this curious concession near the end:

It’s a tricky issue for the left, says political scientist Rachel Caufield of Drake University in Des Moines.

“It creates an environment where the pro-choice supporters have to be in a position to justify some of the practices of Planned Parenthood,” she said.

Hold the presses! “Justify”? Democrats don’t “justify” anything PPFA does. Theirs is a symbiotic relationship.

Put another way, they are joined at the hip, and ordinarily, not only is criticism of one treated as criticism of the other, but

they compete for who best can lecture the public how wonderful they both are.

But, that aside, what might, just might, have to be justified? Let me count just some of the ways.

1. Treating the dissection of aborted babies as a joke, something to smirk about between bites of salad and sips of red wine.

2. Quibble/haggle/barter/wrangle/dicker – take your pick of descriptor – over the price of intact lungs and livers and hearts and brains. Whichever you choose, it places PPFA’s image as a disinterested “non-profit” provider of “women’s health” in an entirely different light.

3. Possible changes in how the abortion is done in order to extract intact fetal organs. There are a lot of suggestions that changes are made. The most well-known is using “less crunchy [abortion] techniques.” But there are others.

For example, the same Dr. Mary Gatter also had this exchange with the uncover investigators:

Gatter: Let me explain to you a little bit of a problem, which may not be a big problem, if our usual technique is suction, at 10 to 12 weeks, and we switch to using an IPAS or something with less suction, and increase the odds that it will come out as an intact specimen, then we’re kind of violating the protocol that says to the patient, “We’re not doing anything different in our care of you.” Now to me, that’s kind of a specious little argument and I wouldn’t object to asking Ian, who’s our surgeon [abortionist] who does the cases, to use an IPAS at that gestational age in order to increase the odds that he’s going to get an intact specimen, but I do need to throw it out there as a concern. Because the patient is signing something and we’re signing something saying that we’re not changing anything with the way we’re managing you, just because we agree to give tissue. You’ve heard that before.

Buyer: Yes. It’s touchy. How do you feel about that?

Gatter: I think they’re both totally appropriate techniques, there’s no difference in pain involved, I don’t think the patients would care one iota. So yeah, I’m not making a fuss about that.

And then there is this, from Dr. Deborah Nucatola:

After nonchalantly extolling PPFA for its adeptness at “crushing” – “you try to intentionally go above and below the thorax, so that, you know, we’ve been very good at get-

ting heart, lung, liver, because we know that, so I’m not gonna crush that part, I’m gonna basically crush below, I’m gonna crush above, and I’m gonna see if I can get it all intact.” Dr. Nucatola is shown on the hidden camera video saying, “And with the calvarium [the skull], in general, some people will actually try to change the presentation so that it’s not vertex [head first], because when it’s vertex presentation you never have enough dilation at the beginning of the case, unless you have real, huge amounts of dilation to deliver an intact calvarium.”

What is their defense? PPFA President Cecile Richards, appearing on “This Week with George Stephanopoulos” over the weekend, talked about how women in a few cases made such “donations.”

And “that women and their families choose to make fetal tissue donations in order to potentially save lives of other folks” is “laudable.”

To which Stephanopoulos adds, “As long as the procedure is never altered and you’re stating that unequivocally.”

“That’s right,” Richards responds.

Other defenses are far more nuanced. The quote above – about “crushing” and delivering the baby head first – would be seen by almost any neutral party as altering the method of delivery.

Dr. Nucatola immediately adds, “So the preparation would be exactly the same, it’s just the **order** of the removal of the products is different.” [My emphasis.]

No change in delivery, just in the “order” of how the baby’s body is removed. If you believe that ...

There is another other way of finessing what they do. The PPFA affiliate in Mar Monte, California, has a “client information for informed consent” form. The very, very last item on a separate

form the abortionist signs reads

No substantive alteration in the timing of terminating the pregnancy or of the method used was made for the purpose of obtaining the tissue. [My emphasis].

There are loopholes here big enough to run a truck through.

And, by the way, in response to a question about possible benefits to PPFA clinics from this grisly trade, Richards says unequivocally, “There are no financial benefits to the clinics.”

“Absolutely?” Stephanopoulos asks.

“Absolutely.”

We’ll see how that blanket denial holds up.



Democrats Defend Planned Parenthood Selling Body Parts of Aborted Babies

Planned Parenthood’s best friends in Congress are rushing to the defense of the abortion business today after a shocking expose’ video caught its top doctor discussing how the abortion company is involved in the sale of body parts from babies victimized by abortions.

New undercover footage shows Planned Parenthood Federation of America’s Senior Director of Medical Services, Dr.

Deborah Nucatola, describing how Planned Parenthood sells the body parts of aborted unborn children and admitting she uses partial-birth abortions to supply intact body parts.

In the video, Nucatola is at a business lunch with actors posing as buyers from a human biologics company. As head of PPFA’s Medical Services department, Nucatola has overseen medical practice at all Planned Parenthood locations since

2009. She also trains new Planned Parenthood abortion doctors and performs abortions herself at Planned Parenthood Los Angeles up to 24 weeks.

The abortion giant released a statement from a top official defending Nucatola and its practice of selling body parts of aborted babies, which it calls “tissue.” Here is the Planned Parenthood press release.

Now, top Democrats in Congress are defending Planned Parenthood. Interestingly, none of the top pro-abortion members of Congress have watched the video showing the leading Planned Parenthood medical official discussing how it sells aborted baby body parts.

As The Hill reports, here’s what they have to say: “Planned Parenthood is actually allowed, is my understanding, for scientific research, to use fetal tissue and that is not illegal,” said Rep. Jan Schakowsky (D-Ill.), a member of the Congressional Pro-Choice Caucus and sponsor of numerous abortion-rights bills.

“Having talked to the leadership at Planned Parenthood, this was a sting operation,” she added. She said she had not watched the nearly nine-minute video. ... When asked about Republicans’ planned investigations into Planned Parenthood, Schakowsky said she wanted an investigation, instead, into the Center for Medical Progress, which she called “a phony company.”

Rep. Barbara Lee (D-Calif.), another prominent supporter of abortion rights, also dismissed the latest attacks against Planned Parenthood. “They’ve been attacking Planned Parenthood for years,” she said. “They’ve been calling for investigations for years, and they surface videos and they come on the attack ... and I think it’s outrageous.” Lee also said she has not seen the video. Rep. Rosa DeLauro (D-Conn.), who is also a member of the Congressional Pro-Choice Caucus, said she had not heard of the video and could not comment. “I’ll take a look at it, but I did not see it so I have no idea what’s in it,” she said.

Carol Tobias of the National Right to Life Committee says her group is shocked that anyone could defend what Planned Parenthood is doing. “It is stomach-churning to hear a top doctor for the national Planned Parenthood organization admit, on videotape, that Planned Parenthood abortionists can and will alter late abortion procedures to facilitate the harvesting of intact baby body parts – she specifically mentioned hearts, lungs, livers, even intact heads – in order to fill specific



pre-orders. Numerous statements by Dr. Nucatola cry out for probes by Congress and other investigatory agencies – and quickly,” she said.

Tobias added: “For example, Dr. Nucatola specifically describes abortionists manipulating unborn children in order to remove them feet first, to facilitate obtaining an intact head, apparently to preserve an intact brain. This statement and others raise a host of ethical questions, including whether pregnant women are being given detailed information in advance about exactly what is going to be done to them and their babies.”

“Planned Parenthood’s political arm is a major backer of many Democratic members of Congress. Lawmakers who have enjoyed Planned Parenthood’s backing should now be asked whether they will continue to oppose pending legislation to restrict the abortion of pain-capable unborn children after 20 weeks fetal age, as Planned Parenthood insists – and if so, whether they are motivated in any degree by a desire to preserve Planned Parenthood’s ability to deliver intact, well-developed baby body parts to order,” she concluded.

Labor Unions Defend Planned Parenthood

Two of the country’s biggest and most powerful labor unions have come to the defense of Planned Parenthood, amid a series of recently released videos in which leaders of the group are seen bargaining for the sale price of fetal tissues and organs, according to Watchdog.org.

“We stand united with our allies at Planned Parenthood, champions of quality healthcare and a cornerstone of vital services to millions of Americans for decades,” Mary Kay Henry, Service Employees International Union president, said in a statement this week.

Henry made the statement after the release of at least two videos and after the Republican-controlled Congress began to take action to stop federal funding for the group, which provides abortions and other women’s medical services.

The for-profit sale of aborted body parts by Planned Parenthood for research is illegal. The group has apologies for the statements made in the videos but says the discussions were about the cost of covering expenses and that there has been no wrongdoing. “Efforts in Congress to de-fund Planned Parenthood by anti-women, anti-choice extremists must be stopped,” Henry also said in the statement. The union coalition AFL-CIO is also backing Planned Parenthood, which receives about \$500,000 annually from the federal government.

Union President Richard Trumka called the stealthy recorded videos “doctored” and said efforts to defund Planned Parenthood are “politically motivated and wrong.” The membership ranks of the AFL-CIO’s two largest affiliates – American Federation of Teachers and American Federation of State,

County and Municipal Employees – include government workers. And many of AFT’s members are nurses.

None of the union groups contacted by Watchdog.org responded to a request to comment.

AFL-CIO, AFSCME and SEIU helped pass ObamaCare through Congress early in President Obama’s first term and

continue to work together. AFSCME, for example, paid Planned Parenthood’s political action wing \$400,000 in 2014, \$20,000 in 2013 and \$20,000 in 2011. And the payments were reported to the Labor Department as a “political program support” expenses, according to Watchdog.org.
