An Unborn Baby Is a Human Being With a Heartbeat at 24 Days and Brain Waves at 43 Days *by Maria Gallagher*

The reality of the hidden life of the unborn child can pop up in the least likely of places. I happened to be watching a “reality show” known for its contentious female friendships when I was surprised to see one of the leading ladies show up at an obstetrician’s office.

They suspected she was pregnant after having suffered the devastation of a miscarriage. She very much wanted a “rainbow baby” to bring hope and healing into her life. Sure enough, the ob/gyn office confirmed the pregnancy, in all its glory, in the ultrasound image that appeared on the screen. The mother was overcome by emotion at the portrait of personhood before her, very early in the first trimester of pregnancy.

Supreme Court Will Fast Track Decision on Texas Abortion Ban, Pro-Life Groups Expect Another Victory *by Steven Ertelt*

The Supreme Court has agreed to fast-track a decision on whether to block the Texas abortion ban while lawsuits from Joe Biden and abortion companies continue in lower courts.

Recently Joe Biden’s administration officially asked the Supreme Court to block the Texas abortion ban, which has saved thousands of babies from abortions. Texas has until noon Thursday to file its legal papers explaining why the Supreme Court should keep the abortion ban in place while the legal challenge proceeds and pro-life groups expect the nation’s highest court to not block the ban for a second time.

Texas Right to Life Director of Media and Communication Kimberlyn Schwartz told LifeNews she expects Biden to lose his request to block the ban: “We are excited to continue saving hundreds of lives through the Texas Heartbeat Act. However, the battle is not finished. We are confident Texas will ultimately defeat these attacks on our life-saving efforts.”

As LifeNews.com reported late last week, the 5th Circuit Court of Appeals rejected Biden’s demand to block the ban. Previously, U.S. District Judge Robert Pitman, who was appointed by Barack Obama, sided with the Biden administration’s Justice Department, which sued the state, arguing Texas’ law was unconstitutional because it went against *Roe v. Wade*.

Disappointed Pope Met with Pelosi and Biden *by Louis Kavanaugh Jr.*

The pro-life movement is very disappointed that Pope Francis met with Speaker Pelosi and President Biden. The pope did not have to meet with these two very pro-abortion politicians, and by doing so he is giving his stamp of approval to what they stand for and what are saying when it comes to abortion. He could have met with them but pleaded with them to change their stand on abortion. We need our clergy to be strong in support of the life issues, but this it is not happening. Let us continue to pray for guidance for them.

These People Were Pro-“Choice” Until They Watched This Video of an Actual Abortion *(LifeSiteNews)*

A powerful video showing how second trimester abortions are performed has been used by pro-life organization Live Action to show pro-choice Americans what abortion really is — and the video changed their minds.

The video is part of Live Action’s new 2,363 campaign launched recently. It features Dr. Anthony Levatino, a former abortion physician, as he describes an animated re-creation of a second-trimester abortion that was shown to anonymous pro-choice Americans on the street after a Live Action reporter interviewed people in various cities and asked them about their views on abortion.

At the beginning of the survey, all of the people featured considered abortion to be a “woman’s right to choose.” But after being shown the four-minute video that illustrates the procedure, every single one of them said they changed their mind.

The new Live Action campaign is called 2,363 in reference to the number of abortions that take place in the United States on a daily basis. As explained on Live Action’s website, the aim

of the campaign is to “to educate the nation on the humanity of preborn children while emphasizing the imperative to protect these children in the womb.”

The video was created in 2016 with the help of Dr. Levatino as part of the launch of a new website called AbortionProcedures.com. Levatino performed more than 1,200 abortions before a life-changing experience led him to join the pro-life movement. He has spoken many times about the different types of abortion procedures, including at least one occasion before a house judiciary committee.

The procedure showed in the animation involves the dismembering of a living fetus in the mother’s womb with a surgical tool called a sopher clamp, “a grasping instrument,” that “when it gets a hold of something does not let go,” as Levatino explains in the video. “I don’t think any kid, any baby or any fetus should go through that,” the woman in New York said. All appeared to have changed their mind on abortion after seeing the video, as the woman in Seattle said.

“The video that you guys showed me has changed my mind.”

12 States Sue Joe Biden for Forcing Americans to Fund Planned Parenthood *by Micaiah Bilger*

State leaders are fighting back against President Joe Biden’s new rule forcing taxpayers to fund the billion-dollar abortion chain Planned Parenthood. On Monday Oct. 25, 12 state attorneys general filed a lawsuit challenging Biden’s rule for the Title X family planning program, saying taxpayer-funded family planning clinics should be physically and financially independent of abortion facilities, the Washington Times reports.

Ohio Attorney General Dave Yost, who led the lawsuit, said they want to restore the 2019 rules President Donald Trump’s administration put in place to ensure that tax dollars are not being used to support abortions. Prior to 2019, however, Planned Parenthood was one of the largest recipients of Title X funding, receiving about \$60 million a year. Under the Trump administration, the abortion chain chose to leave the program rather than comply with the rules. Those rules required Title X recipi-

ents to make their abortion businesses physically and financially separate from the program and to stop referring women for abortions.

However, the Biden administration quickly reversed the rules in October, so that abortion facilities no longer have to separate their family planning services from their abortion businesses. Joining Ohio in the lawsuit are Alabama, Arizona, Arkansas, Florida, Kansas, Kentucky, Missouri, Nebraska, Oklahoma, South Carolina and West Virginia. Some states do not participate in the Title X program. A recent Marist poll found that, by a double-digit margin, a majority of Americans oppose taxpayer funding of abortion (54 percent to 39 percent).

Kamala Harris Colluded With Planned Parenthood to Put Pro-Lifers in Jail Who Exposed Baby Part Sales *by Micaiah Bilger*

An attorney for pro-life journalist David Daleiden slammed Vice President Kamala Harris for “egregious abuse” of her power when she colluded with pro-abortion groups to punish Daleiden for exposing Planned Parenthood’s aborted baby body parts trade.

Harris, as attorney general of California, raided Daleiden’s home after the Center for Medical Progress released videos showing Planned Parenthood allegedly selling aborted baby body parts. Her raid resulted in criminal charges against Daleiden that could send him to jail.

Now, Fox News reports new evidence suggests Harris and the California Attorney General’s Office worked together with Planned Parenthood and the National Abortion Federation to punish Daleiden for his groundbreaking exposé. “This case is the most egregious abuse of prosecutorial power that I have ever seen and I was a trial and appellate lawyer in the Los Angeles County District Attorney’s Office for [30] years,” attorney Brent Ferreira told Fox News.

Daleiden’s attorneys pointed to recent statements and court documents in multiple cases against Daleiden that suggest Harris and the AG’s Office abused their power as a political favor to their allies. Here’s more from the report: Daleiden’s attorneys argue that one of Harris’ appointees, Deputy Attorney General Johnette Jauron, effectively admitted in May 2021 that she abused the powers of her office by giving the National Abortion Federation (NAF) that footage and other materials seized during a raid in 2016 from Daleiden’s apartment as part of Harris’ criminal investigation. By that time, NAF was embroiled in a civil suit against Daleiden. ...

In August, Daleiden followed by asking San Francisco’s superior court to compel the AG’s office to provide correspondence with NAF, Planned Parenthood and others. The AG’s office replied by accusing Daleiden of taking Jauron’s words out of context. However, Daleiden’s attorneys said there is more evidence to support their collusion claims, including billing records from the National Abortion Federation.

According to the report, one record shows an attorney’s bill of \$262.50 for “coordinate review of new videos” on April 6, 2016 – the day after Harris’s office ordered a raid on Daleiden’s home and took his video footage.

Other documents show that Harris had Daleiden’s home raided just a few weeks after holding a meeting with Planned Parenthood executives. Fox News reported more: “Billing records show that on the day of that meeting, NAF attorney Derek Foran and the AG’s office had a conference call in which they discussed ‘legal research regarding’ a redacted subject.”

Planned Parenthood also donated money to Harris’s U.S. Senate campaign at the time and previously had donated to her campaign for attorney general. Last year, Daleiden filed a lawsuit against Harris, HHS Secretary Xavier Becerra, the California Attorney General’s Office, Planned Parenthood and others for allegedly violating his First Amendment rights. “Planned

Parenthood, NAF, and the California Attorney General beginning with Kamala Harris colluded to silence my reporting on illegal fetus trafficking and to obstruct justice in ongoing investigations of their practices,” Daleiden told Fox News.

He said a California Superior Court recently ordered the AG’s office to produce more testimony in response to the collusion allegations. “No matter how hard Planned Parenthood, Kamala Harris, and their associates have tried, the truth can no longer be buried,” he said. Daleiden still is facing criminal charges for his undercover investigation of Planned Parenthood. He is accused of breaking a state video recording law, which his attorneys said has never been used to prosecute any other undercover journalist in the state.

The Center for Medical Progress investigation did a lot of damage to the abortion industry when it revealed Planned Parenthood’s baby body parts operation. Not only did the undercover investigation raise concerns about potentially illegal sales of human body parts, but it also uncovered evidence of abortionists allegedly putting women’s lives at risk by altering abortion procedures to better harvest aborted baby parts. The investigators also found evidence of possible patient privacy violations.

These findings prompted investigations by the U.S. House and Senate, as well as a number of states. The House and Senate investigations both recommended that the Department of Justice investigate Planned Parenthood after finding strong evidence that the abortion chain broke the law. The Department of Justice began investigating under President Donald Trump. Two of Planned Parenthood’s business partners in Orange County, California also admitted to selling aborted baby body parts in a \$7.8 million settlement with the county district attorney’s office.

However, Planned Parenthood and NAF repeatedly have denied all allegations of wrong-doing, and many news outlets now parrot their claim that the undercover videos were deceptively edited. An independent forensics investigation verified that the videos were authentic. Some undercover videos show how Planned Parenthood employees callously and flippantly negotiated the price of tiny baby hearts, lungs, livers and brains. Other evidence indicates the abortion giant may have broken HIPAA patient privacy laws.

Violence is Increasing Against Pro-Life Leaders While Awaiting Supreme Court Ruling

As the potential for reversing *Roe v Wade* gets enticingly closer, frustration on the part of pro-abortion activists is more evident. Each passing day adds to a dramatic increase in the incidents of unhinged violence or threats of violence toward pro-lifers. These events have taken a serious uptick since the US Supreme Court allowed the Texas Heartbeat Act to take effect. That and the Mississippi Dobbs late-term abortion case are bringing more people to the reality that *Roe* is living on borrowed time. And the evidence shows that pro-life leaders and grassroots advocates are increasingly caught in the crossfire.

These days Texas appears to be ground zero for disturbing behavior from abortion proponents who realize the pro-life movement is at the threshold of a major breakthrough.

Police have arrested 20-year-old Austin Wendell Lund. He is charged with making threats on members of the Texas State Legislature who voted for the Heartbeat Act. Lund posted a disconcerting threat on Reddit that threatened to “end each one of you.” The FBI had previously alerted pro-life legislators of a credible danger to their safety. Texas Right to Life has been overwhelmed with vicious hate mail including threats of death and gang rape, profanities, nude photos, and a variety of other unsettling provocation. A bomb threat required the evacuation of their office. The situation worsened when Planned Parenthood doxed a staff member, making personal information, including a private address, public online.

Violence against opponents of abortion is not new and reaches across the nation. Antagonists have been arrested for terrorizing pro-lifers with guns in Dover, Delaware; Detroit; Phoenix; Aurora, Illinois; Bristol, Tennessee; and Charleston, South Carolina. In two of these instances the aggressors were

practicing abortionists. Although the lists of documented attacks against people in the pro-life movement are long and many, those supporting abortion deny their existence and the media is all but ignoring the worsening situation.

I believe there is another reason for the increased violence. Aggression on the part of pro-abortion activists is understandable. Their grip on the status quo of unrestricted abortion until birth is slipping and it's justifiably unnerving them. God willing, there is now a real possibility that *Roe v Wade* will be reversed when the Supreme Court rules on these two cases. But for countless other Americans it may be that the increased attention on the abortion issue reminds them of a past experience they want desperately to forget. They have compartmentalized their abortion(s) and shoved it down deep into their subconscious minds, intended never to be heard from again. Yet the national debate continues to prick their consciences.

A video compiled by Created Equal demonstrates intense anger from those who support abortion. I want to caution you that the aggressors use strong, profane language. After watching it, I wondered how many of these individuals have abortion in their past and are lashing out against those who remind them of what they know in their heart of hearts was wrong. Millions of these people just want the abortion issue to go away, yet it increasingly invades their psyches as the national debate shows no sign of abating. That's why our efforts to reach out to hurting mothers and fathers is so important.

In spite of personal risk, America's pro-lifers are boldly working to end this modern-day holocaust of abortion. When you send your financial contribution, consider including a brief note of encouragement. It would mean more than words can say.

Devastating Poll Numbers Confirm Americans Have Had Enough of Joe Biden

The Joe Biden presidency is collapsing and the networks don't want you to know about it. Two just-released polls have found the Democrat at record lows. But between the evening newscasts on Tuesday and the morning shows on Wednesday, offered zero coverage of the very bad news for Biden.

According to Quinnipiac, the President sits at 40 percent approval. It's even worse for the Grinnell College poll, showing Biden at just 37 percent approval and 50 percent disapproval. Both are respected polling companies and included in the Real Clear Politics Average of polls.

Again, you wouldn't know that if you watched ABC, CBS or NBC. It's not as though *Good Morning America's* Jon Karl wasn't aware of at least one of the polls. He cited Quinnipiac, but only the outfit's numbers on Donald Trump: “A new poll from Quinnipiac found that 78 percent of Republicans want Donald Trump to be president again in 2024.” That amounted to just 8 seconds on the network.

In contrast, Fox Business's Maria Bartiromo highlighted the bad news on Wednesday, noting, “When asked about the most urgent issues facing America, the top answers were the economy, Covid-19, immigration and health care.” Those are subjects that mostly look bad for Biden. In case you need a stark reminder of what the networks are ignoring, the disapproval for Joe Biden has shot up from 36 in January to 51 percent. Instead of polling, *CBS Mornings* devoted five minutes and 11 seconds to breeding cows that burp less and create less methane gas. ABC's *GMA* promoted Amazon products for three minutes and 11 seconds and NBC's *Today* offered six minutes and five seconds on a cute dog that went viral on the internet.

President Trump Announces New Social Media Platform “Truth Social” That’s Free From Censorship *by Ailan Evans*

Former President Donald Trump announced he is launching a new social media platform designed to compete with Big Tech. Trump Media and Technology Group (TMTG) announced Wednesday it was creating a new social media platform called TRUTH Social designed to “fight back against the ‘Big Tech’ companies of Silicon Valley.”

Trump is currently banned from most major social media platforms, including Facebook and Twitter, following the Jan. 6 riots. “I created TRUTH Social and TMTG to stand up to the tyranny of Big Tech. We live in a world where the Taliban has a huge presence on Twitter, yet your favorite American President has been silenced,” Trump said in a press release. “This is unacceptable.”

A beta version of the platform will be available to invited guests this November, according to the press release, and is currently available for pre-order in the Apple App Store. The full version of the platform is expected to be out in the first quarter of 2022. “TMTG was founded with a mission to give a voice to all,” Trump said. “I’m excited to soon begin sharing my thoughts on TRUTH Social and to fight back against Big Tech.”

The new venture was created through a TMTG merger with Digital World Acquisition Corp. Trump said he plans on offering a video-on-demand service with entertainment and news programming to be a “rival to the liberal news consortium.” “Everyone asks me why doesn’t someone stand up to Big Tech?” Trump said. “Well, we will be soon!”
