Major Supreme Court Victory by Katie Franklin

In a 5-4 win, the Supreme Court of the United States issued its decision in *NIFLA v. Becerra*, striking down a 2015 California state law that forced pro-life medical clinics to promote abortion by posting abortion advertisements on their websites and waiting room walls.

The decision marks a resounding victory for pregnancy help centers across the nation, who can now speak their message of hope without government interference. It also marks the end of a three-year legal battle fought by the National Institute of Family and Life Advocates (NIFLA)—the named plaintiff in the case which represents a network of 1,400 pro-life pregnancy centers and ultrasound equipped medical clinics—and for Alliance Defending Freedom, which represented NIFLA throughout the litigation.

Jor-El Godsey, president of Heartbeat International, a fellow pregnancy help network of over 2,500 affiliates, cheered the decision as a victory for pregnancy centers nationwide. "Today's decision is a tremendous win not only for free speech but for human life," said Godsey. "Thanks to today's ruling, California's 200-plus pregnancy centers can continue to serve women and children, unburdened by the unconscionable demands of the abortion lobby. This is an unquestionably major triumph for U.S. pregnancy centers working to save families from the sting of abortion."

The California law, known among abortion advocates as the "Reproductive FACT Act," required pregnancy centers to tell their clients that "California has public programs that provide immediate or low-cost access to...abortion"; and to instruct their clients to "contact the county social services office" at a particular telephone number "to determine whether you qualify."

"No one should be forced to speak a message with which they fundamentally disagree. The obvious intent of this unconstitutional law was to drown out pro-life voices by forcing pregnancy centers to promote abortion," said Danielle White, legal counsel for Heartbeat International. "This is a message that contradicts their very reason for existence, not to mention their deeply-held beliefs about the sanctity of human life."

The law also requires unlicensed centers to post signage saying that the center is not licensed as a medical facility and does not have a licensed medical provider. It also mandates the disclosure to be translated into 13 different languages.

Finally, the statute even requires the disclosure to appear in any advertisement for a given center, with the disclosure's text size even larger than the text of the advertisement itself.

During oral argument, Justice Neil Gorsuch referenced this image, including Heartbeat's contention that if pregnancy help centers decided to run this advertisement against themselves, it would cost them roughly \$9,000 per month. This ruling is the latest—and most significant—court victory for pro-life pregnancy centers which have been the target of similarly onerous

free speech restrictions in New York, Connecticut, Maryland, Texas, Hawaii, and Illinois.

Previously, in 2014, the Second Circuit Court of Appeals struck down a similar New York City ordinance, calling the measure "a bureaucrat's dream" with "a deliberately ambiguous set of standards guiding its application."

Then, in December 2017, the Fourth Circuit Court of Appeals struck down the City of Baltimore's law, capping off a seven-year legal fight with a pro-life win. Giving lie to the same accusations that undergird the California law, namely that pregnancy centers deceive women, the opinion noted that "after seven years of litigation and a 1,295-page record before us, the City does not identify a single example of a woman who entered the Greater Baltimore Center's waiting room under the misimpression that she could obtain an abortion there."

"The Court's message today to the abortion lobby is loud and clear: These bully bills do not belong on our books," said Godsey. "If abortion advocates and pro-choice politicians want to continue their attack on life-affirming pregnancy centers, they will only be met with more definitive court losses and mounting legal fees. The irony is that all of that time and money could have been spent on the very women they claim to help. We applaud the Court for preserving the right of pregnancy centers to speak their message of hope and love to every woman experiencing an unexpected pregnancy."

U.S. Senator Joe Donnelly Votes to Continue Funding of Planned

Parenthood by Louis Kavanaugh Jr.

Tn a recorded vote in August Indiana Senator Joe Donnelly, **▲** who is in a tough re-election battle with former State Representative Mike Braun, voted to continued funding Planned Parenthood. It has been pointed out to him that Planned Parenthood is the leading abortion provider in the country and they spend millions of dollars in each election year supporting candidates who support abortion. Just maybe now they will contribute to Donnelly's re-election campaign. Donnelly is in a close election with pro-life Mike Braun, who had a 100% pro-life voting record while serving in the Indiana House. JUDGE BRETT KAVANAUGH, SUPREME COURT NOMINEE WHO SAYS GOVERNMENT CAN PROTECT UNBORN CHILDREN

The Senate begins confirmation hearings begin on Sept. 4th on Supreme Court nominee Brett Kavanaugh, who sits on the DC Circuit Court. That is the main federal appeals court — often considered a stepping stone to the Supreme Court as it hears some of the most prominent cases, including ones filed against federal legislation like Obamacare.

Kavanaugh worked as associate counsel to pro-life President George W. Bush and he came out of the era of Reagan judicial appointees. His rulings have been said to be more like Scalia than Kennedy.

Sarah Pitlyk, a former law clerk to Judge Kavanaugh and special counsel for the Thomas More Society, which is a leading pro-life legal group, says Kavanaugh has an excellent record and perhaps the best record of any of the finalists president Trump is considering. As she writes:

On the vital issues of protecting religious liberty and enforcing restrictions on abortion, no court-of-appeals judge in the nation has a stronger, more consistent record than Judge Brett Kavanaugh. On these issues, as on so many others, he has fought for his principles and stood firm against pressure. He would do the same on the Supreme Court. As Pitlyk concludes: "In short, Judge Kavanaugh's record on issues of concern to social conservatives is rock solid, and it far exceeds that of any other contender. He is the right person for this pivotal time."

Editor's Note: As we go to press we do not know how the hearings will turn out but it will be close and we also wonder about how our own Senator Donnelly will vote on Kavanaugh. We can only pray for good results.

Election Year 2018 Who Is Running?

The 2018 Election is looming just around the corner and in Indiana one major race will be for U.S. Senate where the present Senator Joe Donnelly will seek re-election after a full term in office. When Donnelly was elected he portrayed himself as pro-life, but he has not gone far from his pro-abortion democratic party. The pro-life movement has not been happy with him during those six years. This does not mean he has been a strong pro-abortion supporter either. Former State Representative Mike Braun won a crowded field in the spring primary and has a 50-50 chance to unseat Donnelly. Mike Braun has strong pro-life credentials and would be a much more dependable prolife vote than Senator Donnelly. Even though President Trump won Indiana by 20% over Clinton, it is expected it will be a tough race to unseat Donnelly, and it appears it will be a dog fight here in Indiana. There will be some low profile races for the state house along with state senate and state representative races, but the U.S. Senate race will be the biggest of them all. Braun will receive the endorsement of the Indiana Right to Life Political Action Committee.

In the race for 8th Congressional District, Congressman Larry Bucshon is expected to hold on to his seat but could be closer than expected because of the off-year election cycle that does not favor the party in power. Congressman Bucshon has been a strong pro-life vote and has received the endorsement of the Indiana Right to Life Political Action Committee.

In the State Senate Races for District 39, pro-life Eric Bassler and in District 48 pro-life Mark Messmer are both unopposed in this fall election. In the State Representative Races in District 62, Representative Jeff Ellington is opposed by Amy Swain. In District 63, Representative Shane Lindauer is opposed by Joe Lannan, and in House District 45 Representative Bruce Borders is opposed by Jim Exline. All three of these districts are represented in Daviess and Martin County area. It appears that Jeff Ellington, Shane Lindauer, and Bruce Borders will be endorsed for re-elections because of their pro-life voting record. In District 64, Matt Hostettler is unopposed in his bid for election. His district is to the south of our area and has some in Pike County. Matt is the son of former 8th District Congressman John Hostettler who was a strong pro-life congressman, and his son Matt appears to be the same way.

Indiana Republicans Adopt Strong Pro-Life Platform

The Indiana Republican Party adopted one of the strongest pro-life platforms in the nation at their convention in June. Some had wanted to soften it somewhat but when the group voted it was overwhelming to keep the strong pro-life language.

Blockage of Indiana's Ultrasound Law Leads to Increase in Abortions

INDIANAPOLIS – Indiana's abortion numbers rose dramatically in 2017 following the blockage of Indiana's ultrasound law by U.S. District Court Judge Tanya Walton Pratt. The increase of 496 abortions in 2017 compared to 2016 marks the first upward swing in abortions in Indiana since 2009, according to the Indiana State Department of Health's newly-released 2017 Induced Terminated Pregnancy Report.

Indiana's Dignity for the Unborn Act, signed into law by Governor Mike Pence in 2016, contained a requirement that any woman seeking an abortion must be given the opportunity to view an ultrasound of her unborn baby at least 18 hours prior to an abortion. The ultrasound provision was challenged by the American Civil Liberties Union and Planned Parenthood in July 2016 in the wake of the Supreme Court's *Whole Woman's Health v. Hellerstedt* ruling but remained in effect until Pratt's injunction in April 2017.

From July through December 2016, while the ultrasound law was in effect, there were 3,317 abortions in Indiana. During the same period of July through December 2017, after the blockage of the law, abortions spiked to 3,813 in Indiana, a 13 percent increase compared to 2016. A significant portion of the increase was due to a massive 33 percent increase in women from out of state coming to Indiana for abortions, with 296 abortions on out of state women in 2017 compared to 222 in 2016.

In total, there were 496 more abortions done in Indiana from July through December 2017 compared to the same period in 2016. When considering the overall annual increase in abortions in 2017 was 498 compared to 2016, the impact of the blockage of Indiana's ultrasound law is clear.

"Activist judges blocked Indiana's ultrasound requirement in early 2017 and now we're paying the price in rising abor-

Pro-Life Women's Center in South Bend, Indiana Purchases Property Across Street from Abortion Clinic

On June 5 Democrat Mayor Pete Buttigieg used his veto power to block a rezoning request for a new Women's Care Center directly next door to a proposed abortion Clinic. After the Mayor did this the WCC announced they were able to purchase in a different spot which was directly across the street from the proposed abortion clinic. In many ways the new site will be better than the original one proposed. The big difference is that the new sight does not have to be rezoned as commercial property and the Democrat Mayor cannot stop it. He may try other ways but will have to wait and see.

"In my 34 years with the Women's Care Center, I have been blessed to witness what I believe are miracles and one incredible example is the unsolicited offer we received just days after the last council meeting" said WCC President Ann Manion. "At this new site with any impediments, we can immediately go to work and hope to be serving Moms and Babies by the end of the year."

tions," said Mike Fichter, president and CEO of Indiana Right to Life. "Planned Parenthood and its allies run to the courts every time our legislators pass laws that could jeopardize their lucrative abortion business. In addition to the ultrasound requirement being blocked, we've seen activist judges over the last two years block multiple laws including parental notification when a minor daughter seeks an abortion, dignified disposal of aborted babies, the mandated reporting of botched abortions that injure women, and even Indiana's ban on abortions for the sole reason of the child's sex, race, national origin, or Down syndrome. We can only imagine how many lives would have been spared if these laws had been able to take effect."

Indiana's abortion numbers show that chemical abortions continue to rise sharply, despite serious risks to women's health. In 2017, a reported 2,805 chemical abortions made up 36 percent of abortions. In 2016, the reported 1,919 chemical abortions made up 26 percent of abortions. The overall increase in chemical abortions in 2017 compared to 2016 is 886 abortions, or 46 percent. The rise in chemical abortions may be the result of new FDA guidelines, revised in 2016, expanding use of the two-drug abortion process from 49 days to 70 days.

"We are heartbroken that the continued blockage of good laws by activist judges is leading to more deaths in Indiana," stated Fichter. "We urge Attorney General Curtis Hill to appeal the activist judges' rulings, all the way up to the Supreme Court if needed. Indiana's legal battles over common sense pro-life laws underscore the need for a solid, Constitutionally-minded replacement to retiring U.S. Supreme Court Justice Anthony Kennedy."

Clinton-Appointed Judge Sides with Planned Parenthood over Women's Health

INDIANAPOLIS – Clinton-appointed U.S. District Court Judge Richard Young granted Planned Parenthood and the American Civil Liberties Union (ACLU) a preliminary injunction against Indiana's new abortion complications reporting law, Senate Enrolled Act (SEA) 340.

Planned Parenthood and the ACLU filed suit in April to block two portions of the law: first, that physicians, hospitals, and abortion facilities report when a woman is injured by an abortion; second, that abortion operators must disclose greater amounts of information when attempting to open a new abortion facility in Indiana.

"We're not surprised a judge appointed by President Clinton would side with Indiana's largest abortion chain," said Mike Fichter, President and CEO of Indiana Right to Life. "Planned Parenthood profits off ending the lives of thousands of unborn Hoosiers every year. We urge Attorney General Curtis Hill to appeal Judge Young's decision, so that women's health is protected and upheld in Indiana."


The liberal media's war against President Trump was as fierce ▲ as ever during the first four months of 2018, but the onslaught appears to be for naught: In the face of massive and hostile coverage from ABC, CBS, and NBC, Trump's overall job approval rating actually rose, from 37 percent in mid-December to roughly 43 percent at the end of April.

The Media Research Center studied all broadcast evening news coverage of the President from January 1 through April 30, and found 90 percent of the evaluative comments about Trump were negative - precisely the same hostile tone we documented in 2017. But unlike last year, when the RealClear-Politics average depicted a slow but steady erosion in the president's job approval numbers, the public has apparently warmed to Trump in 2018, even as the networks are as frosty as ever.

For this report, MRC analysts examined all 1,065 network evening news stories about President Trump and top members of his administration during the first four months of this year. The coverage totaled a whopping 1,774 minutes, or roughly one-third of all evening news airtime.

(For comparison, in 2015 and 2016, coverage of President Obama amounted to just ten percent of all evening news air-

time.) Nearly two-fifths (39%) of the TV coverage we examined focused on Trump scandals and controversies, while 45 percent was devoted to various policy issues. The remaining airtime was spent on controversies involving other top Trump officials, such as EPA Administrator Scott Pruitt, or did not involve specific topics.



Network coverage of those topics, plus a host of other smaller controversies involving the president, was almost entirely negative: of the 598 statements we tallied about Trump's personal controversies or scandals, virtually all of them (579, or 97%) were negative.

(As always, our analysis of "spin" tracks only explicitly

positive and negative statements from reporters and non-partisan sources; it excludes neutral statements as well as statements from partisans such as Trump praising himself or Democrats criticizing him.)

When it came to policy matters, the President fared somewhat better but only in contrast. Of the 542 opinionated statements involving a policy matter, 440 (81%) were negative, compared with 102 (19%) which were positive.

The policy stories earning the most TV airtime in

2018 were immigration (167 minutes), the economy (117 minutes), North Korea (111 minutes), Syria (89 minutes), and gun rights (57 minutes). The networks' spin on immigration, Syria, and gun rights was extremely negative (between 88% and 96% negative). And, despite the potential of a breakthrough with North Korea, the coverage of that topic was tilted two-to-one

against the president (68% negative vs. 32% positive).

But the remaining airtime (51 minutes) consisted of *mostly* positive coverage (73% positive) for the rest of Trump's economic agenda: job growth, tax reform, deregulation, and plans for more infrastructure spending. Yet this coverage has amounted to less than three percent of TV's total coverage of the president this year. continued on PAGE 7

"Gosnell" Trailer Calls Out Media Absence at Evil Abortionist's Trial

The new trailer for Gosnell teases the horror story of a murderous abortionist and his trial – including scenes of empty media seats in the courtroom. It's right. I know because I was there.

The trial of Philadelphia abortionist Kermit Gosnell, in which witnesses described baby abortion survivors "swimming" in toilets "to get out," attracted a mere 12 – 15 reporters (many of whom, I noticed, were local). Only after 56 days did all three broadcast networks report on Gosnell.

But the story is about to garner a new wave of attention with GVN Releasing opening the film, *Gosnell: The Trial of America's Biggest Serial Killer*, to as many as 750 theaters October 12. On Tuesday, *The Hollywood Reporter* (THR) broke the news that filmmakers had released a trailer for the anticipated Gosnell film, which stars big name actors. In the moving video, actor Michael Beach's character, district attorney Dan Molinari, warns those investigating Gosnell that, "When you get to the courthouse, you are going to be swarmed by reporters."

But as they walk past empty rows of seats with signs reading "This row reserved for press," actor Dean Cain, who plays a detective, asks, "Where is everybody?" Among other things, Gosnell was convicted May 2013 of one count of involuntary manslaughter and the first-degree murder of three babies (while the Grand Jury report, THR has noted, "alleges Gosnell killed hundreds of infants by sticking scissors into their necks"). But the film isn't just for pro-life audiences, as one scene in the trailer stresses.

"There's nothing that man did that protects women or children," actress Sarah Jane Morris's character, assistant district attorney Alexis Mcguire, says of Gosnell. "And you don't have to be a pro-life activist to see that." In addition to Gosnell's trial, the filmmakers say they themselves faced challenges in the media as well as the legal system and Hollywood, for their upcoming movie revealing the story of "America's biggest serial killer."

In an exclusive statement to MRC Culture in June, producer Ann McElhinney stated that "finally the Gosnell story will be exposed." "Most Americans have never heard the name Dr.



The positive economic story is probably one reason why the public has rewarded Trump with higher approval ratings, despite the bad press. Another is that the public's trust in the media has been eroding for years, which means that journalists are **less credible critics** than they might have been years ago.

There's no precedent for a president receiving such a sustained level of negative press over such a long period of time. The fact that the public has become more favorable towards the president in this environment is the latest sign that the media watchdog's bite isn't as menacing as their bark suggests.

Kermit Gosnell because the mainstream journalists chose not to cover the trail," she said, because "the left don't want the truth about abortion to be known." Former employees have confirmed what the filmmakers say: Gosnell's abortion clinic was a house of horrors.
