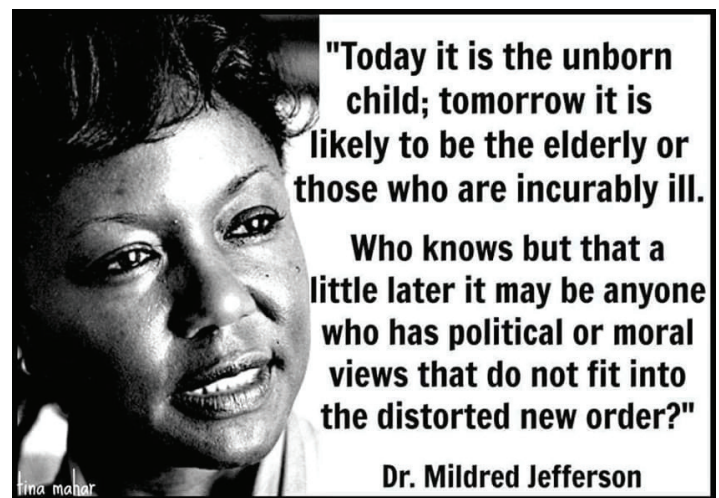

# Supreme Court Should Overturn Roe v. Wade and Let States Protect Babies From Abortions

The possibility that a Mississippi abortion law could lead to the reversal or weakening of Roe v. Wade has many on the left — including “progressives” on the Supreme Court itself — whining that the Court has become too political.

“Will this institution survive the stench that this creates in the public perception that the Constitution and its reading are just political acts?” Justice Sonia Sotomayor asked during the Dec. 1 oral arguments in Dobbs v. Jackson Women’s Health Organization, a suit concerning a Mississippi law that protects babies from abortion from 15 weeks of pregnancy on.

Do Sotomayor and her fellow liberals mean the Court is on the verge of doing what the political branches do? If so, doesn’t that sound familiar? It’s what conservatives have pointed out the Court has done for decades.

When the Court takes a position untethered to the text or structure of the Constitution or objectively rooted in the history, traditions, or legal practices of our country, the justices are setting policy — which is not their job.

The most glaring example of this is the 1973 Roe v. Wade decision that legalized abortion through all nine months of pregnancy. The Supreme Court actually created policy, taking the regulation of abortion out of the hands of the states and making abortion the only medical procedure to have a constitutional status.

Since then the left has been perfectly content to allow the courts to continue in their role as the arbiter of abortion policy, with the Supreme Court having the last word.

But if the Dobbs decision does reverse or reduce Roe, the Court actually will have demonstrated its desire to be *less* political, to return the regulation of abortion to state government, where it belongs. Now 330 million people can help determine abortion’s status through their elected representatives. That’s a far cry from 1973, when seven unelected justices took part in the most notorious judicial overreach in our nation’s history and set policy for the whole nation.

**Some state legislators have been quite content to let the Supreme Court regulate abortion. It gives them cover with their constituents because they can say their hands have been tied.** The right decision in Dobbs will return decision making to these recalcitrant lawmakers. Nor do abortion supporters have anything to complain about. If they think unrestricted abortion is the right policy, let them make their case to their fellow voters and to the lawmakers they elect. As we know, some states will protect babies from all abortions and others declare themselves — as California intends — “abortion sanctuaries.”

In his questions during the Dobbs arguments, Justice Brett Kavanaugh — one of three justices appointed by then-President Donald Trump — got it right when he took up the neutrality issue while questioning Mississippi Solicitor General Scott Stewart.

“... As I understand it, you’re arguing that the Constitution is silent and, therefore, neutral on the question of abortion? In other words, that the Constitution is neither pro-life nor pro-choice on the question of abortion but leaves the issue for the people of the states or perhaps Congress to resolve in the democratic process? Is that accurate?” Yes, Justice Kavanaugh, that is accurate. Many have suggested the Mississippi law is before the Supreme Court now precisely because Trump’s three nominees would have an opportunity to team up with other conservatives on the court and wreak havoc on the nation. That’s ridiculous.

Mississippi passed the law in 2018, a year after Trump’s first nominee, Neil Gorsuch, was confirmed to the Court, and the same year as Justice Kavanaugh’s confirmation. Not even the best crystal ball could have predicted Justice Ruth Bader Ginsburg’s death or the swift confirmation of Trump’s third nominee, Amy Coney Barrett. Mississippi legislators could not have known that a conservative-majority Court would hear their case.

But while the political leanings of the Supreme Court do make a difference, it’s not because of their position on hot-button issues like abortion, but how they feel about the role of a judge.

On that point, Justice Barrett was especially eloquent on Oct. 26, 2020, as she was introduced by President Trump and sworn in for the Court by Justice Clarence Thomas. “The confirmation process has made ever clearer to me one of the fundamental differences between the federal judiciary and the United States Senate,” she said. “And perhaps the most acute is the role of policy preferences. It is the job of a senator to pursue her policy preferences. In fact, it would be a dereliction of duty for her to put policy goals aside. By contrast, it is the job of a judge to resist her policy preferences. It would be a dereliction of duty for her to give in to them.

“Federal judges don’t stand for election, thus they have no basis for claiming that their preferences reflect those of the people.” The Supreme Court has been political for decades. Now, we dare to hope that this pattern is about to undergo a major change.

# Pope Francis Condemns Childless Culture: Having Pets Instead of Children Is Selfish

During his weekly General Audience message, Pope Francis urged couples to have children, saying those who choose to have pets instead are hurting themselves and society. The pope encouraged child-bearing and adoption Wednesday in his message about Joseph, the adopted father of Jesus.

“Having a child is always a risk, either naturally or by adoption,” Pope Francis said. “But it is riskier not to have them. It is riskier to deny fatherhood or to deny motherhood, be it real or spiritual.” Too many couples are choosing not to have children, and some are filling the relationship gap with pets instead, he said. These choices are creating a “demographic winter” in countries across the world where populations are aging and the elderly have no one to care for them, he continued, according to Vatican News. Birth rates are down in most of Europe, Asia and the United States, so much so that some countries now are offering incentives to encourage couples to have more children.

“We see that people do not want to have children, or just one and no more,” the pope said. “And many, many couples do not have children because they do not want to, or they have just one — but they have two dogs, two cats ... “Yes, dogs and cats take the place of children,” the pope said. “Yes, it’s funny, I understand, but it is the reality. And this denial of fatherhood or motherhood diminishes us, it takes away our humanity. And in this way civilization becomes aged and without humanity, because it loses the richness of fatherhood and motherhood. And our homeland suffers, as it does not have children.”

For infertile couples, the pope encouraged adoption, saying, “How many children in the world are waiting for some-



one to take care of them?” He concluded by praying that no child ever would be “deprived of a bond of paternal love.” Pope Francis frequently speaks about the value of children, born and unborn. In September, he criticized the “throwaway” culture that makes abortion seem “normal.” “There is the waste of children that we don’t want to welcome,” he said. “It is really a murder.” He added: “Is it right to eliminate, to take a human

life to solve a problem? Is it right to hire a hitman to solve a problem? That’s what abortion is.”

## Trump Slams Democrats: “We’re Tired of Taking Lectures From a Party That Thinks Babies Can be Killed After Birth”

Former President Donald Trump headlined a rally with tens of thousands of pro-life conservatives in Arizona on January 15. During his speech, Trump slammed Democrats for supporting abortion and even going beyond that — defending infanticide.

According to the former president, “We’re done taking lectures on science from a party that tells us men are women, women are men, and the babies... and this is a fact, the babies can be killed even after birth,” Trump said. “They used to talk late-term, now they’re talking about... just go check out your former governor of Virginia, who said it’s all just fine with them, babies can be killed after birth,” he added. This isn’t the first time Trump has railed on Democrats for their extreme abortion stance.

# Joe Biden’s Approval Numbers Hit All-Time Low: Americans Say He’s a Failed President

Joe Biden’s job disapprovals hit an all-time high in a new CNBC poll. Thomas Franck explains:

Fifty-six percent of voters now say they disapprove of the job Biden is doing, the worst such reading of his presidency as he approaches the end of his first year in office, according to new CNBC/Change Research polls. Prior polls in the series showed Biden’s disapproval rating at 54% in early September and 49% in April.

Biden’s approval rating is now at 44%, down from 46% in September and 51% in April...

Results from a CNBC/Change Research poll show 60%

of respondents said they disapprove of Biden’s handling of the economy as he nears the conclusion of his first year in office.

A 55% majority of survey respondents also signaled disapproval of his leadership during the pandemic, an area in which he previously excelled. Bad as those numbers are, Biden scores worse on personal favorability: 38/56.

The picture these numbers paint for the elections this fall are grim. “While the president’s party typically loses seats in Congress during a first-term election, present polling about Biden and Democrats suggest they could face a rout in November,” Franck writes.

# Here's Why I'm a Pro-Life Millennial Woman Who Opposes Killing Babies in Abortions

The recent Supreme Court argument on overturning *Roe v. Wade* is the most consequential case of my lifetime. And for countless millennials, and particularly young women like me, it is time the court overturns *Roe v. Wade*. On the surface, I look like a typical, pro-choice Democrat acolyte. As a young, successful millennial who grew up in a single-parent household that survived on government assistance, my supposed support of abortion is expected, particularly among liberal Democrats and the mainstream media.

But those folks are wrong about this, as they are about so many things. As a Christian, I am an adamant supporter of life. And I'm not alone. My generation is waking up to the toll of abortion on demand. A study released earlier this year showed that nearly 60% of millennials and Gen Z support overturning *Roe*. Those are numbers unheard of in previous generations.

The support for abortion is cratering because so many of us have witnessed the heartbreak, pain and depression experienced by friends and family who thought abortion was an easy choice, not to mention those who have experienced it firsthand.

As a student at Dixie Hollins High School, it was common to see my female peers get pregnant and then struggle to decide what their next steps should be. The same lack of education and understanding that led to their unwanted pregnancy was compounded by the lack of information on the options for single mothers.

Three of my friends, who each came from different socio-

economic backgrounds, had to make very adult decisions at a young age on terminating an unplanned pregnancy.

One chose to carry full term and raise the child as a single mom with the help of her family. One chose to carry full term and put the child up for adoption. And one chose to terminate the pregnancy with an abortion. The immediate impact of each of these decisions was obvious for the two who chose to carry to term, but relatively minimal for the one who chose abortion. The one who aborted her baby went back to partying, got into college as she had planned, and never looked back.

The reality is, the young woman who chose abortion has had countless battles with depression, anger, and now infertility. The decision she made with little information about the long-term mental and physical health effects now plagues her daily life. *Roe v. Wade* changed the landscape of America, but our generation is waking up to what the original sin of wokeism cost us. It not only cost the lives of over 62 million innocent babies but also the cost of unspoken depression and mental health scars that never go away.

Growing up here in Pinellas County, I remember happy things like playing outside until the lights came on, going to the beach, and going on mission trips with my church. But I also remember the pain and hopelessness of friends who wrongly thought abortion was the easy way out. The next generation will have many challenges. But because of a conservative Supreme Court willing to stand up for the law, on-demand abortion is unlikely to be one of the challenges they will face.

# Did the Catholic Bishops Cave In to Catholic Politicians Receiving Communion?

At the latest meeting of the Catholic bishops in November they voted 222-8 to adopt a new document on receiving Holy Communion that calls on Catholic politicians to base their political views on “the Church’s faith and moral law.” The new document stopped short of saying whether pro-abortion politicians like Joe Biden should be denied Communion. Many in the pro-life movement felt the bishops may have caved in to pressure from the Vatican or more liberal bishops and not wanting to take a strong stand against Catholic politicians who flaunt their Catholic faith but also flaunt their strong support of abortion, thus creating a scandal in the Catholic Church.

The document, “The Mystery of the Eucharist in the Life of the Church,” emphasized the “special responsibility” of Catholic elected officials to follow Church teachings. However the document does not mention Biden or any other politicians’ names, but it does emphasize that public figures who profess to be Catholic have a greater responsibility to live out their faith although it says at one point, “Lay people who exercise some form of public authority have a special responsibility to embody Church teaching.” Some bishops did not want to use this issue as a weapon against pro-abortion Catholics, and by not being stronger on this issue they are turning a blind eye to this scandal thus creating even more uncertainty among the Catholic faithful.

Many Catholics see the lack of action by the bishops as saying that any person can be pro-abortion in the church and the church will look the other way. This is a scandal that is getting worse within the church; and by not taking a strong stand against Catholic politicians supporting abortion, they will continue to push their pro-abortion views on our country. They profess to be Catholic but are so in name only. Abortion is not the only issue that is raising concerns. These same Catholic politicians also push gay marriage and transgender policies that should be of grave concern to the church leaders.

***What did the Bishops say in their watered down document? It was a 31 page document that was hard to get to the real heart of the issue. Much was in there that the average Catholic would wonder what they were trying to say. So far I have not seen a Catholic paper that really summarized and got to the bottom line of what the bishops were saying. It reminds me of what the bishops put out before each election which is lengthy in words and so much double talk the average Catholic won’t even read it. When it comes to the elections, what the bishops should be saying in one sentence is that “Voters should not vote for candidates who support abortion or gay marriage that conflict with church teaching.” But the bishops don’t want to do that.***

Bishop Joseph Strickland of Tyler, Texas, who had been critical of President Biden in the past, asked colleagues to amend the document by quoting the church catechism and the Bible as saying anyone who creates scandal would be better off having a “millstone fastened around his neck and to be

drowned in ... the sea.”

After the vote, Bishop Strickland spoke to his fellow bishops and emphasized the importance of abortion. “I must speak for the babies,” he said, reminding everyone that it’s a “preeminent issue” and that the murder of unborn children “destroys the very foundation of our civilization” and that as a shepherd, he has to speak on this. “Abortion opens the door to evil, and allows Satan to run rampant through every aspect of human life.”

**Though Biden claims to be Catholic, he is advancing the most radical pro-abortion agenda of any U.S. president in history, including plans to force taxpayers to pay for elective abortions all across the world and remove the Hyde Amendment which has prevented Americans from funding abortion; but Biden wants to remove it.**

Many Catholic bishops and other Christian leaders have expressed concerns that Biden’s radical abortion advocacy is misleading Catholics and creating scandal for the faith. They have said the church must do something to make it clear that Catholics cannot support abortion and must repent before participating in Communion.

Earlier in November, Biden met with Pope Francis at the Vatican. Afterward, the president said the pope told him he was a “good Catholic” and he should “keep receiving Communion”; however, the Vatican has not confirmed those remarks. We don’t know whether Biden was telling the truth as Biden has made statements in the past that have turned out not to be true.

It appears to many pro-life Catholics that the pope has also been very weak in his response on the abortion issue. If the pope really did say this, it is of grave concern. Remember, he did meet with pro-abortion Catholic Speaker of the House Nancy Pelosi weeks before he met with President Biden, but we don’t know even if the issue of abortion was brought up.

Biden openly defies church teachings about the sanctity of human life. After just 100 days in office, he surpassed President Barack Obama as the most pro-abortion president in U.S. history, including allowing mail-order abortions and trying to force taxpayers to fund abortions. His administration also is fighting to overturn a pro-life Texas law that has saved thousands of unborn babies from abortion in the past two months. And it dropped a lawsuit defending a pro-life nurse from Vermont who was forced to participate in an abortion.

The bottom line is the lack of strong action by the bishops has given an unclear message to Catholic politicians and Catholics in the pew. It has given pro-abortion politicians a pass on this very important issue in the church. This will continue to give mixed signals to all Catholics and give them an excuse to continue to vote for and support catholic politicians who support abortion, gay marriage and gender issues that should be strongly opposed by the church.

This document will be like much of the rest that bishops have issued and will have a lot words without really getting to



the heart of the issue. The Right to Life organization and other pro-life organizations like them must continue to speak out on the dangers of voting for pro-abortion candidates as this will be the only way that we can overcome Catholic politicians and other politicians who think they can sing to Jesus on Sunday and then on every other day of the week work for the killing of the unborn.

Let us continue to publicize those candidates who support abortion and hit them at the ballot box, as that is the only way going forward since many (not all) of the clergy lack the backbone to stand up for the unborn.

## The Late Dr. Bernard Nathanson Said This About the Clergy Who Did not Speak Up on Abortion

Dr. Bernard Nathanson, who was one of the leading abortion doctors who helped to make abortion legal in America, had this analogy for those clergy who would not speak up after abortion became legal in the United States. Dr. Nathanson, who performed thousands of abortions himself, said that “if all the clergy had spoken with one voice against abortion, it would never have happened in this country.” So many clergy were weak in their response or not at all; some clergy in liberal churches actually supported abortion. Many good Christian clergy did speak out and are continuing to do so, but they are much fewer in numbers. So many are silent and never speak about the evil of abortion, and they make the excuse they don’t want to be political. Well, this is not political; it is a matter of life and death. An example of this is the U.S. Catholic bishops. There are about 240 or more Catholic bishops in the United States, but we only hear from 20-30 that really make strong statements against abortion. The rest may say they are against abortion, but you will hear them talk more about the danger of global warming than the evil of abortion. It is such a sad state we are in.

There are many leaders in the pro-life movement that feel many of the Catholic bishops may be more sympathetic to the Democratic Party and Democrat politicians, and this may be the real reason behind their lack of action. You may ask why the pro-life movement is critical of clergy for not speaking out against this evil of abortion. We know they have every right to speak out on this issue, and they are in a position where it would greatly enhance our chances to defeat this evil if they would raise their voice and speak out on this issue and lead the charge. It would mean so much coming from them that abortion is wrong and we must do everything we can to stop this evil against the unborn.

The bishops and all church leaders have a responsibility to speak out plainly on what is right and what is wrong according to the church teachings, especially on issues such as the sanctity of life, as this is a miraculous gift from God. Yet when our church leaders are not clear, or remain silent on this issue, then one may start to draw their own conclusions and find it justified

After all this is God’s little ones that are calling for help to save their lives. God give the clergy strength to do God’s will!
