Pregnancy Care Centers Are There to Help Young Mothers in Unplanned Pregnancies

So many times we hear the pro-abortion forces push this unfounded statement that pro-life people don't care about babies already born, just those to be born. All across the country pregnancy care centers have sprung up and continue to help mothers with an unplanned or unexpected pregnancy. It is estimated there are around three thousand pregnancy care centers in the United States, and there are several very nice facilities here in our area.

We start with First Choice Solutions here in our area, which is located at 714 W. Walnut Street in Washington, Indiana. It was formerly known as the Washington Pregnancy Care Center; but they changed their name a couple years ago and have moved from the location at the Grace Baptist Church to the very up-to-date building at the west end of Washington. They bought the building and totally refurbished it from top to bottom with new electrical/heating and air conditioning, and it looks like a new building on the inside. They offer counseling, pregnancy tests, ultrasounds, and many clothes and baby items for young mothers, and just anything that an expectant mother would need. They continue to increase the numbers of clients they see each month and are able to help young mothers, and for many it is a life-changing time.

There are other pregnancy care centers in our area. In Vin-

cennes there is Heart to Heart; and in Bedford there is Hope Resource Center; and in Linton there is Pregnancy Choices for mothers with unplanned pregnancies. In our area there are many resources available to young mothers such as St. Vincent DePaul Societies in Washington and Loogootee. First Choice Solutions here in Washington (formerly the Washington Pregnancy Care Center) was started by Right to Life organizations here in Daviess County. Many of the pregnancy care centers were started by Right to Life organizations or people who belong to both organizations.

So when you hear some pro-abortion person making the statement that Right to Life people don't care about pregnant mothers, now you know that there are many organizations that have been started to help pregnant mothers in the time of need. In Daviess and surrounding counties there are several churches and organizations that work tirelessly to help pregnant mothers in need, and this does not include other churches and organization who are doing the same work on a smaller scale.

When pro-abortion people spout this propaganda, they are only doing this to try to justify their own pro-abortion mentality. It is similar to those individuals who try to justify voting for pro-abortion candidates by saying abortion is only one issue and there are other issues as important as abortion.

Catholic Group Supports Ketanji Brown Jackson Even Though She's Pro-Abortion

Network, a political lobbying group that identifies as Catholic, joined other groups Wednesday in calling for the confirmation of pro-abortion U.S. Supreme Court nominee Ketanji Brown Jackson. Jackson is President Joe Biden's choice to fill retiring Justice Stephen Breyer's seat; and Biden promised to choose a justice who believes in the so-called "right" to abort an unborn baby. Jackson also has the support of NARAL Pro-Choice America, which advocates for abortions without limits up to birth, as well as leftist "dark money" groups funded by pro-abortion billionaire George Soros.

Both pro-life and abortion activists believe Jackson would support *Roe v. Wade* and abortion on demand if confirmed to the high court, and many Catholics oppose her for this very reason. Network, however, believes Jackson would "enrich" the high court, according to the Catholic News Service.

At a rally Wednesday in front of the U.S. Supreme Court building, Mary Novak, executive director of Network, praised Jackson for being calm and gracious during her hearing last week, the report continues. "We need her," Novak said. "Network's got your back." In the letter, her organization urged Durbin to confirm Jackson "with bipartisan support and all deliberate speed."

Catholics for Choice, a pro-abortion group that claims the Catholic label but is not affiliated with the church, also participated in the rally, according to the report. Pro-life leaders and Republicans have raised many concerns about Jackson's record. In 2001, she co-authored an amicus brief supporting a Massachusetts law that created a floating "buffer zone" to prevent pro-life sidewalk counselors from approaching women outside of abortion facilities. Her clients included NARAL and the Abortion Access Project of Massachusetts.

She also ruled against the Trump administration's efforts to defund the billion-dollar abortion chain Planned Parenthood, and she clerked for pro-abortion Justice Breyer when he issued an opinion against the partial-birth abortion ban.

U.S. Sen. Josh Hawley, R-Missouri, raised other concerns about Jackson's "soft" record on criminals convicted of child pornography offenses. The Senate Judiciary Committee is scheduled to vote on her confirmation April 4, and a full vote in the Senate likely will be held later that week.

It is expected that Judge Jackson will get the necessary approval needed for her to secure the nomination to the Supreme Court as one Republican Senator from Maine, Susan Collins, has stated she will vote for Jackson. Democratic Senator Joe Manchin, who considers himself to be pro-life, has stated he will vote for Jackson. With Jackson's pro-abortion record, how can anyone who calls themselves pro-life vote for her? We are disappointed in Senator Manchin. And we are sure the other 49 pro-abortion Democrats will follow in step. Arizona Democrat Senator Kyrsten Sinema hasn't yet said how she would vote as she has voted pro-life at times even though she is a Democrat.

With Susan Collins and potentially another Republican, Lisa Murkowski, voting for Jackson as both Collins and Murkowski are pro-abortion, her nomination is all but assured. The vote out of committee is expected on April 4 and then it goes to the full senate for final confirmation.

Jackson was nominated because she was a liberal black woman. Biden has promised to nominate a black woman to the Supreme Court. There were plenty of good conservative black women that could have been nominated, but Biden wanted one who supported the killing of the unborn. Jackson had a record in her past and it is not good for the protection of the unborn. There is plenty in Jackson's rulings for pro-lifers to worry about.

We can only hope the decision by the present Supreme Court that is due out in late June will help to put restrictions on abortion here in America.

Ben Watson: “Stop Playing Word Games. Abortion Isn’t Health Care”

Joe Biden referred indirectly to abortion as health care during his State of the Union address. It was a euphemism inside a euphemism: the “right to choose” abortion framed as a necessary part of this thing we call “health care.”

But abortion isn’t health care. And it’s time to stop playing word games.

Health care’s dictionary definition is “efforts made to maintain or restore physical, mental, or emotional well-being especially by trained and licensed professionals.” But abortion doesn’t treat a disease or improve a disorder. It forcibly ends a life.

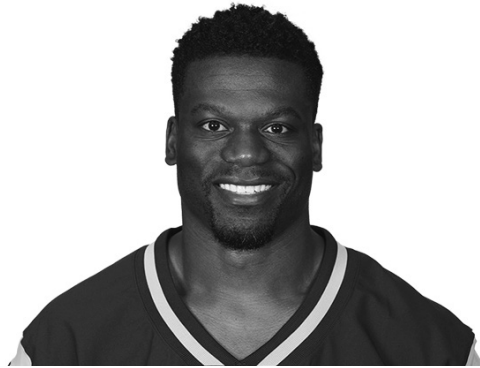
The Hippocratic Oath, one of the foundational pillars of the medical profession, explicitly bans doctors from administering abortions or euthanasia.

Talking about abortion like its “health care” isn’t just a pernicious, subtle lie. It confuses and obscures reality. It harms women, it harms children and it prevents us from improving countless lives.

There is also a deliberate attempt to convince our kids that abortion is just another part of women’s health care. Planned Parenthood is already in many classrooms nationwide, teaching students that abortions are a normal medical procedure. This muddies the water even more, and is going to make real maternal health care reform increasingly difficult as time passes.

There’s a reason its advocates need to play word games, after all—“abortion” is a word with negative connotations, no matter where it’s used. An “aborted” landing, an “aborted” meeting, an “aborted” mission: these are all things that have been terminated too soon. They aren’t routine procedures. Being “aborted” is not a good thing.

Framing abortion as the only possible response to inadequate maternal health care makes killing unplanned babies the



easiest thing to do—and that’s exactly what so many young, frightened mothers choose to do. And the longer people get away with calling abortion “health care,” the longer we avoid the conversation about what real maternal health care would look like.

I’m not really sure why we dodge this question. The U.S. has nearly double the maternal mortality rate of any other wealthy, developed nation. That’s a scandal.

The maternal mortality rate disproportionately affects minority women. The impact of structural racism and implicit bias on social determinants of health is undeniable. During the pandemic, for example, maternal mortality spiked because more Black women died. The mortality rate for white women, while still relatively high, remained more or less unchanged. When critical factors such as economic stability, quality education, health care access and mental health are left unaddressed, we simply double down on the nefarious policies that created these inequities.

Complications from pregnancy, delivery or the postpartum period is among the most common causes of death for American women ages 20-34. I find it hard to believe that these mortality rates don’t influence a mother’s decision to kill her child. This is avoidable. We should make it possible for these women to feel safe keeping their babies, by giving them better access to maternal health care. Not abortion, mind you. Actual health care.

What Will Happen in the Midterm Elections in 2022?

Since the beginning of the year, liberal media networks CNN, NBC, CBS, MSNBC, and ABC have expressed concerns that the GOP will triumph over Democrats in the 2022 midterms, with many hosts asking how President Biden can save the party from an impending bloodbath.

On March 23, *The New York Times* published an op-ed in which columnist Thomas B. Edsall asserted that Democrats are making it too easy for Republicans to claim victory and slammed liberals for turning away from the working class while tolerating brazen crime.

Meanwhile, on the March 30 airing of MSNBC's "Meet the Press Daily," host Chuck Todd sounded the alarm on Democrats' dwindling chances of victory in November with a "Mid-term meter" that placed the president's party in the "shellacking" category, below bad, decent, and exceptional.

Todd went on to say this is the first time since 2014 that Republicans hold a 46-44 advantage in the congressional preference election poll. He said this is an extreme red flag, and you could tell that by the tone of his voice. Not only by his reporting this, but it pained him so much, as well as all liberal media outlets, since they have been cheerleaders for the Biden campaign and for the Biden Administration since he took office.

Will the Republicans retake the U.S. House and Senate? Time will tell as the Biden Administration is in total disarray at the present time with gas prices the highest ever and one crisis after another. President Biden refuses to take questions, and he is not willing to even admit that he is causing these crises by what he is doing in his administration. Yes, there is still time for the Democrats to recover; but if the Biden Administration continues with their present policies, it may get even worse.

Primary Elections on May 3, Who Is Running

In the 8th district congressional race the incumbent Congressman Larry Buchson is unopposed in the primary, but on the Democrat side there are three individuals running to challenge him. They include Adnan Dhahir, Ray McCormick, and Peter Priest II; and none of the three have responded to the questionnaire from the Indiana Right to Life P.A.C., so their views are unknown.

In the race for state representative in district 45, on the Republican side, incumbent Bruce Borders is running for re-election and he is being challenged by fellow Republican State Representative Jeff Ellington who moved from District 62 to challenge Borders. Both have pro-life voting records and both are co-endorsed by Indiana Right to Life P.A.C.

In state representative district 62, on the Republican side, Dave Hall and Greg Knott are running for the open seat left by Jeff Ellington. Hall has been endorsed by Indiana Right to Life P.A.C. On the Democrat side of District 62 Penny Githens and Brad Swain are running and neither have responded to the questionnaire from Indiana Right to Life P.A.C.

Several Races are unchallenged in the primary: Races for U.S. Senate, State Senate 39 and 48 and State Representative 63 and 64. The incumbents either have no challengers in the primary or no opponent at this time for the fall election. The party has until August to fill the position. Early voting has started and will continue till the primary on May 3. All voters are encouraged to vote. Remember, you can't complain if you don't vote.

Oklahoma Legislature Passes Abortion Ban That Will Save 4,000 Unborn Babies A Year *Micaiah Bilger, LifeNews.com*

Pro-life legislation on its way to Oklahoma Gov. Kevin Stitt would protect almost 4,000 unborn babies every year by banning abortions in the state.

Tulsa World reports the state House passed the abortion ban (Senate Bill 612), sponsored by state Sen. Nathan Dahm, R-Broken Arrow, by a strong majority. The vote was 70-14, with one Republican, state Rep. Carol Bush, R-Tulsa, joining Democrats in voting against it.

The pro-life bill bans all abortions in Oklahoma except if the mother's life is at risk. It also creates felony charges for abortionists who kill unborn babies in violation of the ban, which includes up to 10 years in prison and a \$100,000 fine.

About 4,000 unborn babies are aborted every year in Oklahoma, according to state health statistics; but abortion industry workers say they have been seeing more women come from

Texas for abortions since the Texas heartbeat law went into effect in September.

Emily Wales, interim president of Planned Parenthood Great Plains Votes, said their abortion facility in Oklahoma saw an 800-percent increase in women coming from Texas for abortions since last fall, according to the Associated Press.

That means the legislation could save thousands of unborn babies' lives every year, not just in Oklahoma but also in Texas.

Nathan Dahm, the lead sponsor of the bill, said abortions destroy innocent human lives. "For almost half a century, our nation has sacrificed unborn children, costing over 60 million lives." "The core and proper function of government is to protect our rights."

The bill passed the state Senate by a strong majority during the last session. Stitt, a pro-life Republican, is expected to sign it.

If More Women Saw Ultrasounds of Their Baby, More Women Would Reject Abortion

Women deserve to be informed completely about the development of their unborn child. An ultrasound is part of the critical information needed for a woman to know clearly the impact that an abortion would have. No woman should be deprived of such valuable knowledge.

Of course, it should not be surprising that abortion centers want to operate under cover of darkness. Each abortion is the taking of an innocent, unrepeatable human life. It is quite hard to argue for “choice” when the face of the victim appears on the screen.

Women Dying in Back Alley Abortions Prior to 1973 – False Statements!

When the pro-abortion forces were pushing for abortion to be legalized in the United States prior to 1973, the leader of that movement, Dr. Bernard Nathanson, made a statement at a press conference that 10,000 women died each year from back alley abortions. That number was totally false, and he knew it; but they fed it to the liberal press who was also pushing for abortion to be legalized, and the press ran with it. All the press picked it up and used it time and time again and never once checked the facts.

Dr. Nathanson, who was an abortionist himself, later saw the evil of his ways and converted to pro-life, converted to the Catholic Church, and tried to set the record straight with the media; but they would hear nothing of it. What they had written they had written, and they were not going to change it. Dr. Nathanson said he would carry to his grave the stain of abortion that he helped to inflict on this country, and he deeply regretted it. I met Dr. Nathanson several times, and in 1988 he spoke to the Right to Life Banquet here in Daviess County when he told his story. He talked about how he was the leader of that small group of individuals that made big money by performing abortions and helped to get it legalized here in the United States. Although the decision finally came from the U.S. Supreme Court, he softened the mood of the country and helped to lay the path. Dr. Nathanson died a few years ago in his modest apartment in New York.
