## Radical Abortion Activists Attack Pregnancy Center That Helps Pregnant Women

The pro-abortion terrorist group Jane's Revenge vandalized another pregnancy center Saturday in Bowling Green, Ohio. HerChoice pregnancy center was the latest target in dozens of vandalism and arson attacks against pro-life organizations within the past year. On Saturday, pro-lifers discovered graffiti spraypainted across the exterior of the building, including the words "Jane's Revenge" and "Fake clinic." "Fund abortion," "Abort God" and "Liars," according to a press release from Ohio Right to Life.

"Those who work at the [Bowling Green pregnancy center] are some of the kindest, loving, and caring individuals you could ever meet," said Peter Range, CEO of Ohio Right to Life. "Knowing these individuals personally, this attack on their cen-

ter will only strengthen their resolve to continue to love those in need."

The Bowling Green organization provides free pregnancy tests, ultrasounds, STI testing, parenting classes, infant and toddler supplies and more to help families in need.

According to 13 ABC, security footage caught the vandal in the act, and local police are investigating. Although the suspect's face was covered, the vandal appears to have been a woman, pregnancy center staff told the local news outlet.

# New Abortion Law Passed in July of 2022 Ruled Constitutional by the Indiana Supreme Court

*Supreme Court Ruled in Favor of the Pro Life Position* By Louis Kavanaugh Jr.

On Friday June 30 the Indiana Supreme Court ruled that abortion laws passed in a special session by the Indiana legislature and signed by Indiana Governor Eric Holcomb was constitutional and therefore is expected to go into effect here in Indiana around August 1.

In a special session in late July of 2022 the Indiana legislature passed strong pro-life legislation (SB-1) which would protect the lives of the unborn. Shortly after the law took effect, Planned Parenthood and like-minded pro-abortion groups filed a court case asking the court to set aside SB-1. Devil worshippers have also joined the lawsuit on the side of the pro-abortion forces. We now know PP is in partnership with these people. What does that tell you? These type people (devil worshippers) have said these babies killed by abortion are a sacrifice to the devil. Legal experts have stated they see nothing in the Indiana Constitution that would give women the right to abortion, and the courts finally agreed to that.

The Indiana Supreme Court took the case and they heard arguments on January 19th of 2023 and ruled in favor of the pro-life position on June 30, 2023, but it is unclear when SB-1 will go into effect. It took a from January 19 to June 30 for the court to decide this case, but in the meantime a lot of babies were killed while they took their time to decide the case.

## Some background on this case:

The law in question was enacted by the Indiana General Assembly and signed into law by Governor Eric Holcomb on August 5. It bans most abortions except in cases of rape,

incest, and specific medical conditions. **“This law passes the constitutional litmus test,”** said Breen.

The lawsuit, filed in a Monroe County court, has triggered several actions. The first was September 22 with the issuing of a preliminary injunction on the law, which had gone into effect on September 15 of 2022. This action set the state law to its status prior to the ban, again allowing abortions in the state up to 22 weeks gestation.

Indiana Attorney General Todd Rokita sought to bypass the appeals court and asked the Indiana Supreme Court to take over the case and to lift the temporary injunction. The court agreed October 12, 2022 to take the case but left the temporary injunction in place until a decision is reached. **“The circuit court’s decision to halt enforcement of Indiana’s new protections for unborn children is unsupported in Indiana law and history,”** Breen said.

In response to the announcement that the temporary injunction would remain in place, Indiana Right to Life CEO Mike Fichter stated the organization estimates “at least 3,000 unborn babies, whose lives otherwise might have been saved, will now needlessly die from abortion as the law remains blocked.”

“Thousands more will die as we await a final ruling after the January hearing,” he said. “Although we are confident the law will be upheld, it will be far too late for those whose lives will be lost as this is argued in the courts.” Now that SB-1 has been upheld, it has cost thousands of lives of unborn children and we are not quite sure when SB-1 will go into effect. We can only hope it will be soon.

# Planned Parenthood is Killing as Many Babies as Possible Before Indiana Abortion Ban Takes Effect

Indiana Planned Parenthood facilities appear to be rushing to abort as many unborn babies as possible before a state ban on elective abortions goes into effect. On June 30, Indiana achieved a huge victory for life when the state Supreme Court issued a decision in favor of the abortion ban. The law, which has been blocked since September, is expected to go into effect within the next month.

In the meantime, Planned Parenthood facilities are completely booked for abortion appointments for the next three weeks, the *Indy Star* reports. Exactly how many unborn babies are slated for death in that time period was not mentioned, but pregnant mothers likely are coming from nearby pro-life states like Kentucky and Tennessee as well as Indiana.

In a press release, Planned Parenthood said 1,827 women came from other states to its Indiana facilities for abortions in 2022. This year, the abortion chain said its abortion drug sales to out-of-state women have doubled.

Still, hope remains that the pregnant mothers scheduled for abortions will change their minds. Pro-life sidewalk counselors continue to offer information and support outside abortion facilities daily, and pregnancy resource centers and other charities are prepared to provide material and emotional assistance to help families choose life for their babies.

Indiana was the first state that passed a law to protect unborn babies from abortion after the U.S. Supreme Court overturned *Roe v. Wade* on June 24, 2022. The pro-life law bans abortions with exceptions for rape, incest, fatal fetal anomalies and situations when the mother’s life is at risk. Planned Parenthood challenged the law in court and a judge blocked it in September. However, on June 30, the Indiana Supreme Court agreed to lift the injunction, ruling that the state legislature has

“broad ... discretion for determining whether and the extent to which to prohibit abortions.”

As a result, the state will be allowed to enforce the pro-life law as soon as the court certifies its decision, likely by August 1, according to the *Indy Star*. Despite its loss in court, Planned Parenthood said it plans to keep facilities open in Indiana to help women book abortion appointments in other states.

“Planned Parenthood will keep fighting to restore reproductive rights in Indiana and to help Hoosiers get access to the services they need,” the abortion chain said in a statement. “To anyone looking for abortion care, Planned Parenthood’s staff is ready to help them find an appointment and provide the information and resources needed to access care.”

However, women do not need abortions, and killing unborn babies is not healthcare – something tens of thousands of doctors confirm. The Indiana law, like all state pro-life laws, does not restrict actual medical care. Doctors still may treat pregnant women who suffer miscarriages, ectopic pregnancies, and other complications that may threaten their lives. The law only prohibits elective abortions, which unnecessarily and intentionally kill babies in the womb.

Meanwhile, state leaders are fighting a second lawsuit from the ACLU and Hoosier Jews for Choice that claims the law violates their religious faith. A judge issued a separate injunction in that lawsuit and the ruling remains in place, but it only applies to the plaintiffs. The Indiana Attorney General’s office is appealing the injunction and courts will hear that case in September.



Indiana Right to Life leaders predict the law will save thousands of unborn babies’ lives when it goes into effect. The Indiana Department of Health just published abortion statistics for 2022. The report shows a massive rise in abortions as well as abortion complications, including one woman who died along with her unborn baby in an abortion.

“Last year was, essentially, open borders on abortion, despite the will of millions of loving and compassionate Hoosiers represented in the passage of SEA 1,” said Mike Fichter, Indiana Right to Life president and chief executive officer. “We are hopeful the recent Indiana Supreme Court ruling ends this exploitation by abortion businesses in Indiana. Each day the law remains inactive, is another day where Indiana becomes the final and fatal destination for unborn babies.”

## Providing or Depriving Women of Resources *by Bradley Mattes*

You’ve heard it before. “If those nasty anti-choice Republicans were really pro-life they’d support programs that provide substantive help for women.” At the same time, their pro-abortion Democrat allies are defended as “heroic feminists.” When it comes to supporting America’s women and their



children, critics say these advocates of abortion have forfeited their feminist cards.

**This year has been a stunning display of who is providing significant resources for women, men, and their babies born into challenging circumstances.**

Democrat governors have been vetoing legislation in cruel fashion

that supports women who struggle with unexpected pregnancies, exacerbated by inflation brought on by poor policy decisions in Washington, DC.

**Arizona’s pro-abortion Democrat Governor Katie Hobbs stripped critical funding for pregnant homeless women.** Since its inception more than 1,100 women have been provided

housing, stability, substance abuse counseling, among other resources – and most importantly – a fresh start in life.

In **Kansas**, pro-abortion Democrat Governor Laura Kelly vetoed:

- The Alternatives to Abortion Program that would have provided significant help for women who choose life for their babies or want to make an adoption plan.
- State income tax credits to support 50 pregnancy centers offering free resources to women.
- Tax credits to assist families with adoption expenses.
- Tax credits for purchases from businesses employing individuals with special needs.
- Informing women about abortion pill reversal.

The legislature, controlled by pro-life Republicans, overrode Kelly’s veto of resources for women through pregnancy centers. They also overrode the veto of abortion pill reversal, which demonstrates Kelly doesn’t support choice for women – only abortion.

**North Carolina’s** pro-abortion governor, Roy Cooper, a Democrat, vetoed the Care for Women, Children and Families Act that included comprehensive practical resources for women and their families in need. The bill:

- Expands access to childcare.
- Funds foster care, kinship care, and children's homes.
- Provides maternity and paternity leave for teachers.
- Grants millions to reduce infant and maternal mortality.
- Assists mothers and fathers as they complete community college.

The pro-life Republican-controlled legislature overrode Cooper's veto, and North Carolina's women will receive the care and resources intended for them.

**President Joe Biden**, another pro-abortion Democrat, has **on a massive scale** eliminated assistance for America's women and their babies, particularly those who are most desperate.

Biden denied the expansion of Medicaid for poor mothers of newborns and other low-income services in Texas, Oklahoma, and Tennessee, (Idaho may be next) because the states do not refer for abortion. These actions come in spite of federal law protecting Title X funds from being used to provide or refer for abortion. Tens of thousands of women are being negatively impacted by the president's actions.



**In spite of these challenges, progress is being made.**

In April, the **Texas** pro-life Republican-led legislature approved \$225 million to assist pregnant and parenting mothers and babies. These new resources will fill a variety of practical and crucial needs during pregnancy, through birth and well beyond.

After Biden denied the state Title X funds to Texas, the legislature filled the gap themselves, extending Medicaid for new mothers up to a year after birth.

**West Virginia's** pro-life Republican Governor Jim Justice signed the Support for Mothers and Babies law that established a \$1 million fund to assist women through pregnancy centers, maternity homes, or perinatal hospice centers.

Pro-life Republican Governor Bill Lee from **Tennessee** signed a law setting up a \$100 million grant fund to serve mothers, fathers, and families facing an unexpected pregnancy. It will provide improved access to healthcare and material support and expand services for children in foster care and those with special needs.

**Arkansas** is an example where both Democrats and Republicans came together and unanimously passed a bill setting up a \$1 million grant that provides pregnancy centers, maternity homes, adoption agencies, and social services material support for women facing unexpected pregnancies. Arkansas also passed three different bills that:

- Raises the state tax credit for stillborn children.
- Allows an unborn baby to be claimed as a dependent for income tax purposes.
- Provides income tax credits for donations to pregnancy centers that provide free resources to women.

**Mississippi** is a shining example of a pro-life Republican majority delivering crucial services for women and their babies in a state known for its poverty. Pro-life Republican Governor Tate Reeves signed several resourceful bills. In total, there were eight pro-life, safety net measures. Those listed will:

- Expand the state's tax credit for donations to pregnancy centers aiding women and their babies.
- Create a website offering information and resources for pregnant women.
- Establish a tax credit up to \$10,000 for adopting a child within the state and half that for out of state adoptions.
- Increase the time a mother has to place her child in a safe haven drop-off point.
- Create transparency for foster parents regarding their rights and responsibilities.

While Blue states – along with the White House – veto, block, and rescind vital resources for women and their babies, Red states are moving forward with impressive speed to create a safety net in the wake of *Roe's* demise.

## Abortion Centers Post-*Dobbs* Court Decision by Bradley Mattes

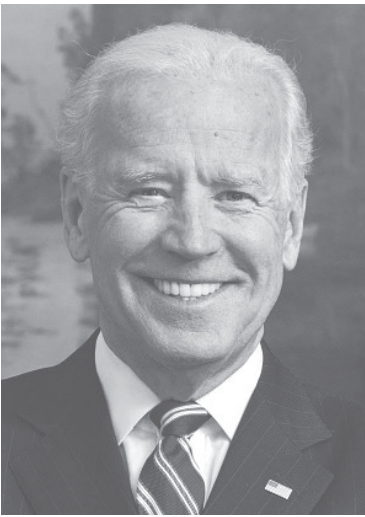
**A**s expected, many abortion facilities have closed since the *Dobbs* decision. Let's take a closer look at how *Dobbs* has impacted the abortion industry. Keeping track of abortion center closings is like picking up Jell-O with your hands. The numbers change almost weekly.

Hardest hit has been the independent abortion centers known as "indies." Many were located in red states, where abortion has been totally or near totally ended. Further, they lack the name recognition, federal tax funding, or fundraising firepower of Planned Parenthood to keep their doors open.

In addition, the indies are more likely to offer late-term abortions – those after the first trimester – which is a more complicated and expensive way to kill the unborn. Also, it has a higher rate of complications and vulnerability to lawsuits. In other words, their overhead can be significantly higher than the neighboring Planned Parenthood that only offers chemical abortion pills.

According to the Abortion Care Network, the rate of indies closing in the months after the *Dobbs* decision was more than

# THE PRESIDENTIAL RECORD ON LIFE

## President Joseph R. Biden 2021-present

*"I believe Roe v. Wade was the correct decision as a matter of constitutional law, an application of the fundamental right to privacy and liberty in matters of family and personal autonomy... The only way we can secure a woman's right to choose and the balance that existed is for Congress to restore the protections of Roe v. Wade as federal law."*

■ **Mexico City Policy:** In one of his first acts in office, President Biden repealed the Trump-Era "Protecting Life in Global Health Assistance" or "Mexico City Policy," which prevents tax funds from being given to organizations that perform abortions or lobby to change the abortion laws of host countries.

■ **Promoting Abortion-on-Demand Until Birth:** President Biden strongly supports the radical so-called Women's Health Protection Act. This legislation would essentially remove all legal protections for unborn children on the federal and state level and prevent future protections for unborn children.

■ **Chemical Abortion:** President Biden's Food and Drug Administration (FDA) suspended protections established for women undergoing chemical abortions, such as seeing the abortionist in person. The in-person requirement ensured that complications, such as an ectopic pregnancy, are ruled out in advance of a woman undergoing a chemical abortion. Mifepristone, the "abortion pill," has no effect on an ectopic pregnancy and leaves the woman with this life-threatening medical condition. The FDA will also permit pharmacists to dispense chemical abortion drugs, and will permit these dangerous drugs to be sent through the mail.

■ **Funding Abortion Providers:** In April 2021, President Biden's Health and Human Services Department overturned the Trump Administration's "Protect Life Rule" on Title X family planning funding. The new Biden Rule means that millions in Title X funding will flow to facilities that perform or refer for abortions.

■ **Fetal Tissue Research:** Under President Biden, the National Institutes of Health reversed Trump Administration regulations and announced that it will again fund intramural research and will no longer convene the Human Fetal Tissue Research Ethics Advisory Board for extramural research.

■ **Abortion Funding:** Though he long supported the Hyde Amendment in the past, as a presidential candidate, President Biden changed his position in 2019. President Biden is now on record in support of eliminating the Hyde Amendment which prevents the use of federal funds to pay for abortions except in cases of rape, incest or to save the life of the mother. By Executive Order, President Biden directed his administration to consider actions to advance access to abortion, including an effort to encourage states to apply for Medicaid waivers to pay for abortion travel.

■ **Abortion Funding in the Military:** Biden's Department of Veterans Affairs has announced they will pay for and provide abortions for "health reasons," defined broadly as to be for any reason. This has been statutorily prohibited since 1992. Under the Biden Administration, the Department of Defense announced it will pay the travel and transportation costs for military members and dependents to travel to obtain elective abortions.

■ **Appointments:** President Biden has surrounded himself with stalwart pro-abortion public officials, including Vice President Kamala Harris. His cabinet appointments include pro-abortion former congressman and former California Attorney General Xavier Becerra to head Health & Human Services, pro-abortion activist Samantha Power to head the U.S. Agency for International Development and Chiquita Brooks-LaSure, who consulted for Planned Parenthood during the 2020 elections, to lead the Centers for Medicare and Medicaid Services.

■ **Supreme Court:** President Biden promised to only appoint justices who support a right to abortion, nominating Ketanji Brown Jackson to serve on the Supreme Court. Her nomination was strongly backed by Planned Parenthood, NARAL, and other abortion groups.

double the closures during the year before. That is not surprising. What may be, however, is the tenacity of the former killing centers as they frantically pivot to stay open.

Thirty days after the *Dobbs* decision, Guttmacher Institute – originally founded as the research arm of Planned Parenthood – reported that seven states had ended all abortions and that 43 abortion centers in 11 states stopped committing abortions. Some were providing alternate services, others planned to move to states permitting abortion, and still others closed permanently.

Guttmacher then took a detailed look at the abortion landscape 100 days post-*Dobbs*. At that point, 66 abortion facilities in 15 states stopped killing the unborn.

**It didn't take long for this financial reality to catch up with the bottom line.**

Of the 66 centers, 40 continued to offer non-abortion services. These include hormonal treatment for the purpose of sexually transitioning, birth control, and STD testing and treatment. However, none can match the lucrative income generated by abortion and as a result, 26 facilities closed and others were in danger of doing so.



**Planned Parenthood's notorious claim that abortion was only 3% of their services proved to be propaganda. It is doing considerable juggling to maintain financial viability in a post-*Dobbs* environment.**

Shortly after announcing significant layoffs at the national office, the abortion giant is closing and/or consolidating outlets. Earlier this month Planned Parenthood “temporarily” closed its Logan, Utah abortion center with no explanation.

After 50 years in operation, their abortion affiliate in Steamboat Springs, CO abruptly closed its doors, even catching the staff unaware. The Alamosa, CO center had been closed for several months.

In Iowa they are closing three of their nine centers, impacting Cedar Falls, Council bluffs, and southern Des Moines. Sarah Traxler, chief medical officer for Planned Parenthood, said that since *Roe's* demise, they've experienced a 13% decrease in abortions in the state, which she attributes to a 24-hour waiting period.

Another reason for the closures, Traxler said, is the stigma toward the abortion giant affecting their recruitment and reten-

tion of staff. Simply put, people are not inclined to work at an abortion facility, and if they do, they aren't there very long.

## On the Move

The lucrative abortion industry generates income that makes it difficult to just close its doors. It is motivating abortion centers to move from states that protect their unborn children to those that do not. “I'm just not ready to walk away,” said Kathaleen Pittman of a Shreveport abortion center. Louisiana's three abortion centers in New Orleans, Baton Rouge, and Shreveport will relocate, but declined to offer information on where they are going.

A Memphis, TN center is relocating to Carbondale, Illinois. The remaining abortion center in Mississippi is moving to Las Cruces, New Mexico. The only North Dakota abortion facility has moved a short distance over the state line to Moorhead, Minnesota. Whole Women's Health is fundraising to move its center to New Mexico. An abortionist moved his San Antonio, TX facility to Albuquerque, New Mexico. His daughter moved her abortion center from Tulsa, OK to Carbondale, Illinois.

## Parking Lot Abortions

An Illinois Planned Parenthood has stolen a page from the gamebook of pro-life pregnancy centers. It's taken delivery of an RV but instead plans to offer chemical and some surgical abortions wherever they park.
