Supreme Court Overturns Roe v. Wade: “Constitution Does Not Confer Right to Abortion” January 22, 1973 to June 24, 2022

After nearly 50 years of abortion in the United States, the U.S. Supreme Court has ruled 6-3 to reverse that decision.

For nearly 50 years, pro-life advocates have worked tirelessly to overturn the Supreme Court’s 1973 decision in Roe v. Wade. Now, with its decision in Dobbs v. Jackson Women’s Health Organization, the Supreme Court has overturned Roe and its related 1992 ruling in Planned Parenthood v. Casey. This is one of the most significant advances in legal protection for the unborn in American history, and pro-life advocates are celebrating while preparing to continue the fight.

The Supreme Court has overturned Roe v. Wade, with a 5-4 majority ruling in the Dobbs case that “The Constitution does not confer a right to abortion.” “We hold that Roe and Casey must be overruled. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion. Roe and Casey arrogated that authority. We now overrule those decisions and return that authority to the people and their elected representatives,” Justice Samuel Alito wrote for the majority.

“The Constitution makes no reference to abortion, and no such right is implicitly protected by any constitutional provision, including the one on which the defenders of Roe and Casey now chiefly



rely—the Due Process Clause of the Fourteenth Amendment,” Justice Samuel Alito wrote in the majority opinion. “That provision has been held to guarantee some rights that are not mentioned in the

Constitution, but any such right must be ‘deeply rooted in this Nation’s history and tradition’ and ‘implicit in the concept of ordered liberty.’”

Justices ruled to uphold Dobbs 6-3, with Chief Justice John Roberts affirming the 15-week ban but not voting to overturn Roe, which limits abortion to 15-weeks in Mississippi, effectively overturning Roe v. Wade and returning abortion law to the states. “Abortion presents a profound moral question. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion. Roe and Casey arrogated that authority. We now overrule those decisions and return that authority to the people and their elected representatives,” Alito wrote.

“Roe was egregiously wrong from the start. Its reasoning was exceptionally weak, and the decision has had damaging consequences,” Alito wrote. “And far from bringing about a national settlement of the abortion issue, Roe and Casey have enflamed debate and deepened division.”

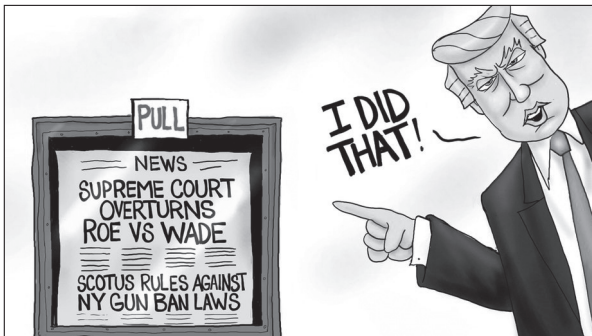
This is a landmark day for the Pro-Life movement and our entire nation. After staining the moral fabric of our coun-

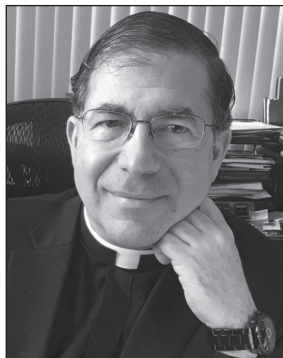
This day has been a long time coming, and we pray we can build on this. With God's help we will do what we can to protect the unborn.

What Pro-Abortion Forces and Democrats are saying About Pro-Life People!

Here are a few of their wild responses and what pro-life people are doing below:

Pro-life people don't care about women.

Response: If they do not care about women and their babies, why has the pro-life movement created and staffed nearly 3000 pregnancy care centers throughout the United States? This has been a huge cost to Right to Life/pro-life groups, but it has proven to be very successful. The pro-abortion politicians have created road blocks for the pregnancy care centers and have done everything they can to discredit, harass and make the operation of pregnancy care centers as difficult as possible, making it hard for them to remain open. However, their tactics have failed, and more have continued to be opened. In fact it is the abortion clinics that have been closing at a rapid rate because they are hard pressed to get qualified doctors and nurses to staff them. Many doctors do not want to perform abortions because of the stigma, and the clinics have been forced to get less qualified help. In spite of the roadblocks placed in the pathway of pregnancy care centers, they continue to flourish.

Women by the thousands will die in back alley abortions.

Response: THIS IS NOT TRUE! When the pro-abortion forces were pushing for abortion to be legalized in the United States prior to 1973, the leader of that movement, Dr. Bernard Nathanson, made a wild statement at a press conference that 10,000 women died each year from back alley abortions. That number was totally false, and he knew it; but he fed it to the liberal press, who were also pushing for abortion to be legalized, and the press ran with it. All the press picked it up and used it time and time again, never once checking the facts. Dr. Nathanson, who was an abortionist himself, later saw the evil of his ways and converted to pro-life; he also converted to the Catholic Church and tried to set the record straight with the media; but they would hear nothing of it. What they had written fitted their pro-abortion agenda, and they were not going to change it. The lie has continued to this day.

So many times we hear the pro-abortion forces push the unfounded statement that pro-life people don't care about babies already born, just those to be born. All across the country pregnancy care centers have sprung up and continue to help mothers with an unplanned or unexpected pregnancy. It is estimated there are around 3000 pregnancy care centers in the United States, and there are several very nice facilities here in our area.

We start with First Choice Solutions here in our area, which is located at 714 W. Walnut Street in Washington, Indiana. It was formerly known as the Washington Pregnancy Care Center but changed their name (to First Choice Solutions) a couple years ago and has moved from the location at the Grace Baptist Church to the very up-to-date building at the west end of Washington. They bought the building and totally refurbished it from top to bottom with new electrical/heating and air conditioning, and it looks like a new building on the inside. They offer counseling, pregnancy tests, ultrasound, many clothes and baby items

for young mothers, and just anything that an expectant mother would need. They continue to increase the number of clients they see each month, and for many it is a life-changing time.

There are other pregnancy care centers in our area: In Vincennes there is Heart to Heart and in Bedford there is Hope Resource Center. In Linton there is Pregnancy Choices for Mothers with Unplanned Pregnancies. In our area there are many resources available to young mothers such as St. Vincent DePaul Societies in Washington and in Loogootee. First Choice Solutions here in Washington (formerly the Washington Pregnancy Care Center) was started by Right to Life organizations here in Daviess County. Many of the pregnancy care centers were started by Right to Life organizations or people who belong to both organizations.

So when you hear some pro-abortion person making the statement that Right to Life people don't care about pregnant mothers, now you know that there are many organizations that have been started to help pregnant mothers in the time of need. In Daviess and surrounding counties there are several churches and organizations that work tirelessly to help pregnant mothers in need, and this does not include other churches and organizations who are doing the same work on a smaller scale.

So when you hear pro-abortion people spout this propaganda, they are only doing this to try to justify their own pro-abortion mentality. It is similar to those individuals who try to justify voting for pro-abortion candidates by saying abortion is only one issue and there are other issues as important as abortion.

try for nearly 50 years, *Roe v. Wade* is no more. Leading pro-life groups hailed the decision, including Kim Schwartz of Texas Right to Life. "After nearly 50 years, *Roe* has been responsible for the deaths of over 60 million preborn American children. Today, the Supreme Court has finally overturned the grievous error of *Roe v. Wade* that has cost so many precious lives," she told LifeNews. "Now, the abortion question will return to the states, authorizing state governments to set their own laws without being suffocated by federal courts."

Justices Sonia Sotomayor, Elena Kagan and Stephen Breyer authored a joint dissent condemning the decision as enabling states to enact "draconian" restrictions on women. "Perhaps, in the wake of today's decision, a state law will criminalize the woman's conduct too, incarcerating or fining her for daring to seek or obtain an abortion," the justices wrote. "And as Texas has recently shown, a State can turn neighbor against neighbor, enlisting fellow citizens in the effort to root out anyone who tries to get an abortion, or to assist another in doing so."

Primary Elections Winners, Who is Running in the Fall Election

In the race for U.S. Senate in Indiana, incumbent Todd Young will face Democratic challenger Thomas M. McDermott, Jr. In the 8th District congressional race, the incumbent Congressman Larry Buchson was unopposed in the primary and will face Democrat Ray McCormick in the fall election.

In the race for State Representative in District 45, Republican incumbent Bruce Borders won the primary election over fellow Republican State Representative Jeff Ellington who moved from District 62 to challenge Borders. In State Representative District 62, on the Republican side, Dave Hall won his

race and will face Democrat Penny Githens for the open seat left by Jeff Ellington moving to District 45.

Several races were unchallenged in the primary: In State Senate District 39 Eric Bassler and State Senate District 48 Mark Messmer are both unopposed. In State Representative 63 incumbent Republican Shane Lindauer is being challenged again by Democrat Teresa Kendall, and in House District 64 Matt Hostettler is unopposed at this time. The Democrat Party has until August to fill the position on the ballot where they do not have a candidate.

Indiana Attorney General Todd Rokita Asks Courts to Lift Injunctions Against Several Indiana Abortion Laws Following Dobbs Decision (Reversal of Roe V Wade)

Not wasting any time, Attorney General Todd Rokita and his team took new actions June 27 to protect women and unborn children following the U.S. Supreme Court's historic decision in *Dobbs v. Jackson Women's Health Organization*.

"Like most Hoosiers, I believe in building a culture of life in Indiana," Attorney General Rokita said. "That means protecting the lives of unborn babies and safeguarding the physical, mental and emotional well-being of their mothers. I'll do everything in my power to advance this mission."

This week, AG Rokita asked courts to lift injunctions against several Indiana abortion laws following the Supreme Court's overturning of the *Roe v. Wade* and *Planned Parenthood v. Casey* rulings. The rejection of those woefully misguided precedents means states now have much greater authority to enact and enforce laws regarding abortion.

The Indiana laws for which Attorney General Rokita is asking courts to lift injunctions include:

- a ban on discriminatory abortions sought specifically

because of the unborn child's race, sex, or disability

- a ban on dismemberment abortions, in which living unborn children are dismembered piece by piece
- a requirement that parents be notified when a court approves an abortion for a minor child without parental consent (barring extenuating circumstances such as reason to believe such notification could endanger the child)

In addition, Attorney General Rokita already has obtained a court-filed stipulation that halts expansion plans by abortion providers Whole Woman's Health Alliance and Planned Parenthood in the cities of South Bend and Evansville, respectively.

"Indiana has a long history of defending life," Attorney General Rokita said, "and the Supreme Court has recognized these contributions. Indeed, the Dobbs decision expressly cited multiple Indiana cases — such as our battles to outlaw discriminatory abortion and require respectful disposition of the bodies of aborted babies."

The Dobbs decision also cited Indiana's work to defend parental notice and sustain an informed-consent waiting period, among other issues.

President Donald Trump told thousands of conservatives at a rally Saturday night in Illinois that the Supreme Court's decision to overturn *Roe v. Wade* is "the answer to the prayers of millions and millions of people."

Here's what the former president told the crowd: "So before we begin, we've got some very big news. Don't we? We have very big news. Maybe the biggest, right from the United States Supreme Court."

"Yesterday the Court handed down a victory for the Constitution, a victory for the rule of law, and above all, a victory for life. This breakthrough is the answer to the prayers of millions and millions of people. And these prayers have gone on for decades and decades. They've been praying, and now those prayers have been answered."

"To the generations of Americans in the pro-life movement, as well as countless constitutional conservatives, your boundless love, sacrifice, and devotion has finally been rewarded in full. Congratulations," Trump said.

Trump recalled his promises to nominate conservative justices who didn't make things up on the bench.

"As the candidate in 2016, You remember that? —I promised to nominate judges and justices who would stand up for



the original meaning of the Constitution and who would honestly and faithfully interpret the law as written. We got almost 300 federal judges, and three great Supreme Court justices confirmed to do exactly that," he said.

"And thanks to the courage found within the United States Supreme Court, this long divisive issue will be decided by the states and by the American people," Trump said. "That's the way it should have been many, many, years ago and

that's the way it is now. So congratulations."

"We believe that every precious child born and unborn is the sacred gift from God," Trump said.

Several states have already banned abortions following the Supreme Court decision to overturn *Roe v. Wade*.

As LifeNews reported, the Supreme Court has overturned *Roe v. Wade*, with a 6-3 majority ruling in the Dobbs case that "The Constitution does not confer a right to abortion" — allowing states to ban abortions and protect unborn babies. The high court also ruled 6-3 to uphold the Mississippi 15-week abortion ban so states can further limit abortions and to get rid of the false viability standard. Chief Justice John Roberts technically voted for the judgment but, in his **//continued on PAGE 7**

14 Recent Polls Show Americans are Pro-Life on Abortion

Here is one of the many false statements made by pro-abortion forces pushing their cause: “70 percent of Americans support a woman’s right to choose.” It’s a false stat that has been debunked for years, but that hasn’t stopped the liberal media, Democrat politicians, and abortion activists from repeating the lie. So what do Americans really think about abortion?

The answer is simple. For decades, a majority of Americans have taken a pro-life position, wanting all or most abortions to be made illegal. In the 1990s, polling data showed approximately 55% of Americans opposed all or most abortions. Yes, Americans support exceptions — such as abortion in cases of rape or incest or when the life of the mother is in danger. But those cases constitute less than 2% of all abortions, as 98% of abortions are cases when abortion is used as birth control.

Since that time, little has changed as poll after poll after poll has found anywhere from 50-60% of Americans still want all or most abortions made illegal.

Below is a list of several major polls in recent years confirming this to be true. (From May 2022 back to June of 2019)

May 2022: A Rasmussen/RMG Research poll shows 65% of Americans essentially want Roe overturned.

May 2022: A new Trafalgar Group poll shows 57.6% of Americans believe all abortions should be banned or banned when an unborn baby’s heartbeat can be detected.

May 2022: A new Rasmussen poll shows more Americans want Roe v. Wade overturned than want to keep the infamous Supreme Court decision in place that allows abortions up to birth.

May 2022: A Fox News poll found Americans are pro-life on a 54-44% margin and majorities want abortions banned after either 6 weeks or 15 weeks.

January 2022: A Marist poll found 71% of Americans want abortions to be made illegal or for more limits to be placed on them, all essentially supporting overturning Roe.

September 2021: A new Rasmussen poll shows Americans support the Texas abortion ban to save babies from abortion by a 46-43% margin.

June 2021: Gallup found 52% of Americans take a pro-life position on abortion wanting all (19%) or almost all (33%) abortions made illegal.

January 2021: A Marist Poll found 51% of Americans take a pro-life position with 12% of Americans saying abortion should never be permitted under any circumstance, 11% of Americans say abortions should only be permitted to save the life of the mother and 28% of Americans take a pro-life position opposing 98% of abortions except in cases of rape or incest or if necessary to save the life of the mother.

June 2020: A CBS poll found just 43% of Americans think abortions should be generally available while 55% of Americans say it should either be more limited or should not be permitted altogether.

June 2019: A Morning Consult poll found 61% of Americans want all or almost all abortions made illegal.

concurring opinion, disagreed with the reasoning and said he wanted to keep abortions legal but with a new standard.

Texas and Oklahoma had banned abortions before Roe was overturned and Missouri became the first state after Roe to protect babies from abortions and South Dakota became the 2nd. Then Arkansas became the third state protecting babies from abortions and Kentucky became the 4th and Louisiana became the 5th and Ohio became the 6th and Utah became the 7th and Oklahoma became the 8th and Alabama became the 9th. Today, Mississippi became the 10th.

Ultimately, as many as 26 states could immediately or quickly ban abortions and protect babies from certain death for the first time in nearly 50 years. The 13 total states with trigger laws that would effectively ban all or most abortions are: Arkansas, Idaho, Kentucky, Louisiana, Missouri, Mississippi, North Dakota, Oklahoma, South Dakota, Tennessee, Texas, Utah and Wyoming.

“Abortion presents a profound moral question. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion. Roe and Casey arrogated that authority. We now overrule those decisions and return that authority to the people and their elected representatives,” Alito wrote. “Roe was egregiously wrong from the start. Its reasoning was exceptionally weak, and the decision has had damaging consequences,” Alito wrote. “And far from bringing about a national settlement of the abortion issue, Roe and Casey have enflamed debate and deepened division.”

This is a landmark day for the pro-life movement and our entire nation. After staining the moral fabric of our country for nearly 50 years, *Roe v. Wade* is no more. Justices Sonia Sotomayor, Elena Kagan and Stephen Breyer authored a joint dissent condemning the decision as enabling states to enact “draconian” restrictions on women.
