# Trump Slams Democrats for Supporting Abortions Up to Birth and Infanticide: "They Execute the Baby"

Recently, Donald trump slammed Democrats for their extremist position supporting abortions up to birth and even allowing infanticide by voting against measures to protect babies who survive abortions. "If it's after the 9th month and the baby was born you put the baby aside. You discuss with the mother and if the mother doesn't want the baby we execute the baby. This is part of their thing," he said during a rally.



Recently, Trump promised to support "political prisoners" if he's elected president. This is an important pledge prolife Americans will appreciate given how Joe Biden has put pro-life advocates in prison for rescuing babies from abortion. Trump announced that if elected in 2024, he will create a special task force specifically designed to review cases of Biden's "political prisoners."

During the Family Research Council's "Pray, Vote, Stand Summit" in Washington, D.C., Trump vowed to get innocent Americans out of jail for standing up for their beliefs while criminals run rampant. "I am announcing that the moment I win the election, I will appoint a special task force to rapidly review the cases of every political prisoner who has been unjustly persecuted by the Biden administration," Trump said.

Trump referenced the convictions of pro-life advocates who now face as many as 11 years in prison for rescuing babies from abortions at a late-term abortion business in Washington D.C. "If we stand together in this fight, we're going to defeat Crooked Joe Biden; if he runs — will he make it to the starting gate?" Trump said.

Recently, three more pro-life advocates were found guilty of violating a federal law protecting abortion centers and now face the possibility of 11 years in prison.

# **Baby Box Dedicated at West End Fire Station**

This effort to see this to completion was a combined effort with the Daviess County Hospital and Daviess County RTL and others.



This process took several years to complete but in the end it will be worth it. Monica Kelsey who is head of the Safe Haven Baby Box Network said there is around 120 baby Boxes in Indiana and dozens more in the works. The first baby box was installed in 2016 in Woodburn Indiana. Most of the electronically monitored, temperature-controlled boxes are installed on the sides of fire stations. Most are also funded through private church donations. A recent surge in surrenders this year includes three babies at a Carmel station near Indianapolis. "I'll tell you I stand on the frontlines of this movement ensuring that every mother has a safe option to place her newborn in the arms of a fire fighter," Kelsey said. This Baby Box dedication took place on Sept. 6 at the West End Fire Station. The Mayor of Washington Dave Rhoades was also present for this special dedication. Several members of the Community were also present for this special dedication ceremony.



## **Pregnancy Centers Face a New Challenge**

Pro-life pregnancy care centers are so successful in fact that it is estimated they have saved some two million babies and provided \$266 million worth of free services to women in need.

Because of this, they have become a primary target of radical abortion supporters. Pro-choice advocates are attempting to prevent these centers from providing potentially lifesaving care.

The state of Colorado has passed the first of its kind legislation preventing pregnancy centers from providing abortion pill reversal services. These services are provided to women who take the first pill in the chemical abortion regimen and then have a change of heart. Rather than taking the second drug they can take progesterone to reverse the effects of the abortion pill.

This has proven successful in up to 68% of cases and has saved thousands of unborn babies. Progesterone has been around since the 1950s and has long been used to combat miscarriage. Fighting back, the Bella Health and Wellness healthcare center is suing the state of Colorado, seeking to prevent enforcement of the law.

Unfortunately, Colorado is not alone in their efforts to force

women to go through with an abortion decision that they regret. The state of California, notorious for its pro-abortion policies, has sued pregnancy centers in an effort to stop them from saving babies.

Most recently, the state Attorney General Rob Bonta is targeting two organizations, Heartbeat International and Real Options Obria Medical Clinics, both of which provide abortion pill reversal services. The state claims that the clinics are issuing "fraudulent and misleading claims" about what he describes as an "experimental procedure."

This is patently false. The pregnancy centers under attack make no guarantee that the treatment will be successful. They simply give women who have changed their mind another option, a chance to choose life.

Pro-abortion advocates often claim that they want women to have a choice, yet now they strip away a mother's choice to change her mind. There is no reason to prevent these women from attempting to reverse the effects of the abortion pill.

We must stand firm in our defense of these pregnancy centers who are on the frontlines in the battle for life.

## Political Persecution in America by Bradley Mattes

We are witnessing political persecution in Washington, DC of those brave enough to speak the truth. Peaceful pro-lifers are facing the potential of 11 years in prison, in part because they exposed illegal activities taking place under the noses of DC officials.

In the face of overwhelming evidence, instead of seeking justice, the angered officials launched an investigation against the messenger. And a biased judge piled on in a court of law.

Lauren Handy and other pro-lifers were a peaceful presence outside Washington Surgi-Clinic, a late-term abortion facility in Washington, DC run by notorious abortionist Cesare Santangelo. As they stood there a young man began loading large boxes onto a truck so they asked if they could have one. To their surprise he said yes.

What they later found inside horrified them. Included with the many bodies were five babies killed by brutal late-term abortions. Their corpses showed the undeniable evidence that they were killed by partial-birth abortion, a horrific procedure that kills a baby during delivery. Viewed as such a heinous act, it was banned by federal legislation.

The pro-lifers photographed the bodies and turned them over to police. Santangelo, nicknamed "The Butcher of DC," had been caught on undercover video stating he would allow any aborted baby born alive to die. Further, he was accused of selling the remains of the babies he killed to an energy company.

After the revelation of the five babies, there was no inquiry by DC officials into the abortionist or his abortion center. Instead, they launched an investigation suggesting Lauren altered the babies' bodies to give the appearance Santangelo violated federal law in the process of killing them.

The persecution didn't end there. Charges were filed against Lauren and other pro-lifers for peacefully staging a sit-in at the notorious abortion center. They were accused of violating the Freedom of Access to Clinic Entrances (FACE) Act.

During the trial Lauren and her fellow defendants wanted to show the jury why they were at the center by displaying images of the five aborted babies.

Judge Colleen Kollar-Kotelly demonstrated her heavy-handed pro-abortion bias by denying the jury the opportunity to see the images. Judge Kollar-Kotelly admitted the abortions were "undoubtedly unlawful under state and federal law" but decreed the pictures were "incendiary" and not "relevant to this case." The peaceful pro-lifers were convicted and face a possible sentence of 11 years in prison.

This, said US Senator Ted Cruz (R-TX), is an example of weaponizing major branches of the government against its political foes. "At least 88 crisis pregnancy centers have been firebombed, vandalized, or set ablaze in the wake of the *Dobbs* Decision," Cruz said. He further labeled the Department of Justice's (DOJ) response to this violence as "anemic," noting that combined, the DOJ and FBI have prosecuted only "one FACE Act case against these criminals."

Senator Cruz accused the DOJ of "aggressively targeting Handy since she and others blew the whistle on [abortionist Santangelo]...who was engaging in illegal, late-term abortions."

Our nation is beginning to take on the appearance of dictatorial third-world countries that create a class of political prisoners who dare challenge the powers that be.

### **Abortion is Child Sacrifice**

When the curtain is pulled back and the façade is thrown off, we see the truth. Abortion is murder.

For years the abortion lobby spent millions of dollars attempting to mislead the public. To convince women that the precious baby growing inside of them was not human, but just a clump of cells. # Pro-Life Advocate Defeats Pro-Abortion Mob's Attempt to Put Him in Prison

It's the stuff of late-night television nightmares: peaceful husband and wife visit the Indiana Statehouse, find a loud pandemonium raised by abortion extremists, and days later their world is turned upside down with a wrongful felony assault charge. It happened to Indianapolis resident Nathan Perry—who has now been vindicated and declared not guilty by a Marion Superior Court judge on September 29, 2023, after successful defense by the Thomas More Society.

In July 2022, Perry—a teacher and church music director—and his wife—a Christian counselor—went to the Indiana Statehouse on the first day of the state legislature's special session, when an abortion ban was being considered. The Perrys consider themselves to be quietly pro-life. They have been long time supporters of Indianapolis pregnancy help ministries and Perry's wife started her counseling career at a Christian pregnancy care center.

"Nathan Perry and his wife had gone to the Statehouse in Indianapolis to exercise their rights as citizens and hear what the elected officials had to say about the abortion issue," explained Perrys' attorney, Carlos Lam, serving as Thomas More Society Special Counsel.

"We were shocked—we had gone to the Statehouse at Indianapolis not knowing this was happening," said Perry. "There we found a mad riot, complete chaos."

In the crowd of more than a thousand people, the Perrys found themselves close to a band performing Christian music, as many of those present queued to enter the building. According to reports, a raucous and vociferous contingent chanted their demands for abortion.

Lam related how one young woman blasted a bullhorn near Perry's head, causing him to react and push out to protect himself—which knocked the bullhorn back toward the woman. As the young woman moved back, Perry was then targeted by the woman with her profanities. Following the incident, the Perrys left the scene while the mob hollered for the police. An older woman then chased the Perrys down the street in an attempt to escalate the situation.

Indiana State Police on site did not react, intervene, or see any cause for concern. Later that day, the Perrys returned home without further incident.

Days later, Perry became aware that something was not right when coworkers on the ministry staff at Christ Evangelical Lutheran in Brownsburg, Indiana, brought to his attention an array of strange social media posts. Tweets and other social media posts targeted Perry, whom the perpetrators had apparently identified with a smartphone video and artificial intelligence tools.

The harassment campaign against Perry was relentless. After Perry and his wife were identified, they were stalked online and targeted—along with their church and employers. "It was a horrific concerted pro-abortion effort to ruin our lives and make an example of us because we did not embrace the pro-abortion message," explained Perry. "This was a mob trying to find someone they could take down and mess with their life."

"As crazy people from all over the country attacked me, I learned what doxing meant," said Perry, detailing how the tormenters had located and published identifying information about him and his wife. He reported that her Christian counseling service began receiving malicious emails and phone calls, and that their church had to shut down its social media.

Perry learned about the charges against him when his employers at a prestigious private school called him into the office at the end of the day and informed him that he could not keep teaching because the Indianapolis Metropolitan Police Department had a warrant out for Perry, for felony battery.

While swift work by Lam got the warrant recalled and saved Perry from actual physical arrest or having to spend time in jail, he suffered serious consequences.

"My reputation in the industry has been damaged, for two years I been unable to teach, not held a full-time job or benefits, and my parents' health has suffered," shared Perry, "All because these extremists had a goal to disrupt my life as an example, so no one will ever oppose their viewpoint."

"I learned way more than I wanted to in the process," admitted Perry, "This has been a steep hill to climb. I am so thankful for the support of the Thomas More Society along this spiritual journey. We are starting over, but our faith has grown, and God has brought us through this journey."

On September 29, 2023, Magistrate Ronnie Huerta declared Perry not guilty of the felony charge, Battery Resulting in Moderate Bodily Injury, after a Marion Superior Court bench trial.
