Daviess/Pike/Martin Right to Life Banquet Speaker Announced for October 3, 2024

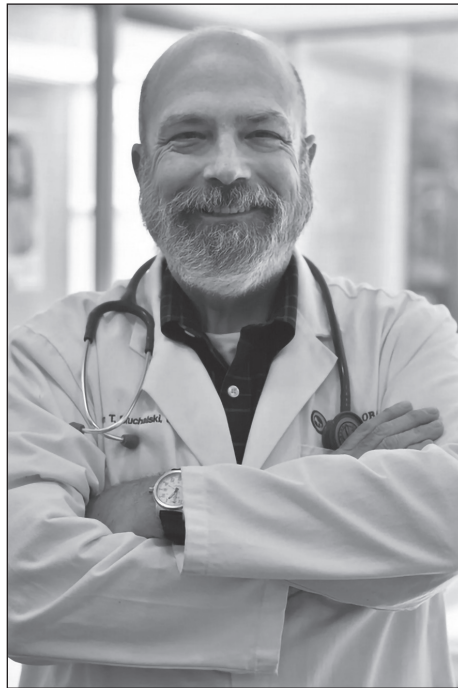

The date and speaker for the annual Right to Life Banquet has been announced and it is Dr. John Bruchalski (former abortionist) who is well known throughout Northern Virginia and much of the United States as a pro-life doctor. His medical practice, Tepeyac OB/GYN, operates as the largest fully pro-life OB/GYN in the nation, with five providers and a midwife.

Dr. Bruchalski grew up in a devout Catholic home but he believed what he was doing for women was best for them. He believed birth control, abortion, and sexual liberation were necessary for women to flourish. After receiving his M.D. degree in 1987, he returned to Virginia for his residency in obstetrics and gynecology at the Eastern Virginia Medical Center.

Dr. Bruchalski's conversion from abortionist to pro-life doctor began as he witnessed the effects of abortion all around him. Far from achieving joy or happiness, the women he aborted or equipped with contraceptives displayed only "more broken relationships, more infections, more destruction, more brokenness."

Dr. Bruchalski's conversion began as he witnessed a late term abortion, his

visit to the shrine of Our Lady of Guadalupe, patroness of the unborn, in Mexico City. While there he heard the clear voice of a woman ask him, "Why are you hurting me?" But still hard of heart, he concluded that his perceptions had been affected by the heat. Two days later, to his

shock, his mother phoned and suggested he accompany her on a trip to a shrine in Medjugorje.

While traveling there, a Belgian visionary told the doctor she had a message from Our Lady for him: he was to be the best doctor he could be; to follow and promote the teachings of the Church; and to serve the poor daily. As he told in an exclusive interview, "the scales fell from my eyes" and it all made sense: the evils of contraception, abortion, and artificial reproduction; the truth of natural law and Church teaching; the love of Jesus Christ. The course of his future was forever altered. This was a major conversion for Dr. Bruchalski. After he returned from Medjugorje, Dr. Bruchalski told his hospital he could no longer perform abortions, prescribe contraceptives, or deal in artificial reproduction. More and more of his fellow residents followed his lead and ceased performing abortions.

After residency and two years of work in a Maryland practice, he felt strongly called to establish a practice of his own design. His journey from an abortionist to a pro-life doctor led him to open Family Health Center, caring for insured and uninsured women alike.

We have to make the most of every day for the people and country we love,” he continued. “Every single moment we have on Earth is a gift from God,” Trump reflected. “I stand before you in this arena only by the grace of Almighty God.”



“I survived because I had God on my side,” he said further. He cited the Bible or credited God with his life multiple times and led a moment of silence for Corey Comperatore, the fire chief who lost his life in the assassination attempt. “Greater love has no one than this, that someone lay down his life for his friend,” Trump said, quoting a Bible verse. “This is what we need. Despite such a heinous attack, we unite this evening, more determined than ever. Our resolve is unbroken and our purpose is unchanged, to deliver a government

that serves the American people better than ever before,” the former president said.

When it comes to pro-life themes, Trump said the Justice Department should stop weaponizing our legal system. That is especially important for the pro-life Americans who Biden put in prison for protesting abortion.

“We are Americans. Ambition is our heritage. Greatness is our birthright,” Trump said in conclusion. “But as long as our energies are spent fighting each other, our destiny will remain out of reach. We must instead take that energy and use it to realize our country’s true potential — and write our own thrilling chapter of the American Story.

“Tonight, I ask for your partnership, for your support, and I am humbly asking for your vote. Every day, I will strive to honor the trust you have placed in me, and I will never let you down.”

Here's Something the Media Won't Tell You: Pro-Abortion Candidates are Losing

After the demise of *Roe*, abortion advocates channeled Chicken Little, claiming the sky would fall on pro-life candidates because outraged voters will elect their pro-abortion opponents.

Pro-Abortion Candidates are Losing

The media touted a State Supreme Court race in Georgia as a bellwether of races to come. Former pro-abortion Democrat Congressman John Barrow ran against incumbent Justice Andrew Pinson because as solicitor general he successfully defended the Heartbeat law.

Barrow centered his *entire campaign* on abortion. Planned Parenthood and other pro-abortion lobby groups endorsed him. Barrow lost by ten percentage points.

During West Virginia's primary, eighty-seven percent of the candidates endorsed by a pro-life political action committee won. The balance of the State Supreme Court moved from a bare margin in favor of life to four to one support for life. Wanda Fraz, president of the PAC said voters support candidates who reflect their values regarding the dignity of human life. She's right.

Similar victories resulted in South Carolina's primary. Three state senators who shared extreme stands on abortion were defeated by pro-life male challengers, one winning with over 80% of the vote. The pro-abortion incumbents lost in spite of an infusion of over \$350,000 on their behalf.

Legacy Media On Notice

CNN reporter Harry Enten said he is "speechless." What ruffled his feathers? Multiple polls show Donald Trump is getting more support from Black Americans, especially young Black voters. Biden's support from these young voters is cratering. Enten said, "I've just never seen anything like this. I'm like speechless. I keep looking for signs that this is going to go back to normal and I don't see it yet in the polling." He added, "We're careening towards historic performance for a Republican presidential candidate, the likes of which we have not seen in six decades."

Advocates of abortion have warned that pro-life candidates would lose due to the wrath of women voters after the demise of *Roe*. The New York Times, a leading pro-abortion advocate, now understands this is merely political hyperbole. It analyzed over 30 polls that when averaged, showed Joe Biden's lead with women is down by about 13% from four years earlier. The Times reported that this erosion of support "has been particularly pronounced among Black and Hispanic women." According to a Harvard-Harris poll, 75% of women support limits on abortion after 15 weeks.

Democrat Politicians Fleeing the Party

Nebraska State Senator Mike McDonnell was censored by his own party for being a pro-life Christian. The Democrat of forty years said, "Douglas County Democrats instead of re-

specting [his position], they decided to punish it." These officials could use some mentoring on how to be tolerant and inclusive. McDonnell's move gives Republicans a veto-proof majority in the single legislative chamber.

Former Democrat Eric Johnson, mayor of Dallas, Texas explained that his deeply held Christian faith was central to his decision to join the Republican Party. Mayor Johnson, a black man, said, "You sort of inherit the Democratic Party as a cultural heirloom when you're African American. It sort of gets handed to you as part of who you are." Which demonstrates Eric's decision was not made lightly.

Louisiana State Rep. Jeremy LaCombe joined Rep. Francis Thompson in leaving the Democrat Party. Thompson's switch resulted in a supermajority for Republicans. North Carolina State Rep. Tricia Cotham's defection also gave Republicans a supermajority.

A growing number of elected politicians who've fled the party say its stand on abortion until birth is a bridge too far for many who like Mayor Johnson are not willing to shelve their faith for political gain. A recent poll shows young American voters do not support unrestrained abortion. 65% of what is called the Youth Vote support significant limits on abortion. And nearly all of them oppose abortion until birth.

When Americans get past the political slogans and into the heart of the matter – particularly the Youth Vote – a strong majority want to see the unborn protected.

Pro-life candidates have a clear path to victory. They must show voters how extreme their opponents truly are.

Abortions in Indiana Drop Drastically after *Roe v Wade* Reversal

In June of 2022 *Roe v Wade* was reversed and that started the work in Indiana Legislature to set stricter laws on abortion. In late July of 2022 the Indiana Legislature passed legislation that closed abortion clinics in Indiana. The only problem was that once it went to court months later, they lost the case and the abortion clinics were closed once again. General Election this Fall, Who Is Running *By Louis Kavanaugh Jr.*

Race for U.S. President

Former President Donald Trump won the Republican nomination on July 15 and picked pro-life JD Vance, a U.S. Senator from Ohio, as his running mate for vice president. Donald Trump has not been as vocal on pro-life issues this time around; but he has a strong pro-life record to stand on from his first four years in the White House, and we expect more of the same if he wins this year. For those following this race closely, we feel Donald Trump is playing down his pro-life credentials until after the election and that his pro-life record should speak for itself. His selection of pro-life judges and pro-life people in key positions in his administration and Trump's cutting off funding to pro-abortion organizations like Planned Parenthood spoke well of his position on the pro-life issue. Former President Trump has already been endorsed by National Right to Life PAC and other pro-life organizations. It may well be that Indiana Right to Life PAC may also endorse the former president, but that decision may not be made till August time frame.

On the Democrat side, President Joe Biden has pulled out of the race after the Democrats finally realized that his mental state was just more than they could hide and he was just not up to doing the job for another four years. They have tried to hide his mental state and his lack of mobility for several years, but it was in full view during the June 27 debate. He has endorsed Vice President Kamala Harris, who has stepped up to run for president and who is very pro-abortion. It is expected that Democrats will line up to support her, and I am sure she will pick another pro-abortion person to be the candidate for vice president on the Democratic ticket.

Race for Indiana Governor

In the race for governor, Republican Mike Braun, who is very pro-life, will be the standard bearer. The candidate for Lt. Governor on the Republican side is also very pro-life, and that is Micah Beckwith. Beckwith, who is pro-life, beat out the Republican candidate who had the endorsement of the Republican organization who also was pro-life.

Race for U.S. Senate in Indiana

In the race for U.S. Senate, pro-life Republican Congressman Jim Banks will be the candidate on the Republican side and on the Democrat side it will be Valerie McCray, whose record on abortion is unknown. Nearly all Democrats do not respond to Right to Life surveys from pro-life organizations, so they want their record to be hidden here in conservative Indiana. The senate seat is now held by Mike Braun who gave up that seat to run for Indiana Governor.

Race for U.S. Congress in the 8th District

Pro-Life State Senator Mark Messmer, who is presently a District 48 State Senator, won the race for the 8th District Congressman Race on the Republican side and will face Erik Hurt,

a Democrat, in the fall election. Messmer has a 100% pro-life voting record. Erik Hurt's record on abortion is not known.

Race for State Representative District 45

Pro-Life State Representative Bruce Borders fended off two challengers to hold on to his seat and will move on to the fall election without opposition. Borders won by about 300 votes over former Representative Jeff Ellington and Kellie Streeter from Vincennes to hold on to his seat.

Race for State Representative District 64

Pro-Life State Representative Matt Hostettler easily won his re-election battle against newcomer Dale Mallory, and Hostettler will now move on to the fall election and at this time has no opposition.

Race for State Representative District 63

Pro-Life State Representative Shane Lindauer, who did not have opposition in the spring primary, will face Teresa Kendall for the third straight time in the fall election. State Representative Lindauer is a strong pro-life advocate for the movement and has a 100% pro-life voting record.

The Top 5 Ways Kamala Harris is a Pro-Abortion Extremist

Now that President Biden has officially dropped out of the 2024 presidential race and thrown his support behind Kamala Harris for the Democratic nomination, let's re-examine the record of his "Abortion Czar," who is arguably even more extreme than Biden himself:

1. She won't name any limits on abortion she supports.

As we covered last September, Harris gave an interview on CBS' Face the Nation with Margaret Brennan in which she repeatedly refused to name any specific limit on abortion the Biden-Harris administration would support.

2. She is the first sitting vice president to campaign at an abortion business.

It was the wrong kind of "first": In March, Harris made a campaign stop at a Planned Parenthood abortion center in Minnesota. As SBA Pro-Life America President Marjorie Dannenfelser pointed out, **pregnant women are sold an abortion 97% of the time at Planned Parenthood** rather than helped to keep their child or make an adoption plan. And in Missouri, they had recently gotten caught abetting the trafficking of a minor, saying, 'We never tell the parents anything.'

Dannenfelser added:

Contrast this with the compassionate and truly empowering support offered by thousands of pregnancy resource centers across America, not only during pregnancy but well after their child is born. Under the Trump-Pence administration, Mike Pence became the first sitting vice president to visit a pregnancy resource center. It couldn't be clearer who is aligned with the overwhelming majority of Americans who support pregnancy centers and want fewer abortions, not more.

3. Harris strongly supports and was an original co-sponsor of Democrats' 50-state, all-trimester abortion mandate.

While in the Senate, Harris co-sponsored the Democrats' signature abortion bill, the deceptively-named "Women's Health Protection Act," in 2017 and 2019.

As a refresher on what this bill does:

- It would impose no-limits abortion on demand at any point in pregnancy, in all 50 states.
- It makes the abortionist, whose payment depends on whether the abortion can be performed, the sole decider of what "viability" means and explicitly blocks any limits that conflict with that person's "good-faith" judgment. Based on statements by abortionists such as Warren Hern and Colleen McNicholas, this could be at any time during pregnancy.
- It says that any state is welcome to widen the circumstances when post-viability abortions are allowed.
- It includes a list of specifically blocked types of laws that includes policies previously upheld by the Supreme Court,

such as informed consent protections and parental notification.

- It would supersede not only all state laws, but also all current and future federal laws, including the Religious Freedom Restoration Act — permitting only a narrow carve-out for federal law on partial-birth abortion to stand (though it's not entirely clear how enforceable that would be in light of many of its other prohibitions).

Even the two GOP senators who supported *Roe* said the WHPA went too far and voted against it — as did Democratic Sen. Joe Manchin, who said, "They're trying to make people believe that this is the same thing as codifying *Roe v. Wade*. And I want you to know, it's not. This is not the same. It expands abortion."

4. Harris voted against protections for babies when they can feel pain – AND babies born alive after failed abortions – repeatedly.

Then-Senator Harris voted twice against a limit on abortions at 20 weeks, well after science shows unborn babies can feel pain – **calling it an "immoral" bill**. As if that wasn't bad enough, she also voted twice against ensuring medical care for babies who survive an abortion attempt.

5. Harris supports targeting pro-life Americans and shutting down pregnancy centers.

Before there was New York Attorney General Tish James' anti-life lawfare, there was California Attorney General Kamala Harris. When brave citizen journalists exposed Planned Parenthood's role in the harvest and sale of baby body parts, Harris prosecuted the whistleblowers:

Instead of investigating Planned Parenthood – which receives more than half a billion dollars a year in taxpayer funding and has spent millions to elect pro-abortion Democrats – Harris (then a candidate for U.S. Senate) met secretly with the organization to discuss the investigation. Two weeks later state agents raided [David] Daleiden's home. Daleiden is believed to be the first journalist ever criminally prosecuted under a California law that prohibits secret videotaping of "confidential" conversations.

As attorney general, Harris also backed legislation to force pregnancy resource centers that provide real support for women and families in need to refer for abortions – legislation that, after a long battle, was eventually struck down as unconstitutional at the U.S. Supreme Court.

Fast forward to 2022: Here is Harris praising efforts to shut down pregnancy centers. Under the Biden-Harris administration, the targeting of pro-life Americans has only escalated as the DOJ throws nonviolent pro-life activists in prison.

The Clergy and Churches Are Not Talking About Abortion and that Silence is Helping to Further Abortion in Our Country!

Over the many years that I have worked in the pro-life movement one thing that has bothered me is the lack of support from Christian churches and clergy for the pro-life movement. One of the biggest complaints I hear from fellow pro-life people is that the very people that should help the pro-life movement are keeping mum and turning their backs on the pro-life movement. What I hear the most from some pro-life people is that churches and clergy will not help and they forbid any co-operation with the pro-life movement.

I will say that this is not true for all churches and all clergy as we have a good relationship with many of them in our area. This was brought home to me recently when I read a letter from Frank Pavone who is head of the Priests for Life Organization. In this letter he laments the problems that he has had to face with his fellow clergy and the roadblocks that he has had to endure.

In a nutshell, Pavone goes on to say that the obstacle he has faced is that many of those who should be our allies in this movement are under the very misguided impression of what the law permits the church to do regarding elections. Priests, bishops and other officials in the church have often gotten very bad advice, which in turn leads them to massive self-censorship regarding what to say and what to do during elections.

Tragically, too many advisors have instilled a tremendous fear of the IRS in many of our bishops and clergy. So much so that when one of our fellow pro-life warriors asks pastors for permission to speak to Catholics in the pews, inform them about what's happening to babies in the womb, urge them to get involved in the political process and tell them how important it is that they take their Catholic pro-life principles with them when they enter the voting booth, the pastor, often under orders from the chancery office (his bishop), usually refuses to give permission because he's been told that such activities would jeopardize the church's tax-exempt status and violate the law. This is not true. **I will say that churches cannot endorse or publicly support a candidate, but they can tell their congregation that they should not support candidates for public office who support abortion.**

Now some individuals giving this advice to our bishops do so because they truly believe they are keeping their bishops out of trouble with the government and out of the IRS crosshairs. Others do so out of pure ignorance of the law and the rules. And still others are politically motivated in favor of the Democrats. But whatever the reason behind the advice, the fact is that so much of the advice that is being given finds its way into official memos at election time.

Pavone goes on to say SILENCE from the pulpit is allowing abortion-on-demand to remain the law of the land. This is what needs to be done: **All churches can and must inform their members not to vote for people running for office who are**

pro-abortion. Churches should not endorse candidates, just inform the voters who is pro-life. This is not happening, and our country is suffering because of it. Those individuals who say neither party is pro-life just do not know what they are talking about. One party may not be as pro-life as we would like, but we know which party supports abortion up to birth and how they stand on abortion. They are pro-abortion from top to bottom. Let us do our best in this election year to get our message out. The unborn are depending on us. So let us vote pro-life.

We also could use louder voices among our clergy, fewer confusing voter guides from some religious groups, more straight talk on why we should vote pro-life and more to the point of insistence on the real-life issues at stake!
