# Pro-Life Leaders Urge Trump to Adopt Pro-Life Policies on His First Day in Office

Leading pro-life groups say that President-Elect Donald Trump should adopt a range of pro-life policies and make critical pro-life appointments on his first day in office. With Americans handing Trump an overwhelming landslide victory in rejection of the radical abortion agenda of Kamala Harris, pro-life groups say Trump should return to the pro-life policies that were a hallmark of his first administration.

Marjorie Dannenfelser of SBA Pro-Life told *LifeNews* that there’s no time to waste in planning for overturning the radical pro-abortion policies of the Biden-Harris administration. “Now the work begins to dismantle the pro-abortion policies of the Biden-Harris administration. In the long term, GOP pro-life resolve must be strengthened and centered on the unalienable right to life for unborn children that exists under the 14th Amendment. In America, where you live should never determine whether you live. Across the nation there are still hundreds of thousands of babies to save and moms to serve and we can’t stop fighting for them now,” she said.

Austin Ruse, the head of the international pro-life group CFAM listed several policies Trump should push forward quickly, as soon as he is inaugurated. “Trump can go a long way toward mending pro-life and pro-family fences by making big strides in the international sphere. As you recall, he made not just a few of our colleagues angry when he seemed to abandon the pro-life cause during the campaign,” he said. “This is not exactly new with Republican presidents. They have used international efforts to make up for shortfalls domestically. Trump should consider this first-day approach.”

Key State Department leadership positions must be staffed by committed pro-life personnel that can streamline a pro-life ethos in U.S. diplomacy and foreign assistance. These positions include but are not limited to: Secretary of State, USAID Administrator, US Ambassador to the UN and Geneva, Ambas-

sador at Large for Global Women’s Issues, Ambassador to UN Economic and Social Council, and Ambassador at Large for Global Health Security and Diplomacy.

Two new positions are needed; Special Envoy for Life and Family at the State Department, and Deputy Assistant to the president for life and family policy.

Reinstitute the Mexico City Policy and expand it to all foreign assistance. This policy originally applied to only family planning funding, though in his first administration President Trump issued an Executive Order to apply it more broadly. It however was too narrowly crafted to only “global health.” This has allowed abortion groups to receive millions of dollars from other sources of federal money. The new Executive Order must be expanded to cover ALL foreign assistance.

Rescind all Executive Orders and strategies that promote abortion and gender ideology. The Executive Order reinstating the Mexico City Policy must also revoke Executive Orders on foreign policy that promote abortion and gender ideology. Further, it should instruct the US Secretary of State and USAID administrator to rescind and replace all State Dep. and USAID strategies and policies that promote abortion and gender ideology.

The Executive Order must specifically direct the U.S. State Department Legal Advisor to issue a guidance on abortion in international law consistent with a textual and originalist interpretation of the obligations of the U.S. government under international law. Other pro-life groups have said they are already putting together plans to work with Trump and his key people on pro-life policies.

“National Right to Life looks forward to working with President-elect Trump, Vice President-elect Vance, and the newly-elected pro-life Congress on policy initiatives to protect the lives of unborn children and provide resources for moms and young parents,” the venerable group informed *LifeNews*.

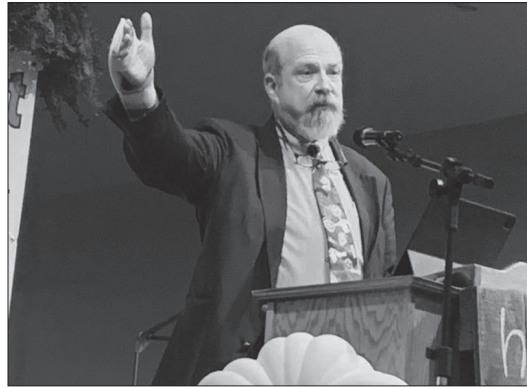
## Former Abortionist Tells of his Conversion to Pro-Life!

Pictured above is Dr. John Bruchalski as he addresses nearly 475 people at the Annual Right to Life Banquet for Daviess, Martin and Pike Counties. Dr. Bruchalski, the main speaker for the evening, told his story about how he went from a strong pro-abortion doctor who thought he was doing the right thing for women to one who finally realized he was doing just the opposite. His conversion began when he did a near full-term abortion and saw the full-term baby struggle for life before finally passing away in a disposal bucket. Another phase of his journey from pro-abortion to pro-life occurred when these women on whom he had performed abortions were having broken relationships and did not showing signs of a new life but of disappointment and despair.

He also was invited to take several trips to religious sites in Mexico and Europe, and during those trips he was moved by what he felt and what he saw, but is hesitant to expand on it. But what he has said is that it moved him more than anything he has felt before. When he returned from his religious trip to Europe, he told his former colleagues he would no longer perform abortions.

He has resolved to practice life-affirming medicine that supports women, children, and their families. As he explains it, "I came to see that true healthcare for women is not about rights but relationships—not about limits, but about love and mercy." He now has a clinic in Virginia that gives women life-saving medicine and not taking lives.

Dr. Bruchalski established Divine Mercy Care, a non-profit foundation that raises funds to support charitable care at Te-



peyac OB/GYN and seeks to educate and inspire current and future pro-life medical professionals. In its almost 30 years of operation, Tepeyac OB/GYN has delivered more than 10,000 children, with nearly 30 percent of their mothers receiving financial aid from Divine Mercy Care.

He did mention that those former colleagues did everything they could to interfere with his new venture and tried to pull his licenses and did what they could to hurt his new pro-life clinic. He mentioned to the audience that these pro-abortion people do everything they can to stop pro-life people from advancing their cause while claiming to co-exist with the opposition. This is what the pro-abortion forces do: they go after the pro-life people and try to shut them down.

Dr. Bruchalski had a final word for the audience. This election is the most important in our lifetime. If you are not registered, please get registered before Oct. 8 and then vote pro-life in this election. It is a matter of life and death.

Mike Fichter the president and CEO of Indiana Right to Life also spoke to the gathering and reported on the number of lives saved from abortion after the reversal of *Roe v. Wade*. Fichter went on to say that after all the litigation from pro-abortion forces were finally put to rest and the Indiana pro-life laws went into effect many lives have been saved.

Mark Messmer, candidate for Congress in the 8th District also spoke to the crowd and reiterated his support for the pro-life cause. Rob and Megan Abel Family of Petersburg was honored as the Adoptive Family for 2024.

# Voter Referendum Results Across the Nation

**R**ight to Life of Southwest Indiana is grateful for the election of pro-life candidates and the upholding of pro-life laws.

Below are some brief updates on referendum results in 10 states across the nation. Some went the pro-life way and others did not.

- Florida's ballot measure (Amendment 4) that would have enshrined abortion in the state's constitution FAILED. Voters in Florida voted to protect life!
- Arizona's amendment PASSED, allowing abortions up until the age of fetal viability. Before the passing of this measure, Arizona banned abortion after the 15th week of pregnancy.
- Missouri's amendment PASSED, allowing abortion in a state where it was previously banned with few exceptions.
- Nevada's amendment PASSED, allowing abortion up to fetal viability. Voters will need to vote on this again in 2026.
- Montana's amendment PASSED, upholding the current law which makes abortion legal.
- Colorado's amendment PASSED, upholding current state law where abortion is legal.

- South Dakota's amendment FAILED, upholding the current state law where abortion is banned with few exceptions. This remains good news!
- Nebraska's first ballot measure FAILED, blocking access to abortion. This is good. The second measure PASSED, upholding the banning of abortion in the second and third trimester.
- New York's amendment PASSED, which means abortion remains legal in New York.
- Maryland's amendment PASSED, which means that abortion remains legal in this state.

We understand that what states call "abortion rights" are nothing other than denying another person's natural and God-given right to life. No person has the right to obstruct another's existence.

We continue to see the need for education on this issue as many voters have simply been misled by opportunistic legislators, pushing an agenda that causes harm to the family.

We DO celebrate the pro-life victories across the nation! Thank you for your continued prayers and support of this vital ministry.

## Pro-Life Won Across the Country *By Brad Mattes, President, Life Issues Institute*

**O**ur country can let out a collective sigh of relief as life won across the country. Radical pro-abortion extremists have been defeated at every level of government.

The election saw President Donald Trump defeat Kamala Harris to become the 47th president of the United States. In a historic political comeback like no other in American history, President Trump will now become the only president to serve two non-consecutive terms in office since Grover Cleveland in 1892.

Harris ran on a platform of pro-abortion promises, repeatedly refusing to outline any limitations or safeguards she would put on abortion. Joining her pro-abortion push was her running mate, Tim Walz, who signed abortion until birth with no restrictions into law in Minnesota. The pair believed that support for all trimester abortion would propel them to victory. It didn't.

Americans from a wide variety of backgrounds put aside their differences and came together for the best interests of our country. A diverse coalition including every race, age, gender, and religious viewpoint rejected the promise of unrestrained abortion until birth.

In key US senate races pro-life candidates prevailed over their pro-abortion opponents, securing a majority in the upper chamber. With strong defenders of life in the senate, pro-life advocates can form an effective bulwark to stop the advances of the extreme abortion lobby.

Similarly, in the House of Representatives pro-life candidates prevailed. Maintaining a level of security in the lower chamber sets the stage for meaningful pro-life legislation to protect women and babies nationwide. The pro-life movement now has an opportunity to support pregnancy resource centers, struggling families, and women in need.

At the state level, successful pro-life campaigns in Florida, South Dakota, and Nebraska all defeated ballot initiatives which sought to enshrine abortion until birth in their constitutions. The abortion industry poured tens of millions of out of state money into these proposed constitutional amendments. Despite the tremendous financial investments and the outright lies of the left, the pro-life movement was able to defeat these grievous proposals.

Sadly, not every state was able to defeat the radical ballot initiatives. In Missouri Amendment 3 passed, bolstered by support in deep blue St. Louis and Kansas City. Other states, including several deep blue states that already had legalized abortion, saw similar amendments pass.

While the results of this election serve as an encouraging reminder that pro-abortion extremists can be defeated, there is still work ahead of us. We will use this momentum to continue to provide lifesaving pro-life education as we fight to change the hearts and minds of millions.

# “Numbers are Shocking:” Christian Voters Played Key Role in Defeating Kamala and Her Abortion Agenda

Catholic voters turned out in droves for President-elect Donald Trump on November 5, playing a key role in propelling the Republican to the White House for a second term. Trump held an 18-point lead among Catholics as of Thursday morning, who made up roughly a quarter of the vote, according to early exit polling by *The Washington Post*. Democratic presidential nominee Kamala Harris struggled to gain traction with Catholics, who largely disagreed with her broad abortion support and apparent anti-Catholic rhetoric.

Despite disagreeing with some of his policy stances, many Catholics favored President Joe Biden in 2020 in part because they viewed him as one of them, which is an advantage Harris' campaign did not have in 2024, Ralph Reed, founder and chairman of the Faith & Freedom Coalition, told the Daily Caller News Foundation.

“Whatever you think of Biden’s social or domestic policies, he is a frequently mass attending Catholic from Pennsylvania who knows the language, you know, and is able to develop an affinity with Catholic voters based on that shared experience, that shared faith experience,” Reed said.

Catholics favored President Joe Biden in 2020 by a margin of 52 to 47, according to previous exit polling from the *Post*. With neither Harris nor running mate Tim Walz identifying as Catholic, the Democratic ticket was unable to resonate with Catholic voters as well as Trump could with the addition of his Catholic running mate, JD Vance.

“This is not the first time we’ve had a post-election survey news conference where we have said, yet again, the Democrats have a religion problem, and it is serious, it is lethal,” Reed said. “Biden was able to square that circle by personally talking about the seriousness of his faith and being seen frequently attending Mass and, you know, meeting the Pope or leaving a service and talking to the Father, the priest and so forth. Those visual images really matter. Meanwhile, he was going to the progressive left and saying, you have my entire domestic policy brief, whatever you want to do.”

Another issue compelling the religious vote on Tuesday may have been Harris' lack of defense of Israel in the ongoing war in Gaza, which Catholics and other religious voters may have seen as the candidate being unwilling to defend religious liberties, Reed told the DCNF.

“I think that this has been devastating to the Democrats,” Reed said. “There is no way to underscore enough how much this issue resonates with church going Protestants, and especially evangelicals.” Protestants and other Christians also supported Trump on Tuesday by a wide margin of 63 to 36 as of Wednesday afternoon, according to the *Post*.

Debates circulated around Biden’s commitment to his faith when a priest denied him Holy Communion in 2019 over his support and promotion of abortion as a public official. The

Biden Pentagon revealed in March that it had spent just under \$45,000 in taxpayer dollars between June and December of 2023 on travel expenses for military members to receive abortions.

The Biden administration was also accused of infringing on religious freedom after it attempted to force religious doctors and hospitals to perform transgender surgeries despite the procedures conflicting with their faith. Biden later took flak for issuing a proclamation for a “transgender day of visibility” on Easter Sunday.

It was also revealed that the FBI reportedly “abused its counterterrorism tools” to target Catholics and pro-life advocates, labeling them as “potential domestic terrorists,” according to the House Weaponization Subcommittee. The committee was referring to a February 2023 memo from the Richmond field office that described traditionalist Roman Catholics as “radical,” which the Bureau eventually retracted.

“Catholic voters played a decisive role in the historic victory of Donald Trump and J.D. Vance,” Brian Burch, president of CatholicVote, said in a statement in response to the double-digit exit polling. “These numbers are shocking, and could prove to be the largest margin among Catholics in a presidential race in decades. Catholics proved again to be a critical voting bloc that cannot be ignored.”
