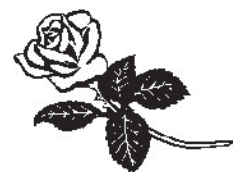

Mark Houck Wins Seven-Figure Settlement After Joe Biden Targeted Him

In a major legal victory against blatant targeting and discrimination from former President Joe Biden's administration, pro-life volunteer Mark Houck has secured a seven-figure settlement in his lawsuit against the U.S. Department of Justice.

The settlement follows the Biden administration's widely criticized prosecution and bogus arrest of the Pennsylvania father under the Freedom of Access to Clinic Entrances (FACE) Act.

In 2022, heavily armed federal agents raided Houck's home after he intervened to protect his young son from an aggressive abortion escort outside a Planned Parenthood facility. Despite offering to cooperate with authorities, Houck was arrested at gunpoint in front of his wife and children – causing them significant trauma and embarrassment. Federal agents pointed automatic weapons at his family, detained him, and chained him to a table for six hours.

The Biden DOJ charged Houck under the FACE Act, exposing him to up to 11 years in federal prison. However, in January 2023, a federal jury acquitted him on all counts after just one hour of deliberation. Following his acquittal, Houck — represented by the 40 Days for Life Institute of Law & Justice — filed a lawsuit against the DOJ, citing wrongful prosecution, excessive force, and violations of his constitutional rights. That case has now resulted in a seven-figure settlement.

Shawn Carney, CEO and president of 40 Days for Life, hailed the outcome. "This is the biggest example of Biden's DOJ being held accountable for targeting and persecuting pro-life Americans. We were honored to represent Mark, along with



many other great people, to secure justice and restore confidence that pro-life Americans can go out and pray without fear of their government," Carney said.

The settlement marks a significant rebuke of the DOJ's conduct under the Biden administration and underscores growing concerns about the weaponization of federal law enforcement against peaceful pro-life Americans.

Houck's ordeal began when he stepped in to shield his son from harassment by an abortion escort. Local authorities initially viewed the matter as non-criminal, yet federal prosecutors pursued the high-profile charges that threatened the father of seven with more than a decade behind bars.

Pro-life advocates view the resolution as not only justice for Houck and his family but also a broader victory affirming the right of Americans to pray and counsel peacefully at abortion facilities without fear of government intimidation.

Supreme Court Rebukes Democrat AG for Threatening Pro-Life Pregnancy Center

The Supreme Court delivered a unanimous rebuke to New Jersey Democrat Attorney General Matthew Platkin for his demand that a pro-life pregnancy center hand over its donor information. Platkin had issued a subpoena to First Choice Women's Resource Centers, seeking to prove that the pregnancy center was misleading donors. The Supreme Court cited *NAACP v. Alabama* (1958), which secured the precedent that donors have a First Amendment right to contribute to causes anonymously.

"Since the 1950s, this court has confronted one official demand after another like the Attorney General's," Justice Neil Gorsuch, an appointee of President Donald Trump, wrote in the unanimous opinion. "Over and again, we have held those demands burden the exercise of First Amendment rights. Disputing none of these precedents but seeking ways around them, the attorney general has offered a variety of arguments. Some are old, some are new, but none succeeds."

In response to the Supreme Court's overturning of the abortion precedent *Roe v. Wade* (1973) in *Dobbs v. Jackson Women's Health Organization* (2022), Platkin established a "Reproductive Rights Strike Force." That strike force issued a "consumer alert" accusing pro-life pregnancy centers of "seeking to prevent people from accessing comprehensive reproductive health care" by "providing false or misleading information about abortion."

Pro-life pregnancy centers like First Choice offer various services to women facing crisis pregnancies, such as counseling, food, shelter, clothing, and baby items in an attempt to convince them not to undergo abortions and to prepare them to take care of their babies. These centers compete with abortion centers, and Democrats have suggested that they engage in misleading advertising to do so.

Platkin's office had not received any complaints from the public about First Choice, but staff served a subpoena on the pregnancy center in 2023, regardless. The subpoena mentioned the state's Consumer Fraud Act and commanded First Choice to produce documents within 30 days, demanding the names, phone numbers, addresses, and places of employment of all individuals who contributed to the pregnancy center by specific means. The attorney general later claimed his office intended to contact donors to determine if they had "been misled" by First Choice.

Gorsuch noted that Platkin's apparent theory involved the idea that First Choice had misled donors into thinking that it provides abortions. First Choice sued, seeking an injunction to block the subpoena. Both the district court and a panel of the U.S. Court of Appeals for the 3rd Circuit dismissed First

Choice's claim. As Gorsuch explained, the case centers on whether the threat of Platkin taking further action against First Choice qualified as an "injury-in-fact," giving the pregnancy center standing to sue in court. First Choice could sue to prevent enforcement of the subpoena so long as it faces "a credible threat of enforcement."

Gorsuch agreed with First Choice's claim that "the attorney general's subpoena itself—and specifically its demand for donor information—has caused it to suffer an actual and ongoing injury to its First Amendment rights by deterring donors from associating with it."

This case follows a recent trend of Democrat attorneys general seeking donor information in a way that contradicts the Supreme Court's ruling in *NAACP v. Alabama*. In 2021, the Supreme Court up held the rights of Americans for Prosperity against California Democrat Attorney General Rob Bonta.

Pro-Life Americans Must Tell Congress to Defund Planned Parenthood Again

Planned Parenthood is still working to raise funds after losing hundreds of millions of dollars in Medicaid reimbursement, thanks to the One Big Beautiful Bill President Trump signed last July 4. Fifty-one Planned Parenthood "health centers" in 18 states closed as a result of the Trump-Republican-pro-life effort, and the nation's number one abortion seller is warning that another 150 could close.

But beyond praying for the day Planned Parenthood will close its last killing center, we need to remind our U.S. senators and members of the House of Representatives that they need to pass a new budget resolution that will continue protecting our tax dollars from funding abortion.

Birth Rate Drops as Number of Babies Killed in Abortions Hit Record Highs

The number of babies born in the United States declined in 2025 while the number of babies killed in abortions has hit record highs. Provisional figures released this week by the Centers for Disease Control and Prevention show 3,606,400 babies were born in 2025, a 1% decrease from 3,628,934 births in 2024. The general fertility rate fell 1% to 53.1 births per 1,000 women and girls ages 15-44, continuing a decline that began in 2007.

Births to teenagers dropped sharply. The rate for girls ages 15-17 fell 11% to 4.7 per 1,000, while the rate for ages 18-19 declined 7% to 21.9 per 1,000. Births rose modestly among women ages 35 and older. At the same time, abortions reached high numbers nationwide.

The Guttmacher Institute estimated 1,126,000 abortions occurred in 2025, virtually unchanged from 2024. Pro-life analyst Michael New noted that “the trend [of] rising abortion numbers continues.” Planned Parenthood reported killing a record 434,450 babies in abortions in its 2024-2025 fiscal year, an 8% increase from 402,230 the previous year. The organization ends more than 1,190 unborn lives each day. Pro-life leaders expressed alarm at the contrast between declining births and sustained high abortion figures.

“Planned Parenthood’s reign of death and destruction increased in 2025,” said Hugh Brown, vice president of American Life League. “And despite its cries that our tax dollars were taken from it, the organization actually received a record amount of government funding last year.”

American Life League President Judie Brown added: “Hidden beneath the glass and the numbers is the actual truth that Planned Parenthood detests families as God designs them. It works tirelessly to market evil and promote it under the guise of ‘healthcare.’”

New pointed out that while some states enforcing pro-life heartbeat laws saw abortion declines, those reductions were offset by increases in telehealth abortions in other areas. He called stopping telehealth abortions “a top priority for pro-lifers.” The figures come more than three years after the Supreme Court’s Dobbs decision returned abortion policy to the states. Pro-life advocates continue to push for stronger protections for unborn children as the nation grapples with falling fertility rates.

Catholic University to Honor Radical Abortion Activist Nancy Pelosi

Notre Dame de Namur University in Belmont California will honor former Speaker of the House Nancy Pelosi as its commencement speaker this year. The Silicon Valley Catholic university said it is “deeply honored” to host Pelosi.

“Her lifelong commitment to public service, leadership, and advocacy for justice reflects the very values that define an

NDNU education and the enduring legacy of the Sisters of Notre Dame de Namur,” President Beth Martin stated in a news release. “During this 175th anniversary year of the Sisters in California, her presence powerfully affirms the impact of faith-inspired education on the world.”

Still, the decision is likely to draw concerns, given Pelosi’s history of supporting abortion and the LGBT agenda, issues at odds with the Catholic Church’s teachings. She still is not allowed to receive Communion in the Archdiocese of San Francisco due to her unrelenting support for the killing of preborn babies.

After attempts to get her to change her ways, Archbishop Salvatore Cordileone publicly instructed Pelosi not to present herself for Communion. The Catholic Church teaches that abortion is a grave sin, as is publicly advocating for it.

“I am hereby notifying you that you are not to present yourself for Holy Communion and, should you do so, you are not to be admitted to Holy Communion, until such time as you [publicly] repudiate your advocacy for the legitimacy of abortion and confess and receive absolution of this grave sin in the sacrament of Penance,” the archbishop wrote in 2022.

She has defied this directive when in other dioceses.

She also came under criticism for falsely claiming the Catholic Church has held a variety of views on abortion.

Pelosi also has a history of supporting so-called same-sex “marriage,” along with the surgical and chemical mutilation of gender-confused kids, also known as “gender-affirming care.”

The graduation is scheduled for May 2.

Court Says Louisiana's Lawsuit Against Mail-Order Abortions is "Likely to Succeed"

A federal judge temporarily halted Louisiana's lawsuit against the U.S. Food and Drug Administration (FDA) seeking to limit access to the dangerous chemical abortion drug Mifepristone's mail-order availability while the agency completes an ongoing safety review of the drug. While the pause keeps mail dispensing of chemical abortion drugs in place for now, the judge noted that Louisiana Attorney General Liz Murrill, and Rosalie Markezich, who was coerced by her boyfriend to have an abortion via mail-order pills, have standing to bring the lawsuit. The judge ruled that the state and Markezich "are likely to succeed on the merits" due to the FDA's "own shortcomings" in loosening the drug's safety restrictions.

In a 37-page memorandum ruling, U.S. District Judge David C. Joseph of the Western District of Louisiana granted the Trump administration's request to pause the case pending the FDA's promised "good faith, evidence-based and expeditious review" of Mifepristone's safety risks. The ruling temporarily denies Louisiana's effort to roll back the FDA's 2023 decision to let Mifepristone be dispensed by mail and telehealth without an in-person medical visit.

The lawsuit, filed in October 2025, argues that the FDA acted unlawfully under the Administrative Procedure Act (APA) by loosening Mifepristone's safeguards without adequate scientific justification. An April 2025 study from the Ethics and Public Policy Center found that nearly 11 percent of women who take Mifepristone experience serious adverse health events, including "sepsis, infection, hemorrhage, need for blood transfusion, hospitalization, emergency room visits related to the abortion, need for a surgical abortion due to incomplete abortion, and other abortion-specific complications."

Louisiana contends the FDA failed to consider these cumulative safety effects and relied on missing or compromised data regarding adverse events. Louisiana further argues that the FDA's actions undermine state abortion laws and impose financial burdens on the state, particularly through Medicaid costs associated with emergency care following chemical abortions.

While declining to issue immediate relief to Louisiana and Markezich, Judge Joseph found they have Article III (federal) standing to bring their claims. The U.S. Supreme Court had previously dismissed another Mifepristone case in 2024 for lack of standing (*FDA v. Alliance for Hippocratic Medicine*), but this case is different because the FDA's Mifepristone Risk Evaluation and Mitigation Strategy (REMS), implemented by the Biden administration, undermines Louisiana's abortion laws, the ruling states.

"[In a] post-*Dobbs* regulatory environment, there is evidence that the 2023 REMS was approved without adequate consideration, at least in part, as part of an effort to circumvent anti-abortion states' ability to regulate abortion," wrote Judge Joseph. "Likewise, there is evidence that the consequences of this action were predictable – out-of-state providers and related entities would expand access to mifepristone in ways designed

to reach into jurisdictions like Louisiana. These actions cause concrete and ongoing injury to Louisiana..."

Judge Joseph further wrote that while the FDA has "acknowledged" its own procedural deficiencies regarding its decision-making, the agency should complete its safety review "free from judicial interference," but should do it with "deliberate speed."

"...the stay granted to FDA will not remain open-ended," wrote Judge Joseph. "FDA has an obligation to act with all deliberate speed to review its past actions and complete a thorough analysis that addresses the deficiencies it has acknowledged. The parties and the American public deserve nothing less. Should the agency fail to complete its review and make any necessary revisions to the REMS within a reasonable timeframe, the Court's analysis – and the weight accorded to these factors – will inevitably change."

To impose accountability, Judge Joseph ordered the FDA to:

- produce the entire administrative record of Mifepristone's safety decisions within 60 days.
- file a status report within 6 months.
- notify the court within 14 days after completing its safety review.

Liberty Counsel Founder and Chairman Mat Staver said, "While the ruling keeps harmful chemical abortion drugs available by mail, the judge's findings on standing and likelihood of success are essential. By finding that Louisiana and Rosalie Markezich have standing and signaling serious concerns with the FDA's decision-making on the merits, the court ensured that this case will move forward on solid legal footing once the FDA's review is complete. The FDA's deregulatory actions regarding abortion drugs are destroying innocent children and harming women. The FDA can no longer be allowed to violate federal law and circumvent state abortion laws by facilitating abortion pill trafficking nationwide through the mail. Chemical abortions are never safe and harm women and kill children."

Battle is Not Over for Pro-Life Pregnancy Centers Facing Persecution

The Supreme Court spoke with one voice today, and its message to New Jersey was clear: government officials may not use the machinery of the state to intimidate pro-life ministries into silence before those ministries can seek protection in federal court.

In *First Choice Women's Resource Centers, Inc. v. Davenport*, the Court ruled 9-0 that First Choice, a faith-based network of pregnancy resource centers in New Jersey, may bring its First Amendment challenge in federal court after the state demanded private donor information through a sweeping subpoena. Justice Neil Gorsuch wrote for a unanimous Court. The judgment reversed the Third Circuit and sent the case back for further proceedings.

This decision does not end the fight. New Jersey's pro-life pregnancy centers still must defend themselves against an aggressive investigation launched by pro-abortion official's hostile to their mission. The Court did not decide whether the subpoena itself violates the Constitution. That battle now moves forward in federal court.

But today's ruling gives these centers something they desperately needed: protection from being forced into a hostile state process before they can ask a federal judge to defend their constitutional rights.
